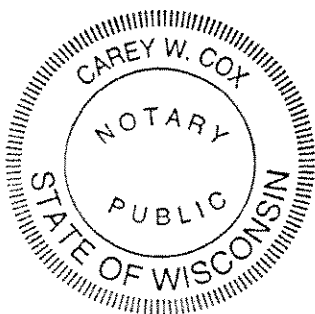

NOTICE TO ELECTORS OF
THE CITY OF MILWAUKEE
WISCONSIN**

TAKE NOTICE that the Common Council of the City of Milwaukee, Wisconsin, at a lawful meeting held on the 14th day of November, 2006, adopted an initial resolution, pursuant to Section 66.1103 of the Wisconsin Statutes, as amended, authorizing the issuance of not to exceed \$2,500,000 aggregate principal amount of revenue bonds (the "Bonds") on behalf of Pettit National Ice Center, Inc, a Wisconsin nonprofit corporation (the "Eligible Participant"). The purpose of the bond issue is to finance costs of providing a project to be located at 500 South 84th Street in the City of Milwaukee, Wisconsin (the "City"). The project would consist of acquisition of the Pettit National Ice Center facility and equipment therefor and/or improvements thereto by the Eligible Participant (the "Project"). The Eligible Participant expects the Project to eliminate 0 jobs, create 0 jobs, maintain 10 full-time jobs and at least 100 part-time jobs at the Project site in the City, and neither eliminate nor create jobs elsewhere in the State of Wisconsin.

THE BONDS SHALL NOT CONSTITUTE AN INDEBTEDNESS OF THE CITY WITHIN THE MEANING OF ANY STATE CONSTITUTIONAL PROVISION OR STATUTORY LIMITATION. THE BONDS SHALL NOT CONSTITUTE OR GIVE RISE TO A PECUNIARY LIABILITY OF THE CITY OR A CHARGE AGAINST ITS GENERAL CREDIT OR TAXING POWER. THE BONDS SHALL BE LIMITED OBLIGATIONS OF THE CITY PAYABLE BY THE CITY SOLELY OUT OF REVENUES DERIVED FROM THE ELIGIBLE PARTICIPANT OR OTHERWISE PROVIDED FOR PURSUANT TO THE TERMS OF A REVENUE AGREEMENT TO BE ENTERED INTO BETWEEN THE CITY AND THE ELIGIBLE PARTICIPANT.

The aforesaid initial resolution is a public document and may be inspected by any elector of the City at the City Hall, 200 East Wells Street, Room 205, during business hours.

TAKE FURTHER NOTICE that the electors of the City of Milwaukee may petition for a referendum on the question of the bond issue. Section

66.1103(10)(d) of the Wisconsin Statutes provides:

The governing body may issue bonds under this section without submitting the proposition to the electors of the municipality for approval unless within 30 days from the date of publication of notice of adoption of the initial resolution for such bonds, a petition conforming to the requirements of s. 8.40, signed by not less than 5% of the registered electors of the municipality, or, if there is no registration of electors in the municipality, by 10% of the number of electors of the municipality voting for the office of governor at the last general election as determined under s. 115.01(13), is filed with the clerk of the municipality and as provided in s. 8.37 requesting a referendum upon the question of the issuance of the bonds. If such a petition is filed, the bonds shall not be issued until approved by a majority of the electors of the municipality voting on the referendum at a general or special election.

TAKE FURTHER NOTICE that the Common Council of the City of Milwaukee, Wisconsin, at the lawful meeting held on the 14th day of November, 2006, did also resolve that:

"It is the finding and determination of this body that the City will not control the design, costs, construction or operation of the Project; that no public moneys will be expended for the Project; that the City will have no beneficial ownership in the Project; that the primary reason for requiring competitive bidding for construction of municipal projects is to protect the taxpayers against excessive expenditures of public funds and that such reason, although sound as applied to public works, is not applicable to the Project in which no general funds or tax revenues of the City will be used or put at risk; that it would be more efficient and expedient for the accomplishment of the public purposes of the revenue bond issue if the Eligible Participant were to have complete control over the letting of contracts for construction for the Project. Therefore, the City does hereby waive the provisions of Section 111(b) of the Act with regard to the Project."
