Officers spoke with employees who stated that two armed suspects came to the store and demanded money from the registers and safe. The employees stated that the suspect forced them to the back room where the money was located. The entire staff was cooperative with officers during the course of the investigation.
- 2. On 09/30/20, Milwaukee Police were dispatched to 5201 N. 91st St, for a shop lifting complaint. Officers spoke with the manager who stated that an unknown subject took items from the store without paying for them. The suspect left the location on foot southbound from the location. On Monday January 4th 2021, at 8:37 PM, I was dispatched to a Property Damage call for service at Walgreens located at 5201 N 91st St in the City and County of Milwaukee.

Upon arrival I spoke to the caller Mia R BURNSIDE (B/F 10/24/96) who identified herself as a security guard employed with Infinite Security assigned to Walgreens. BURNSIDE stated she was in the store when she observed a subject trying to exit the store with various items with a cart, described as a black male wearing a Green Bay Packers hat, a surgical mask, gray shirt, dark blue coat, and black pants. Mia stated she took the cart for the unknown subject before he exited the store. Mia stated the door was locked due to the subject attempting to leaving with items. When the unknown subject got to the door, he was unable to open it, so he kicked the lower glass breaking it and exiting the store. Subject was seen leaving south bound on foot from the above location. I check the area for a subject matching the about description and no one was able to be located.

I took 7 pictures of the damages.

I provided Mia with a PV-17.

Mia and Latija did not know a value of the window nor did they know who the insurance carrier was.

Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
