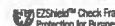

RE: LETTER OF INTENT FOR THE MILWAUKEE GUN SUMMIT

Dear Ms. Vinik:

We are reaching out to your foundation to ask for support of the 2014 Milwaukee/Minneapolis Summit to Combat Gun Violence that has been tentatively scheduled for early September in Milwaukee, Wisconsin. This correspondence serves as our letter of intent to provide you with a general overview of our proposal. We are formally requesting a grant of \$38,000 to cover expenses relating to our proposed Gun Summit in partnership with the City of Minneapolis and the Police Executive Research Forum (PERF). We have attached a draft agenda, budget, and invitation list for your review.

As Mayor and Police Chief of the largest city in Wisconsin, we are intimately aware of how illegal gun possession negatively impacts our neighborhoods. Wisconsin needs gun legislation reform to support cities working to thwart criminals' easy access to guns. Therefore, we are planning to bring regional criminal justice partners together in an interactive forum to accomplish the following goals:

- Gather information and data prior to the Summit to assist invited guests to prepare for a day of discussion and problem-solving designed to reduce gun violence.
- Facilitate interactive dialogue with the region's foremost criminal justice partners, who are intent on strategizing best practices for a sustainable reduction in gun violence.
- Target key gun violence issues, including operational, community-based, evaluative, media, and legislative topics, and provide attendees with experts and research on their most important concerns.
- Rally criminal justice partners to take a position for common sense gun legislation reform to reduce gun related violence in our neighborhoods.

The Milwaukee Summit to Combat Gun Violence comes at a time when Governor Scott Walker has expressed his support for our recommended modifications to strengthen Wisconsin's firearms laws. This occurred at a bill signing event involving additional funding for ShotSpotter, gunshot detection technology. Bringing together experts that deal with gun violence on a regular basis will help us build strong support across the state and the region for changes in gun laws that include felonizing illegal possession of a firearm and disqualifying habitual criminals from obtaining a carry conceal permit.

Along with the Police Executive Research Forum, the Cities of Milwaukee and Minneapolis will work together to engage various criminal justice partners from across the region, as we did in 2013 in Minneapolis. We are proposing to include a dinner reception the evening before the Summit, followed by a one-day forum facilitated by the Executive Director of PERF, Chuck Wexler. We intend to strategically partner with our invited guests so that together we can more effectively address gun violence, formulate best practices, and more importantly, share real-world experiences to make better use of our resources and incite changes in policies to reduce gun violence.
