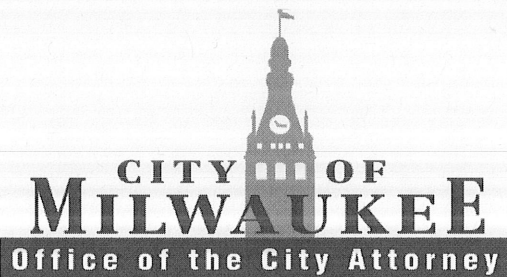

Joseph Walker v. City of Milwaukee, et al., Case No. 20-CV-0487 (E.D. Wis.)

Dear Council Members:

Enclosed please find a proposed resolution to authorize payment of the judgment, plus statutory interest, in the above captioned lawsuit docketed March 29, 2024, amended on July 30, 2024, and amended on October 11, 2024.

The judgment, as amended, reflects a total compensatory damage award of \$2,000,000 dollars to Plaintiff, as well as \$248,920.12 in associated costs and attorney's fees. Interest accrues at a rate of 5.02% per annum from the date of entry. The total judgment due to plaintiff, including compensatory damages, attorney's fees and costs, plus interest totals \$2,231,297.15.
