Enclosed please find a proposed resolution approving payment of \$30,000 to settle the claims of Dennis J. Dalgord, Raenita Hunt, and Victor R. Dalgord, arising from a motor vehicle accident on November 30, 2021.

The vehicle driven by Dennis J. Dalgord, with passengers Raenita Hunt and Victor R. Dalgord, was struck by a Milwaukee Department of Public Works vehicle. The claimants submitted itemized statements of damages requesting \$61,963.01 for Dennis J. Dalgord, \$37,7887.00 for Raenita Hunt, and \$25,945.00 for Victor R. Dalgord.

Based on the status of the claims and the strengths and weaknesses of each parties' positions, it is the City Attorney's recommendation that the proposed settlement is in the City's best interest.
