FINDINGS OF FACT

- 1. Laschelle R. May (hereinafter the "Licensee") is the holder of a Public Passenger Vehicle Driver license in the City and County of Milwaukee, Wisconsin. Said license expires at midnight, October 31, 2013.
- 2. An application to renew said license was filed with the Office of the City Clerk August 23, 2013.
- 3. Pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department filed a police report dated August 28, 2013. That report could form the basis of non-renewal or suspension of this license.
- 4. On September 18, 2013, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes of a police report that could form the basis for suspension or non-renewal of the license of the licensee and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police report on October 3, 2013 at 9:00 a.m. in Room 301B of City Hall. At said date, time and place, the licensee did appear and was not represented by counsel.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On May 5, 2012 the licensee was convicted of failure to pay forfeiture in Walworth County Circuit Court and her license was suspended for 334 days.
 - B. On April 3, 2012 the licensee was convicted of failure to pay forfeiture in Milwaukee City Municipal Court and her license was suspended for 19 days for



two different citations.

C. The applicant stipulated to her convictions regarding traffic law for infractions on:

1/10/13	operating while registration suspended
1/17/13	operating while registration suspended
1/17/13	operating while suspended
3/21/13	operating while registration suspended

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24, Wisconsin Statutes.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Laschelle R. May, has not met the criteria of Chapter 100 of the Milwaukee Code of Ordinances or § 349.24 of the Wisconsin Statutes to allow renewal of her Public Passenger Vehicle Driver license without undergoing a ten (10) day suspension based upon the police report and stipulated driving record.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Public Safety Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew with a ten (10) day suspension the Public Passenger Vehicle Driver license held by Laschelle R. May based upon the police report and stipulated driving record.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee recommends that the Public Passenger Vehicle Driver license of Laschelle R. May be renewed with a ten (10) day suspension based upon the police report and stipulated driving record.

Said suspension is to be in effect from November 1st, 2013 through 11:59 P.M. November 10, 2013.

Re: Report of the Renewal Application of Baljit Singh for a Public Passenger Vehicle Taxicab Permit #56.

FINDINGS OF FACT

- 1. Baljit Singh (hereinafter the "Permitee") is the holder of Public Passenger Vehicle Taxicab Permit #56 in the City and County of Milwaukee, Wisconsin. Said permit expired at midnight, October 31, 2013.
- 2. An application to renew said permit was filed with the Office of the City Clerk on August 26, 2013.
- 3. Pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department filed a police report dated August 26, 2013. That report could form the basis of non-renewal or suspension of this permit.
- 4. On September 20, 2013 the City Clerk's Office provided timely notice to the Permitee, pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes of a police report that could form the basis for suspension or non-renewal of the permit and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police report on October 3, 2013 at 9:30 a.m. in Room 301B of City Hall. At said date, time and place, the permitee did appear and was represented by Attorney Vincent Bobot.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On November 29, 2012 at 1:30 p.m. a police officer was inspecting taxis at 2947 South 31st Street. While speaking with the driver of taxicab #56, the officer learned that the driver was not renting the taxicab from the permit holder Baljit Sigh. The driver stated he was renting the vehicle fro Aftab Sultan. The officer contacted the permit holder with this information. The permit holder initially



denied knowledge of the illegal subleasing; stating that Aftab Sultan collected rent fro him when he was out of town. When advised of the conversation with the driver, the permit holder admitted that he rented the taxicab to Sultan for \$1,500 a month and he knew that Sultan rented the vehicle to two drivers. The permit holder stated he did not know it was illegal. The permit holder was advised to rent directly to the driver and was given a copy of the city ordinances pertaining to leasing.

B. On March 4, 2013 a police officer observed Yellow Cab taxi #56 in the taxi stand at 1721 West Canal Street with registration plates that expired in January. The vehicle left the taxi stand before the officer could speak to the driver. The officer contacted a supervisor at Yellow Cab Co-Op to have them notify the permit holder of the expired registration. The permit holder was cited for expired registration – owner responsibility and was found guilty on April 26, 2013 and fined \$88.80.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24, Wisconsin Statutes.
- 2. Based upon the above facts found, the Committee concludes that the permitee, Baljit Singh, has not met the criteria of Chapter 100 of the Milwaukee Code of Ordinances or § 349.24 of the Wisconsin Statutes to allow renewal of Public Passenger Vehicle Taxicab Permit #56 without undergoing a fifteen (15) day suspension based upon the police report.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Public Safety Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew Public Passenger Vehicle Taxicab Permit #56 held by Baljit Singh with a fifteen (15) day suspension based upon the police report.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee by vote of three (3) ayes and two (2) noes recommends that the Public Passenger Vehicle Taxicab Permit #56 of Baljit Singh be renewed with a fifteen (15) day suspension based upon the police report.

Said suspension is to be in effect for November 1st, 2013 through 11:59 P.M. November 15, 2013.

On September 18, 2013, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes of a police report that could form the basis for suspension or non-renewal of the license of the licensee and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police report on October 3, 2013 at 9:00 a.m. in Room 301B of City Hall. At said date, time and place, the licensee did not appear and was not represented by counsel.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. Notice was sent to Terry L. Harris, Sr. at 3629 North 12th Street, Milwaukee, Wisconsin 53206, along with a copy of the police report on August 27, 2013 in an envelope which was sent by U.S. first-class prepaid mail in an envelope bearing the return address of the License Division, 200 East Wells Street, Room 105, Milwaukee, WI 53202. The address of 3629 North 12th Street, Milwaukee,



Wisconsin 53206 was the address given by the applicant on his renewal application. The notice included a copy of the police report. The licensee failed to appear at the hearing and the envelope containing the notice and police report was not returned to the License Division by the U.S. Postal Service.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24, Wisconsin Statutes.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Terry L. Harris, Sr., has not met the criteria of Chapter 100 of the Milwaukee Code of Ordinances or § 349.24 of the Wisconsin Statutes to allow renewal of his Public Passenger Vehicle Driver license based upon nonappearance.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Public Safety Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Public Passenger Vehicle Driver license held by Terry L. Harris, Sr. based upon nonappearance.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee recommends that the Public Passenger Vehicle Driver license of Terry L. Harris, Sr. be denied based upon nonappearance.
