ADENDUM TO PETITION FOR AMENDMENT OF SPECIAL PRIVILEGE (Change of Name/Ownership)

The purpose of the Petition for Amendment to which this Addendum is attached is to reflect a change in ownership and a change of name of the current privilege holder from Miller Brewing Company ("Miller") and, where appropriate, Miller Breweries East, Inc., a wholly owned subsidiary of Miller, to MillerCoors LLC, a Delaware limited liability company, licensed and registered to do business in the state of Wisconsin.

The entity to which the change and designation of ownership will be applicable is a joint venture resulting from a merger of Miller and the former Adolph Coors Brewing Company of Golden, Colorado ("Coors"). Coors is currently, at least until the effective date of the closing of the merger, a unit of the Molson Coors Brewing Company.

MillerCoors LLC will be 58% owned by Miller and 42% by Coors. Miller will retain its own corporate stock but will transfer its physical assets to MillerCoors LLC including the property and operations in Milwaukee. Coors will make a similar transfer but there will be no change in operations. The Milwaukee brewery will be maintained and will operate as it is being run now and the special privileges which are being amended will serve the precise function that they currently serve under the sole ownership of Miller.
