3. On 02/05/2017 at 3:32am officers were dispatched to Y-Not II, 706 E. Lyon St for a battery complaint. The victim, Kevin HAGE, stated he was a bartender at Y-Not II but was not working at the time of the incident. He stated at about 2:30am he allowed two patrons (one male and one female) back in the bar to look for their lost cell phones. While escorting them out the male accused HAGE of pushing his girlfriend. The male then attempted to hit him but missed. He then pushed HAGE to the ground and hit him to the head. The on duty bartender was Cassondra KELLER. She stated after HAGE pushed the subjects outside the female punched her to the face twice. The video of the incident was recovered and placed on inventory. Milwaukee Police Department IR#17-039-0069 filed.






