We are writing to express our opinions on and opposition to the application for a Class A Malt & Class A Liquor license for Family Grocery Store, located at 5160 W. Forest Home Ave. We have had negative interactions with the owners of this business on multiple occasions. The owners harass anyone who pulls into their parking lot who does not immediately go into their store.

My family and I have been residents in the for seven years. When we first moved into the apartment, we had gone to their store to check it out and purchased a few snack items. They were very unfriendly towards us, and we haven't gone back to the store since.

As I work 10+ hours a day, my disabled wife will often have groceries or food delivered to our apartment. Sometimes there is no available parking along Forest Home in front, and delivery people do not notice that there is an alley at the back, so they will pull into the parking lot to drop off items. The delivery drivers are immediately accosted by the owners before they are even able to get out of their car. The owners take pictures of the drivers and their cars and threaten to call the police. This includes company delivery services such as Amazon and Fed Ex. My wife has had delivery drivers express concerns for their safety, and one driver had stated that the male owner had pulled a gun. People who had regularly picked up orders for us have stated that they do not feel safe and will no longer accept our orders. The only non-customers allowed to park there are law enforcement and the postal service.

Adding the ability to sell alcohol makes us concerned about the potential for noise pollution and traffic

congestion. Forest Home is already a very busy road. The intersection of Utah and Forest Home, where the store is located, is a dangerous intersection. It is difficult to see oncoming traffic from the East due to the shrubbery and the cars/trucks parked in front of the Auto Plex car dealership at 5130 W. Forest Home Ave. We are afraid more traffic will lead to more accidents in the area.

We are also concerned about the potential for illegal activities. Our apartments open directly to the outside, not a hallway or secured entrance. We have had homeless people sleeping on our porches and patios, and law enforcement had to be called. The owners have already put up a fence around their back lot because of people doing illegal activities there. With the addition of a liquor store right out our front door, I am concerned that these instances will go up.

There are already liquor stores in the area. Forest Home Beer and Liquor is four blocks West of this location. Not to mention Discount Liquor and El Rey Grocery Store are on the corner of 51st and Oklahoma Ave. We do not believe that there is a need for another business selling liquor in the area.

We hope you will take our opinion into account when making your decision.

ADDITIONAL COMMENTS/RECOMMENDATIONS:

This report was written by Police Officer Fabian Garcia assigned to District 6-Days, Community Liaison/Community Partnership Unit.

On Monday, May 19, 2025 at 9am, my partner Police Officer Michael Ward and I met with Licensee/Agent Ranko Lalusic at Family Grocery, located at 5160 W. Forest Home Avenue.

The location is currently open and currently hold a food and weight and measures license. This business is family operated and has been in business since 2014. Ranko stated that they have attended the Robbery Prevention Training in 2014, which was displayed. The location is equipped with four exterior cameras, two that are located in the front of the business and parking lot, and two in the rear of the building. The business is equipped with 5 interior camera, which do face the entry and exit doors, register and front counter area. There is a monitor screen located near the front counter, where employees are able to monitor the cameras, while also attending to customers.


The location does have a parking lot that is equipped with signage for customer parking only. Ranko stated that he plans to add "No Loitering" signs on their building. The standing complainant form was filled out and filed and Ranko was provided with a District 6 community contact guide.

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.) 6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
