1st Aldermanic District

W. Hopkins St. – N. 34th St. to N. 35th St. (ST211110131):

Concrete pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, narrow width of roadway from 56 feet to 50 feet, install concrete walk where none currently exists, sodding (0-2 foot width of tree border area), and grading.

No one present when called.

Ald. Donovan moves approval with late billing. Prevailed 4-0. (Ald. Wade excused)

N. 28th St. – W. Atkinson Ave. to W. Glendale Ave. (ST211060103):

Pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, widen width of roadway from 26 feet to 30 feet, sodding (9-foot width of tree border area), and grading.

No one present when called.

Ald. Bohl moves approval with late billing. Prevailed 4-0. (Ald. Wade excused)

N. 34th St. – W. Capitol Dr. to W. Hopkins St. (ST211110113):

Concrete pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, narrow width of roadway from 57 feet to 50 feet, install concrete walk where none currently exists, sodding (5-11

foot width of tree border area), and grading.

Pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (0-7 foot width of tree border area), and grading.

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (8-foot width of tree border area), and grading.
