

NOTICE OF CIRCUMSTANCES GIVING RISE TO CLAIM  
AND CLAIM PURSUANT TO WIS. STAT. S 893.80

PLEASE TAKE NOTICE that Ivorena Taylor states that the following  
circumstances give rise to a claim:

1. On Wednesday, December 3<sup>rd</sup>, 2003 at 8:54 p.m., two masked armed men forced they way into my home at gunpoint. The police were called at 8:54 p.m. and the call was given a Priority 1 status. The police arrived on the scene at 9:14 p.m. and when they were asked what took them so long, they stated they arrived 5 minutes after being dispatched. Upon search of the house, I informed police that my video camera had been stolen which had the taping of my child's birth on it. That was the only item found to be missing, but the value of the tape it contained was priceless and the perpetrators stole the video camera on their way out of my home. Had the police been dispatched in a timely manner from a location that was closer in proximity to my home, they would have arrived while the perpetrators were still in my home.
2. On December 4<sup>th</sup>, I filed a complaint with the Chief of Police Ann Haggerty and I requested copies of the six 911 calls that were placed from open records. As of March 31, 2004, I had yet to hear anything regarding the status of my complaint so I called Internal Affairs who informed me that the investigation had been completed on February 12, 2004 and that the dispatcher (TC11) was at fault because she failed to follow proper procedures when dispatching a Priority 1 call. She was counseled and the investigation was closed. They never contacted me with the results because they received a new computer system that wasn't set up to generate a letter giving me the status of my claim. I will be seeking damages from the city totaling \$50,000 which is comprised of \$451.68 for my camcorder and it's accessories and \$49,548.32 for the tape which contained the birth of my son which I will probably never get back and it's true value is an indeterminable amount, and emotional distress.

WHEREFORE, claimant, whose name and address are stated above, claims relief against City Clerk Ron Leonhardt and the Milwaukee Police Department - Communications Department for \$50,000.

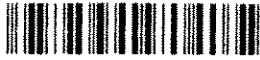
