Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. This report is written by Police Officer Felix, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 08/08/2007, at 9:34am, a Milwaukee Police Department squad was sent to an armed robbery at the Wendy's parking lot 4601 W North Avenue. Upon arrival spoke to the manager who stated as he was walking to his car he was robbed of the night deposit, which is approximately \$2000.00. He stated it was two black males with a gun in a maroon Ford Expedition that fled eastbound through the rear alley.

2. On 05/31/18 at 8:24am a squad was dispatched to 4601 W. North Avenue (Wendy's) for a burglary complaint. Squad arrives and concludes a burglary did happen and an incident report was filed (171510029).
3. On 08/20/17 at 4:00pm a Milwaukee Police squad, while on patrol, observed two vehicles and a pedestrian dealing drugs in the parking lot at 4601 W. North Avenue (Wendy's). The officer's stopped the individuals in the parking lot, found drugs and drug packaging material, and they were arrested. An incident number was filed (172320130)

4. On 03/19/2019 officers were dispatched to a property damage at Wendy's, 4601 W. North Av. The officers spoke with that manager who stated an employee was having a problem with an ex-boyfriend. The employee stated she had an argument with her ex-boyfriend prior to coming to work. When she got to work he pulled up in his car and she closed the business door and locked it. He then kicked the door and left the scene.

5. On 10/04/20 Milwaukee Police were dispatched to 4061 W. North Av (Wendy's) for a hold up alarm. Upon arrival officers spoke with an employee who stated that the alarm was activated by mistake, and did not require the police. Officers checked the restaurant and observed that no one was in distress. The employee was not pleased that the police were at the location.

6. On 09/02/22 at 2:04pm, Milwaukee Police were dispatched to 4601 W. North Avenue for a property damage complaint. Investigation revealed that two terminated employees damaged property at the establishment. The manager had surveillance footage of the incident and she was cooperative with the investigation.
7. On 11/06/22 at 6:22pm, Milwaukee Police were dispatched to 4601 W. North Avenue for a shots fired complaint. Surveillance footage showed a vehicle parking in the middle of N. 46th Street, just south of W. North Avenue. The driver exits the vehicle and walks toward the establishment and at the same time an employee of Wendy's exits the building and walks toward the drive through. The two subjects exchange gunfire, and both leave the scene before police arrival.

8. On 03/24/23 Milwaukee Police were dispatched to 4601 W. North Avenue for a theft complaint. Officers spoke to the employee who stated that his phone was taken while he was on his lunch break. Officers reviewed video of the incident, and the phone was taken by two customers of the restaurant, while the employee walked away.
9. On 04/03/23 at 8:32am, Milwaukee Police were dispatched to 4601 W. North Avenue for a damage to property complaint. Officers spoke with the manager who stated that on the previous night a customer became upset over a food order. The customer exited her vehicle and threw a car jack at the business window damaging the window. The manager stated that he would get a working copy of the video for officers at a later date.
10. On 10/22/23 at 11:40pm, Milwaukee Police were dispatched to 4601 W. North Avenue for a sick and injured complaint. Officers spoke with the manager who stated that an employee had a medical emergency. Milwaukee Fire Department was on scene treating the employee. The manager stated that employee was working and then he just fell to the floor. The employee was conveyed to the hospital for medical evaluation.

11. On 04/11/24 at 10:32pm, Milwaukee Police were dispatched to 4601 W. North Avenue for a subject with weapon complaint. Investigation revealed that a customer was upset for not receiving the proper change and confronted the employee about it. An argument ensued and the customer said the employee displayed a firearm in his waistband. The manager on scene said she pulled the employee back to deescalate the situation and she never saw the employee with a gun. The manager called her supervisor who checked the surveillance video and he said he did not see a firearm on video. The employee was not at the establishment when police arrived.

The following items are relayed to 4601 W. North Ave.

12. On 08/24/25, at 2:24 a.m., Officers were dispatched to a Subject with Weapon complaint. An employee and known subject engaged in a physical fight in the business's parking lot. The employee was armed with knife and the subject armed with a handgun. The manager provided security camera footage.
13. On 03/06/26, at 7:30 Milwaukee Police received a walk in Robbery complaint. A victim reported on 03/05/26 they were conducting a Facebook Market transaction in the parking lot. One of the suspects pointed a handgun at the victim and fled with their money. Security camera footage was available for review.

This report is being written by PO Justin YOUNG assigned to District 3, Late Shift.

On Sunday, August 24th, 2025 at 2:24 AM, Squad 3330 (PO Joseph MACK and I equipped with Axon body cameras that were active during this investigation) along with Squad 3390 (PO Isaac ORTIZ and PO Samuel WAGGONER) were dispatched to a Subject with a Weapon call for service at the Wendy's located at 4601 W North Av, which is in the city and county of Milwaukee. PO MACK and I arrived on scene at 2:26 AM, where I observed two subjects near the Wendy's entrance next to a silver vehicle. According to the CAD notes which stated that there were two subjects physically fighting where one subject was armed with a knife and the other a firearm. I drew my firearm and ordered one male individual who was shirtless later identified as Alexander A. WILLIAMS (B/M, 08/02/1989), Wendy's employee, to show me his hands. WILLIAMS was then detained. PO WAGGONER pointed his firearm at the other individual wearing a black sweatshirt later identified as Jazmaine M. LINTON (B/M, 07/02/2003) and detained him for the investigation.

I spoke to WILLIAMS near the entrance of the Wendy's restaurant. WILLIAMS stated that on Sunday, August 24th, 2025, he and his coworker, Lafonda L. JORDAN (B/F, 06/03/1997) had just finished closing out the restaurant when he walked outside and observed LINTON outside. WILLIAMS stated that he and LINTON have a mutual friend and have been arguing about a female talking poorly about LINTON. WILLIAMS stated that he observed LINTON holding a firearm to the side when LINTON stated that he was going to "blow WILLIAMS down". WILLIAMS stated that he went back inside of the Wendy's restaurant and grabbed his backpack. WILLIAMS stated that he went back outside carrying his backpack when he was met up by LINTON again. WILLIAMS then stated that LINTON pointed the firearm at him causing him to fear for his safety. WILLIAMS stated that LINTON struck him with the firearm in the head about 2-3 times causing him pain. WILLIAMS then stated that he knocked the firearm out of LINTON's hands and grabbed the knife from his backpack to defend himself. WILLIAMS then stated that he and LINTON began to physically fight with each other while he was on the ground and started tussling over the knife. WILLIAMS stated that he and LINTON continued to fight until police arrived on scene.

Officers spoke with the caller and one of the employees of the Wendy's, Lafonda L. JORDAN (B/F, 06/03/1997) who was unable to provide video surveillance of the incident, but would contact the District manager regarding the incident.

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
