
### 2026 Revenues Summary




In 2026, the Budget and Management Division anticipates an increase of revenues for general city purposes of \$15.9M from 2025. Overall, City will still collect \$21.9M less in revenue than in 1995 when adjusting for inflation.

The City will receive \$196.6M less in intergovernmental revenues in 2026 than in 1995 when adjusting for inflation, forcing the City to shift to a greater reliance on charges for service, property taxes, City sales taxes.

### 2026 Proposed Fees & Forfeitures



#### Conduit Fees

Ordinance 250708 passed on 9/23, which increases anticipated revenue by \$500,000

#### Vehicle Registration Fee

- Increase the fee from \$30 to \$40 –\$2,750,000 anticipated increase in revenue
  - Stand alone legislation

#### DPW

- Increase all processing fees to \$20
- Increase weed and snow removal violation charges by 50% \$130,000 anticipated increase in revenue
- Increase excavation permits 20-40% \$125,000 anticipated increase in revenue
- Increase oversize load permits 40-50% \$50,000 anticipated increase in revenue
- Increase temporary occupancy permits 15-45% \$240,000 anticipated increase in revenue
- Increase special permits to use the public way by 25% \$30,000 anticipated increase in revenue

## 2026 Proposed Fee Increases Continued



#### **DNS**

- Most electrical installations increased 10-25% \$220,000 anticipated increase in revenue
- Heating system permits increased \$5 for most units, \$50 for commercial and industrial exhaust hoods
  \$50,000 anticipated increase in revenue
- Updates to some other miscellaneous fees which weren't updated last year \$166,000 anticipated increase in revenue


#### **Common Council-City Clerk and Health**

- Increase miscellaneous business licenses 15-20% \$175,000 anticipated increase in revenue
- Increase food dealer licenses 15% \$450,000 anticipated increase in revenue
- Increase health reinspection fees 20% \$10,000 anticipated increase in revenue

### Tax Stabilization Fund




#### **TSF Balances and Withdrawals**
