Returned herewith is a document filed by Attorney Laurie Eggert for attorney's fees for representing Police Officers John Amberg, Gregory Wagner and Michael Albright. The claim is in the amount of \$1,683.90, including \$11.90 in disbursements for 15.20 hours of service billed at the rate of \$110.00 per hour. We ask that this matter be introduced and referred to the Committee on Judiciary & Legislation.

We have reviewed this claim and advise that in our opinion, the time spent was reasonable. Legal representation was occasioned by a criminal investigation. No criminal charges were brought against the Police Officers on whose behalf this claim was filed.

As we have advised you under similar circumstances in the past, the Common Council has discretion to reject this claim or to pay it in whole or in part. Sec. 895.35, Stats., Bablitch and Bablitch v. Lincoln County, 82 Wis. 2d 574 (1978).

This report was dictated by Detective Jeffery HOOVER, of the Internal Affairs Division/Criminal Investigation Unit (IAD/CIU), day shift.

#### **ALLEGATION:**

The complainant, Otha D. HUDSON, states that three Milwaukee police officers, later identified as P.O. Michael ALBRIGHT, P.O. Gregory WAGNER and P.O. John AMBERG illegally entered his apartment with their guns drawn and conducted a search without lawful authority or consent.

### **INVESTIGATION:**

On March 3, 2000, I, Det. Jeffery HOOVER, interviewed the complainant. The complainant stated on February 7, 2000, he was inside the apartment with his relatives and a friend. The police knocked at the door and his cousin, Shawn WILLIAMS, opened the door. Next, three police officers entered the apartment without consent. Two officers were armed with a handgun and the third officer was armed with a shotgun. The officers searched the premises with their guns drawn. Additionally, the officers entered a rear bedroom and arrested his cousin, James WILLIAMS. Also, the officers actions caused everyone to become frightened and his auntie, Betty WILLIAMS, urinated on herself.

In addition, the following relatives were located and interviewed. Joel WILLIAMS, Betty WILLIAMS and Edwin Lashaun WILLIAMS (also known as Shawn WILLIAMS). The

statements obtained from the relatives corroborated the complainant's statement.

Furthermore, all three officers involved in this incident were interviewed. The officers indicated that they were sent to the complainant's address to check for a James WILLIAMS who was wanted on a felony warrant for Recklessly Endangering Safety (RES). They further indicated they were given permission to enter and therefore they searched the premises and found James WILLIAMS hiding in a rear bedroom closet. They denied entering the apartment illegally.

On Tuesday, August 22, 2000, Deputy District Attorney Jon REDDIN reviewed the case and declined to issue the charge of Misconduct in Public Office against the officers. Deputy DA REDDIN based his decision on the fact that the officers knew a felony arrest warrant existed for Mr. James WILLIAMS and they had probable cause to believe that he was inside the residence. In addition, he felt that the actions of the officers were legal and they acted properly.

#### **CONCLUSION:**

Investigation by the Criminal Investigation Unit revealed that the three officers were dispatched to the complainant's location to check for James WILLIAMS, who was currently wanted on a felony warrant for RES. An occupant of the apartment opened the door enabling the officers to enter the premises, at which time they searched for James WILLIAMS and found him hiding in a rear bedroom closet. All three officers involved in this incident were interviewed and they denied entering the premises illegally. Deputy DA REDDIN reviewed the Misconduct in Public Office and declined to issue any charges. Therefore, this case will be cleared as warrant refused.
