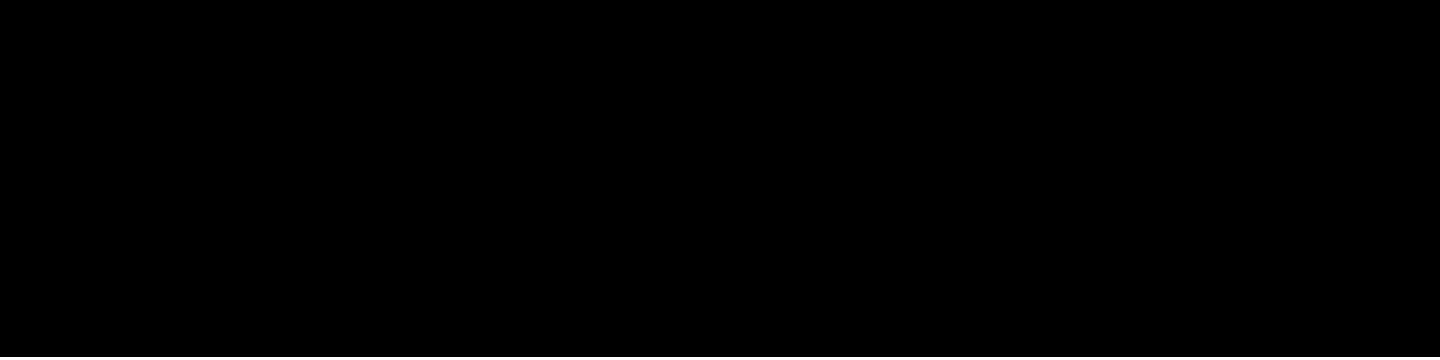

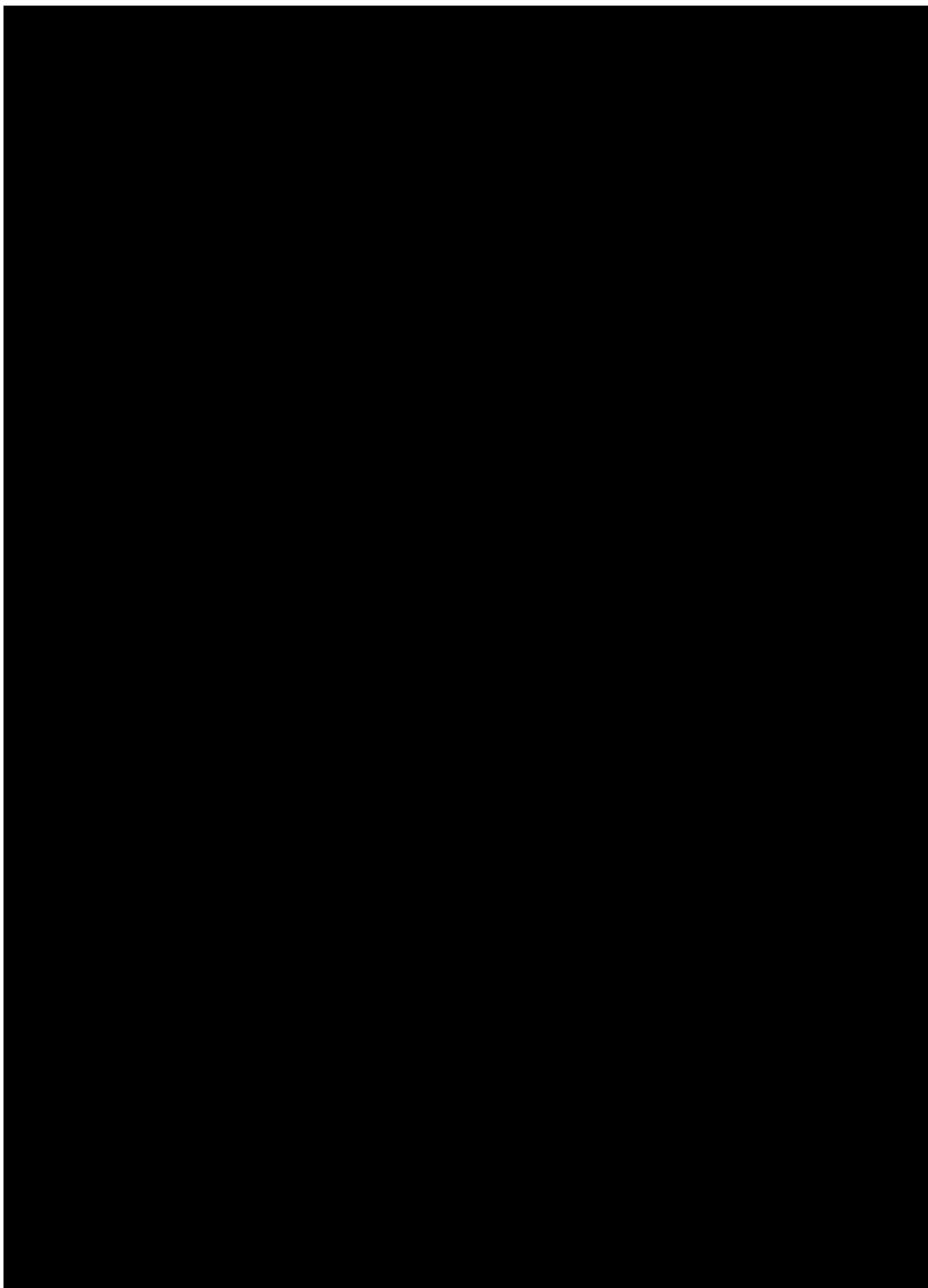

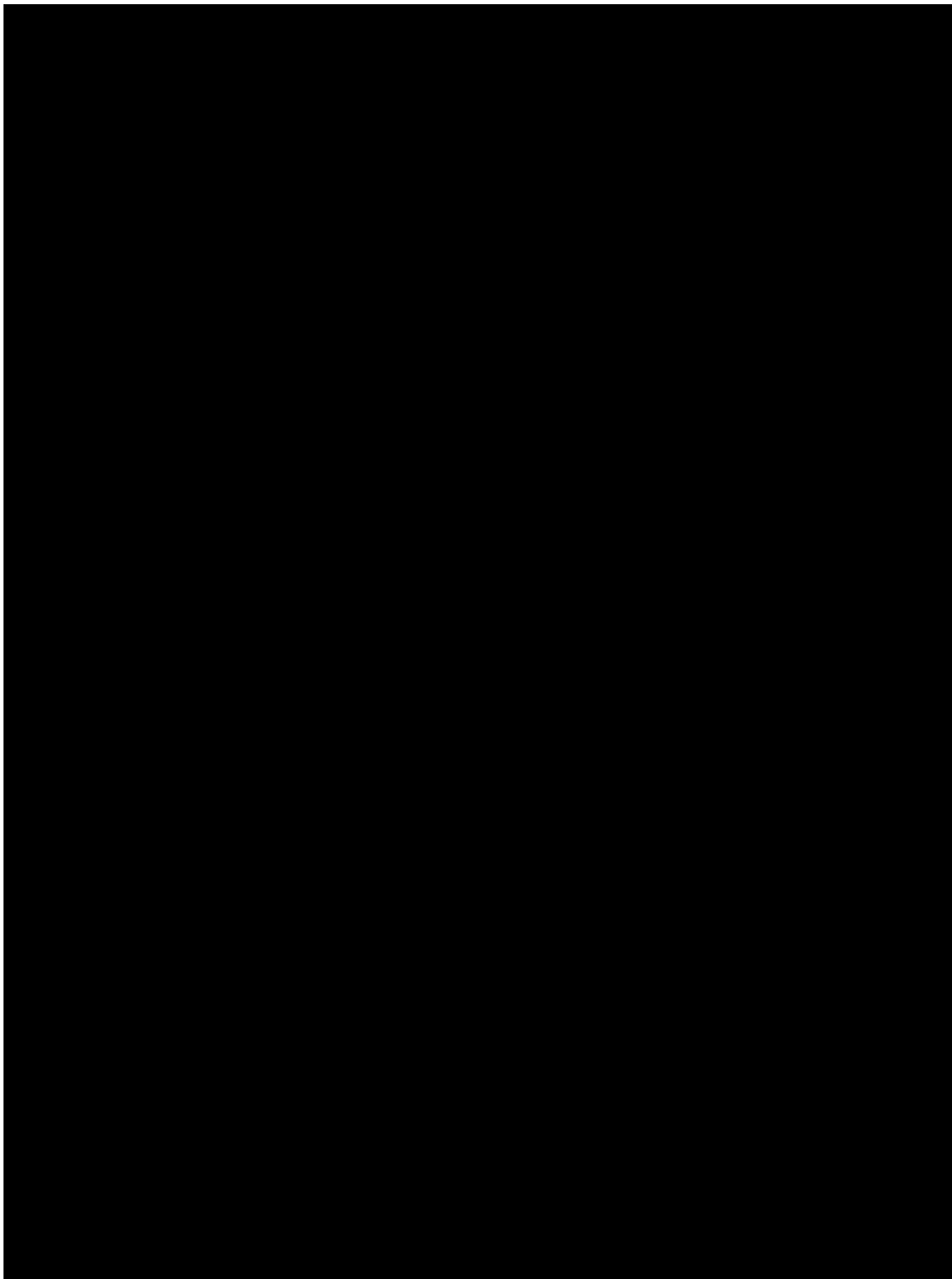
- a. The team training officer shall file a roll call training outline with the team ~~manager~~ **coordinator**.

- c. The team equipment officer shall file equipment checklists and Electronics Function Check forms with the team ~~manager~~ **coordinator**.

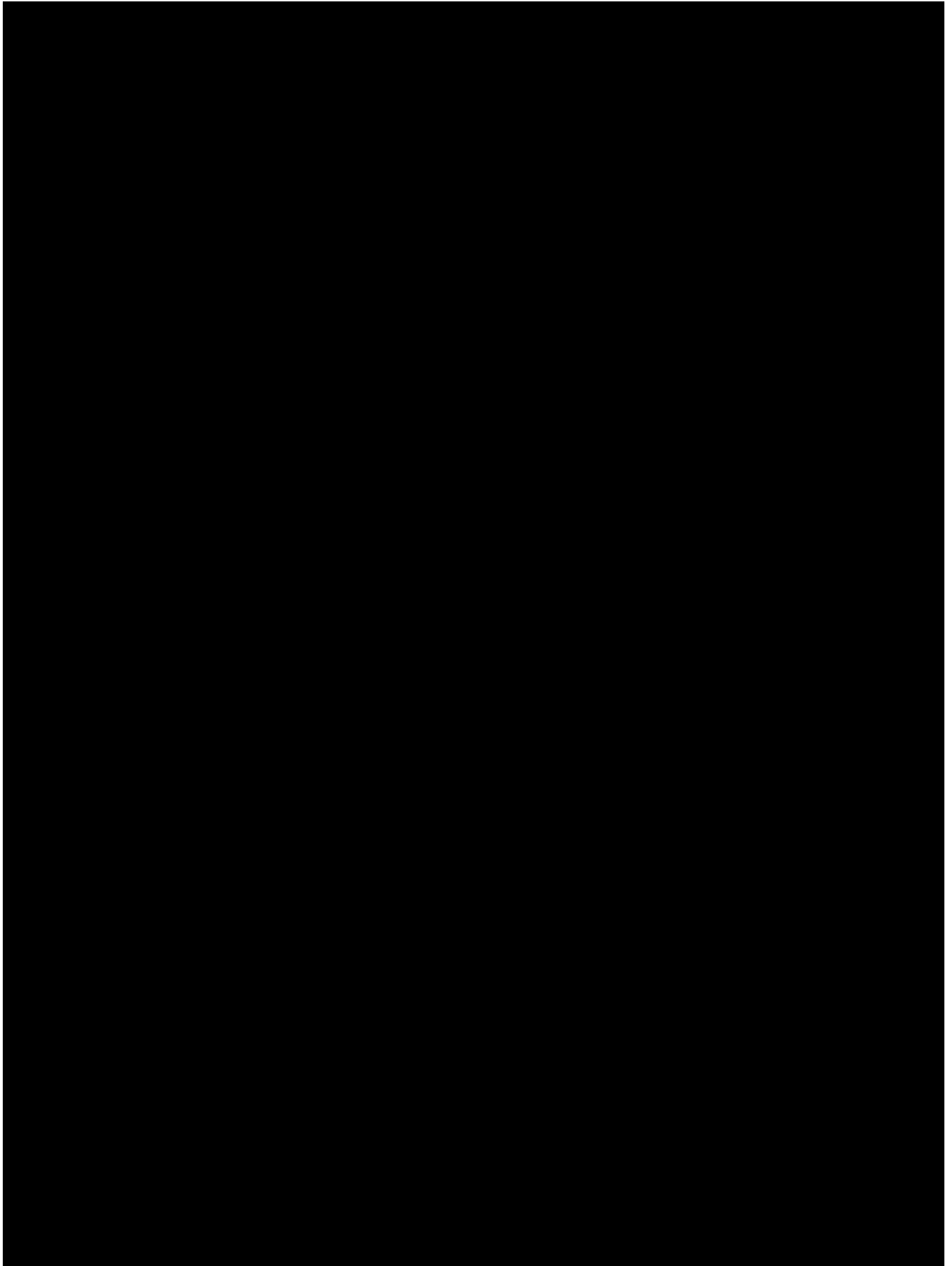

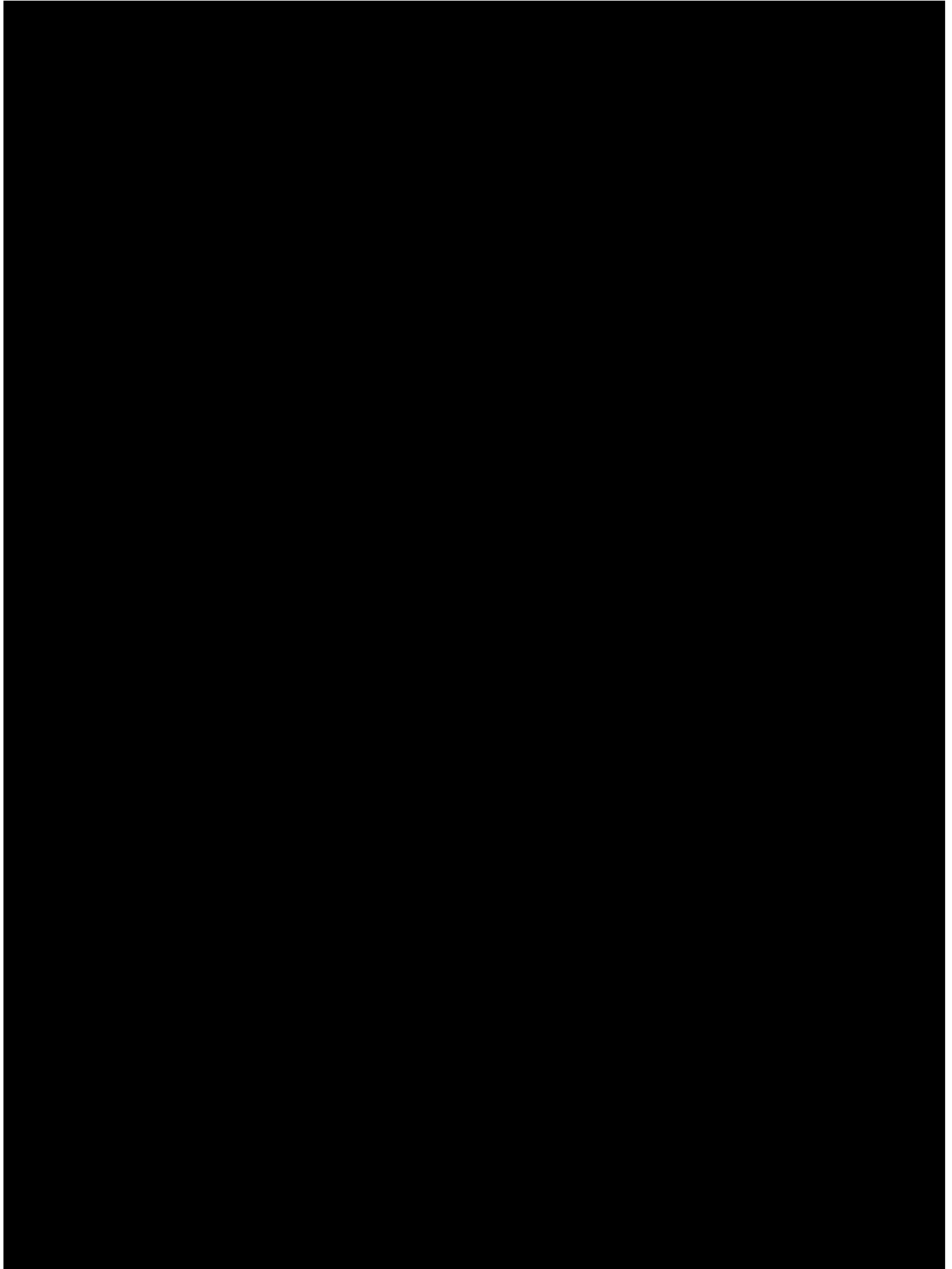
D. UNAUTHORIZED RIDERS PROHIBITED

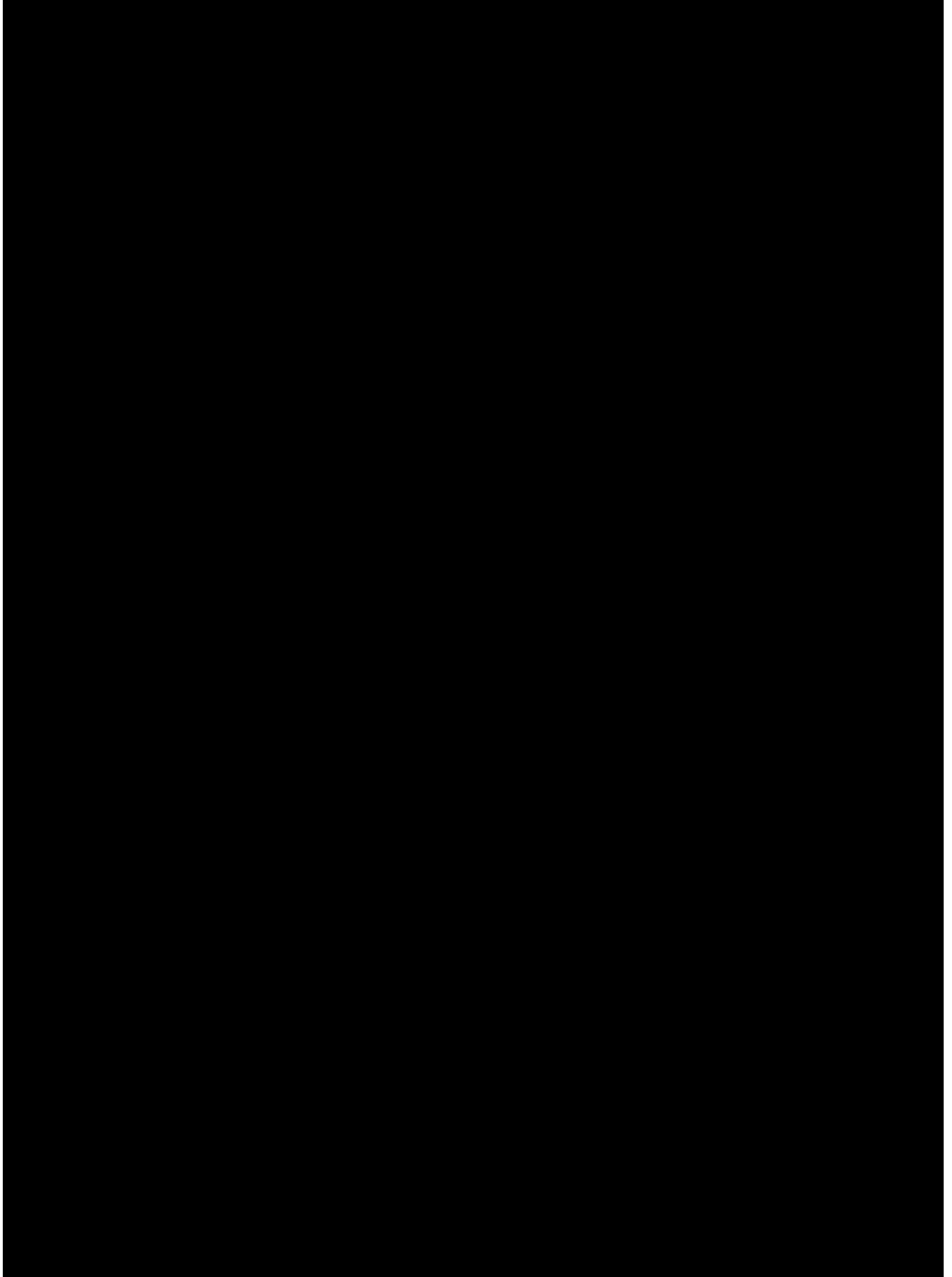
1. No unauthorized person may ride **on** a Milwaukee Police Department boat. The Marine Operations - Harbor Patrol Unit supervisor, **unit commander, or commanding officer of SPD** shall determine who is authorized.
 2. Persons requiring conveyance to safe harbor, prisoners, and persons undergoing field sobriety tests do not require prior authorization.

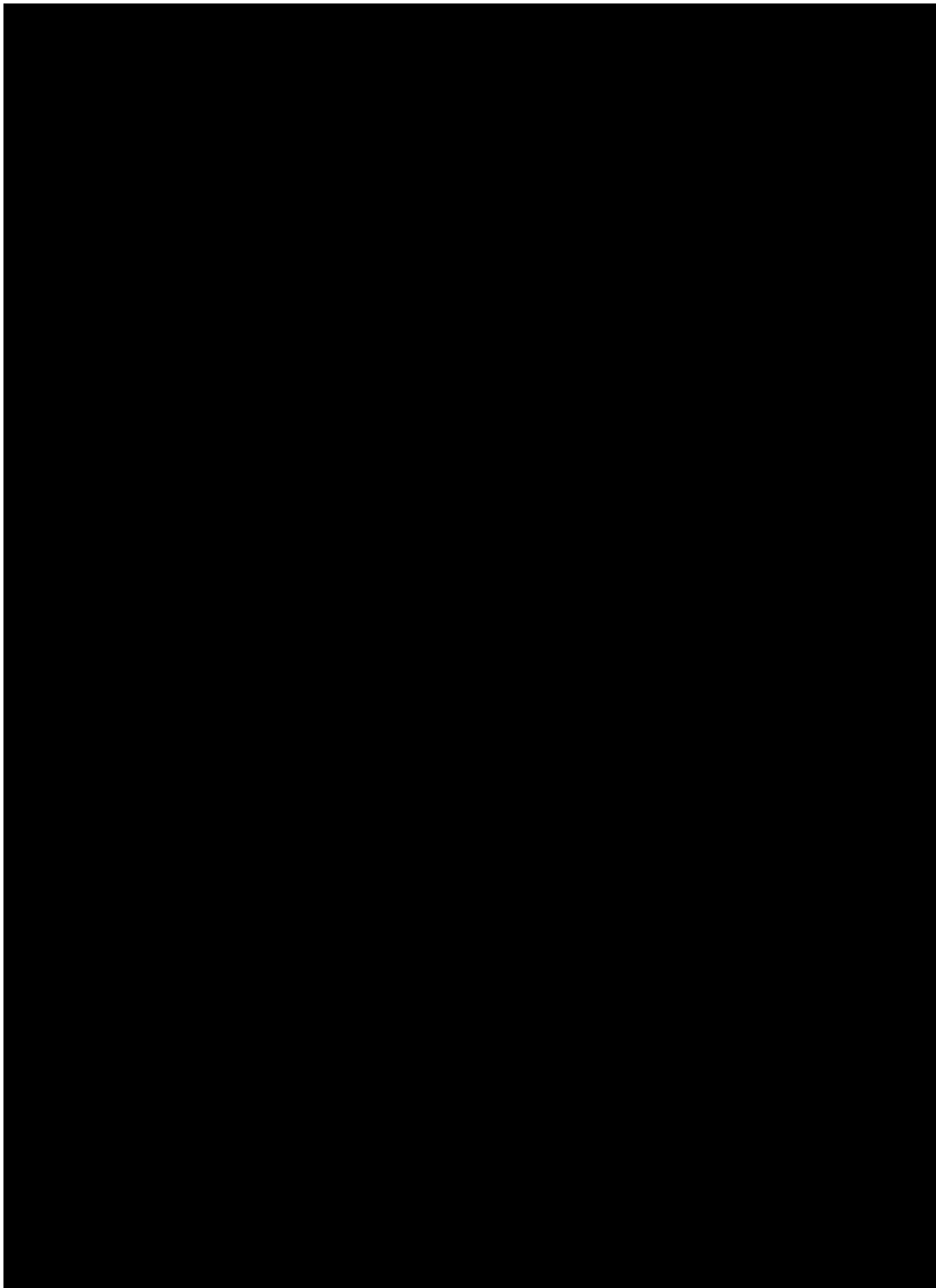


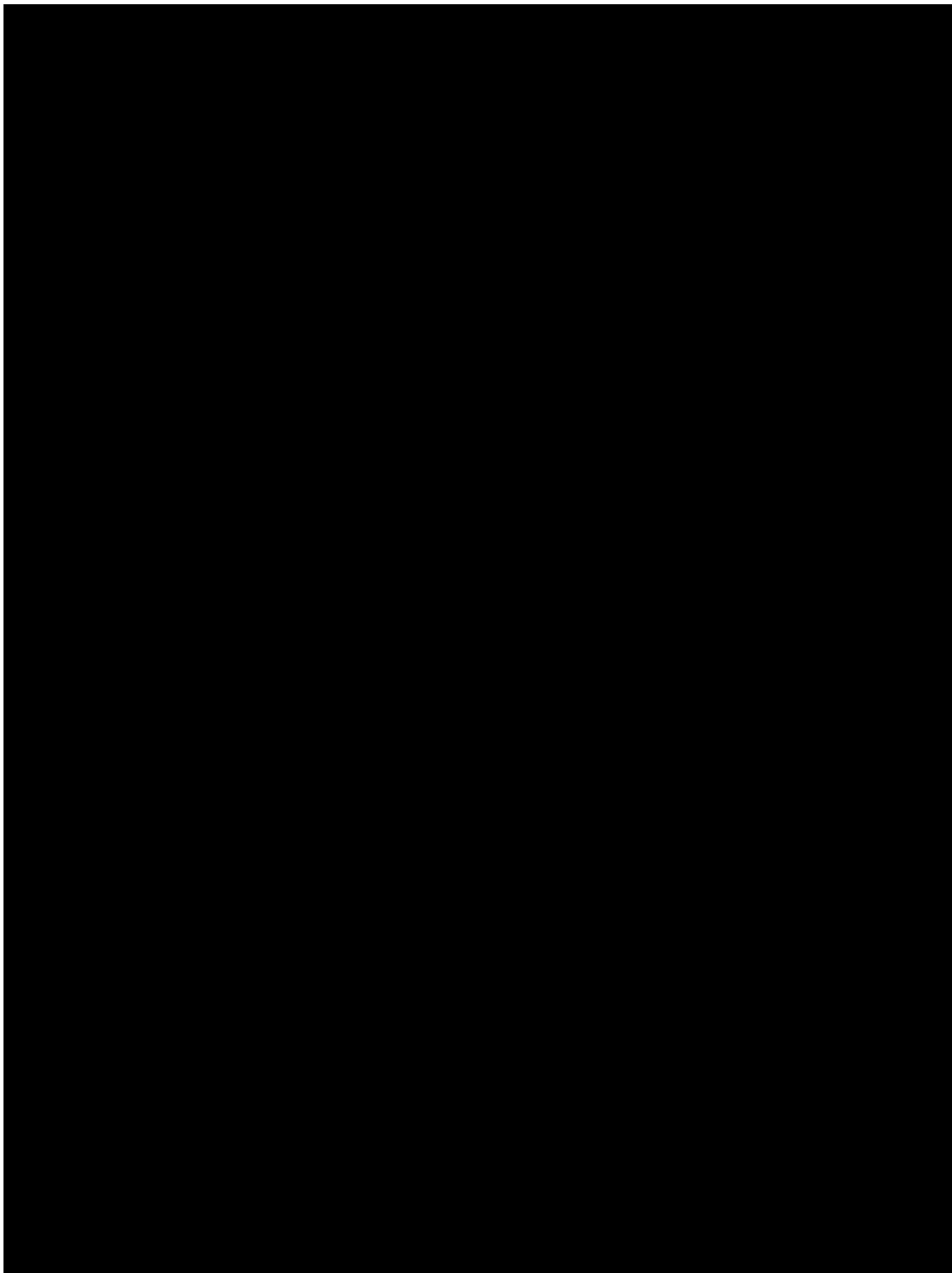








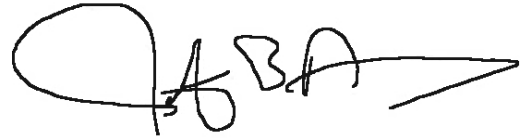
