If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffit, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Numerous complaints have been registered with the third district police and have been basically ignored. The dept of neighborhood services has been notified of the collapsed of they are still allowed to continue with outdoor parties for opening day of the Brewers and more outdoor activities.

We are concerned for the safety of our property and the regularly overserved guests at these gathering. contact the police for noise complaints (loud bass thumping clearly heard more than 50 feet away from the source)nothing can be done. pets stress out with the hours of constant noise rattling the . frequently have to leave for relief to these problems.

We are trying to get a response from the city and the police to correct the violations of this establishment.

Over the past 20 plus years of our residency we have encountered numerous obstacles. Police will not respond because they have friends in the bar. City building inspectors are also buddies of the bar and the residential property

.( owned by the same people who own the bar and whose foundation is in a state of disrepair that has had insurance canceled and to do work on for fear of the possible damages )

# some of the things we have experienced in the 20 plus years of living near Kelly's Bleachers.

Most recently when we registered a complaint about the fence and the condition of the foundation at the adjacent building owned by the bar at 519 N. 52nd St.

The third district police have told us they can't do any thing about noise complaints because the address of 5218 W. Bluemound is in wauwatosa

Third district police will not register noise complaints or any other complaint against this establishment. Making it difficult to present any evidence of of a problem to the common council.

Police having lunch in the bar have been sent to our front door by the bar owner to talk to us about a civil matter.

In the past we have had drunken patrons fall into our driveway due to lack of proper fencing.

have had 2am visits from drunk people insisting they be let into our home(so drunk he did not know where he was)the police officer who came to answer up call walked him to his vehicle.

The police in the past used to escort numerous drunks to their cars at closing time.

have been threatened by officers that want us to leave their friends at the bar alone and had our employment compromised by police calling our jobs.

Previous visits to license committee and common council have resulted in regulations that are ignored. Including our notification of when their license is up for renewal.

Previous contact with neighborhood services has resulted in us being sited.

These are just some of the incidents we have had to deal with.

This group of people are not a friendly business owners,, snow and leaves have been maliciously blown onto hand when confronting they have threatened our lives.

One of the first incidents we encountered involved an officer Miller who at bar closing time to answer a call (he was drunk and tapping on his service revolver) telling us to leave his friends at the bar alone



The Milwaukee Police Department's investigation regarding this application revealed the following:

- - 2. On 07/06/2018 at 12:25am officers investigated an incident at Kelly's Bleachers, 5218 W. Bluemound Rd. The investigation revealed the waitress attempted to close out a bill and the credit card was declined. She told a security guard who approached the subject outside as he was sitting in a vehicle. The subject became verbally combative and made threats to shoot him. The subject then drove off in their direction, almost striking the security guard.
  - 3. On 01/01/2019 at 2:19am officers responded to a battery complaint at 5218 W. Blue Mound Rd. The officers spoke with the victim who stated he was outside of Kelly's Bleachers waiting for an UBER when a male subject was talking to a female in a degrading manor. The victim confronted the subject about the way he was treating the female and the subject hit the victim with a cane to the shoulder and head. The victim then punched the suspect, causing him to pass out. The officers spoke the suspect who did not recall what happened. The officers spoke with the applicant who stated he did not witness the fight but helped his security assist the subject up off the ground and told another employee to call 911. Both of the subjects refused medical attention and stated they did not want to press charges.

4.	On 08/25/2019 at 2:30am officers were dispatched to fight at Kelly's Bleachers, 5218 W. Blue
	Mound Rd. When the officers arrived they observed a subject lying on the ground out front
	bleeding from the head. The victim stated she was exiting Kelly's Bleachers and observed two
	groups of former patrons fighting outside. She attempted to break up the fight and was struck
	in the head with the base of a car seat. The manager, Brendan BUTLER, stated there is a
	camera on the front door but it does not face the street and would likely not have captured the
	fight.

- 5. On 03/13/2020 at 9:57pm officers conducted a license premise check at Kelly's Bleachers, 5218 W. Blue Mound Rd. The officers found no violations.
- 6. On 03/16/2020 at 9:11pm officers conducted a license premise check at Kelly's Bleachers, 5218 W. Blue Mound Rd. The officers spoke with the bartender and informed them of the rules going into effect at midnight. The staff stated they understood the rules. No violations observed.
- 7. On 05/11/2020 at 11:23am officers were dispatched to Kelly's Bleachers, 5218 W. Blue Mound Rd, regarding a violation of the Safer at Home order. The officers found only employees inside, with the business not open. The complaint was found to be baseless.
- 8. On 05/13/2020 at 7:16pm officers were dispatched to Kelly's Bleachers, 5218 W. Blue Mound Rd, for the business being open. The officers spoke with the applicant, who stated they were open for curb side pick-up only. The applicant allowed the officers inside where they only observed employees.

- 9. On 04/22/22 at 12:30am, Milwaukee Police were dispatched to 5218 W. Bluemound Road for a battery compliant. Investigation revealed that a patron was escorted out of the establishment because he was causing problems with multiple people inside. The subject attempted multiple times to regain entry into the tavern and on the final attempt the subject was denied, he fell back, striking his head on the concrete sidewalk. No employees were able to gain access to the security cameras to view the incident.
- 10. On 06/14/22 at 12:37am, Milwaukee Police conducted a license premise check at 5218 W. Bluemound Road. No violations were found and the bartender was cooperative.

- 11. On 12/27/22 at 1:12a.m., Milwaukee Police conducted a License Premise Check at 5218 W. Blue Mound Rd. No violations were found and the bartender was cooperative.
