Dear Ms. Bruce:

We have received your claim for the amount of \$10,000.00 in relation to the personal property you allege was stolen from your vehicle while it was at the City of Milwaukee Tow Lot.

The City of Milwaukee Tow Lot reports your vehicle was towed on August 23, 2013 from 321 West Wisconsin Avenue due to being parked in a tow zone. The tow report indicates the vehicle was towed with prior dings and scrapes. The doors were locked at the time of the tow, and the keys to the vehicle were not made available to the tow company or the tow lot.
