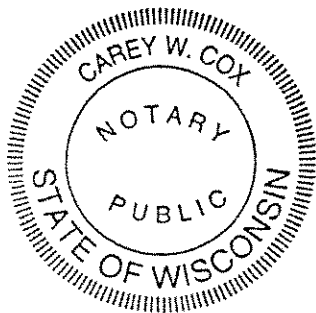

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, and storm drainage facilities where needed.
