Dear Mr. Sharman:

We have received your claim in the amount of \$3,129.00, relating to the total loss of your vehicle from an October 31, 2014 loss in which you allege that because a stop sign for northbound traffic at the intersection of North Cramer Street and East Thomas Avenue had been turned and was facing the wrong direction, you collided with another vehicle.

The Infrastructure Services Division records indicate that prior to this loss, the City had no notice of this hazard and because of this lack of notice the City would not be liable. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.
