## QUARTERLY REVIEW

*January 1—March 31, 2023-2025*

### Part I Crime

2025 compared to 2024:

- Part I crimes have decreased 12% (4,840) from (5,521)
- Homicides increased 9% (25) from (23)
- Aggravated assaults decreased 23% (1,207) from (1,565)
- Carjackings decreased 12% (73) from (83)

### Crash Data

2025 compared to 2024:

- Crashes decreased 6% (3,225) from (3,417)
- Hit and run crashes also declined 6% (1,201) from (1,279)
- Fatalities decreased 30% (7) from (10)

### Clearance Rates

In 2025, the homicide clearance rate was 124%\*.

**Data Methods:** Part I crime data was obtained from the DCS Fact table and counts distinct incidents (with the exception of rape, aggravated assault and human trafficking which count victims) for the time period of January 1—March 31, 2023-2025. Homicide and non-fatal shooting data was obtained from the OMAP Homicide and Non-Fatal Shooting databases and counts victims for the same time period above. Carjacking data was obtained from the OMAP Carjacking database and counts distinct incidents for the same time period above. Crash data was obtained from TraCS 10 and counts distinct crashes for the same time period above. Fatal crash data was obtained from OMAP Fatal Crash database and counts victims for the same time period above. UCR Homicide clearances were obtained from the Homicide Division and reflects homicides cleared by arrest or exceptional means and include prior year clearances. Note the homicide clearance rate may exceed 100%, since prior year homicide clearances are included in the UCR clearance rate formula: Total cases cleared in 2025 / Total homicides in 2025.
