## Dear Alderman Bauman:

This is in response to a request our office received from a citizen to install the above-captioned parking restriction.

Our traffic engineering staff has investigated this request and found that southbound motorists exiting North 12th Street at West Saint Paul Avenue have a difficult time seeing traffic traveling westbound on West Saint Paul Avenue when vehicles park close to the intersection. Therefore, in the interest of public safety, we recommend installing the above-captioned parking restriction to increase cross traffic visibility at the intersection.

We will prepare the necessary legislation for the next Public Safety and Health Committee meeting, so that you may support it to final passage.
