..Title

Resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$225,000 for a total estimated cost of these projects being \$696,000.

..Analysis

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$225,000 with the total cost estimated to be \$696,000.

..Body

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

6th Aldermanic District

N. 6th St. – 250' +/- south of W. Vienna Ave. to W. Vienna Ave. (SM495250044) Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost of the project including the requested amount is \$88,000. This project is anticipated to be completed during the 2026 construction season.

W. Concordia Ave. – N. 9th St. to N. 10th St. (SM495250042) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost of the project including the requested amount is \$89,000. This project is anticipated to be completed during the 2026 construction season.

W. Concordia Ave. – N. 11th St. to N. 12th St. (SM495250043) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost of the project including the requested amount is \$88,000. This project is anticipated to be completed during the 2026 construction season.

8th Aldermanic District

27th Street Viaduct (400 North) (BR100250114) Bridge expansion joint replacement. (City Share Non-assessable Structure Fund - \$150,000). The total estimated cost for this project is \$150,000. The project is anticipated to be completed during the 2026 construction season.

W. Orchard St. – S. 41st St. to S. 42nd St. (SM495250045) Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost of the project including the requested amount is \$95,000. This project is anticipated to be completed during the 2026 construction season.

9th Aldermanic District

Sewer Easement Bounded by N. Granville Rd., W. Lolita Ave., N. River View Ct., N. 94th St. (SM495250052) Relaying storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$112,000. This project is anticipated to be completed during the 2025 construction season.

12th Aldermanic District

S. 5th Pl. – 175' north of W. Burnham St. to W. Burnham St (SM495250041) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost of this project including the requested amount is \$74,000. This project is anticipated to be completed during the 2026 construction season.

Further Resolved, That all City Departments are authorized to perform engineering, surveys, plan preparation, and determine an estimated cost thereof; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That the City Comptroller is authorized to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
