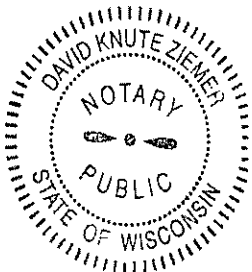

**081704...** A substitute ordinance establishing a public passenger vehicle driver's license classification system, and revising driver's license qualifications and application procedures.

**090131...** A substitute ordinance to further amend the 2009 rates of pay of offices and positions in the City Service.

**090132...** A substitute ordinance to further amend the 2009 offices and positions in the City Service.

**090152...** A substitute ordinance relating to maximum allowable taxicab rates and charges.
