
Dear Mr. Randall:

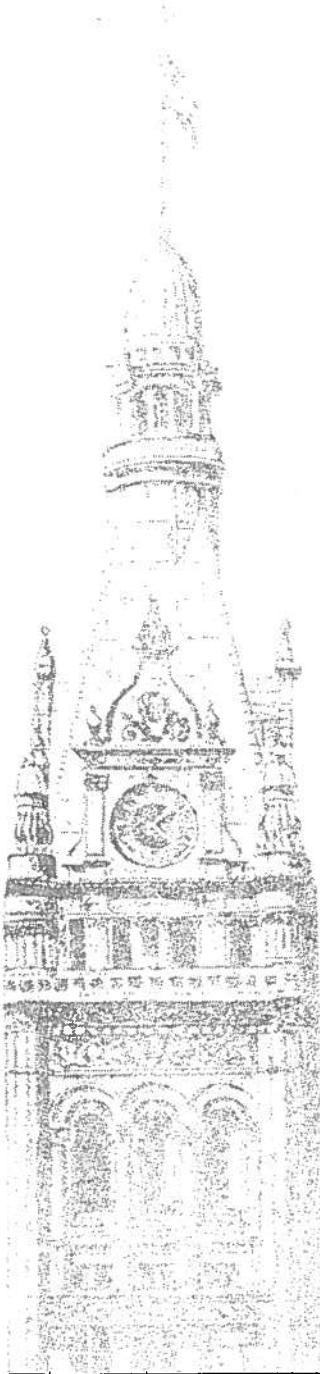

Re: Report of the Renewal Application of Brian C. Randall, Agent for Bootleggers of Milwaukee, LLC for a Class "B" Tavern and Tavern Dance license for the premises located at 1023-27 North Old World Third Street in the City and County of Milwaukee, Wisconsin ("Bootleggers of Milwaukee").

FINDINGS OF FACT

1. Brian C. Randall, Agent for Bootleggers of Milwaukee, LLC (hereinafter the "Licensee") is the holder of Class "B" Tavern and Tavern Dance licenses for the premises located at 1023-27 North Old World Third Street in the City and County of Milwaukee, Wisconsin ("Bootleggers of Milwaukee"). Said licenses expire at midnight, January 14, 2010.
2. Applications to renew said licenses were timely filed with the Office of the City Clerk on November 20, 2009.
3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department responded with a report that could form the basis of non-renewal or suspension of this license on November 23, 2009. In addition, there were also claimed neighborhood objections to loitering, littering, loud music and noise, parking and traffic problems, fights, sales to intoxicated persons, trespassing, patrons leaving roof top deck of the premises and trespassing on private property, vandalism, operation of the premises in such a manner that it creates a public nuisance, disorderly patrons, and conduct which is detrimental to the health, safety and welfare of the neighborhood.
4. On November 25, 2009, the City Clerk's Office provided notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the



police report that could form the basis for nonrenewal or suspension and the neighborhood objections and included a copy of the police report. The matter was scheduled for a hearing on the police report and neighborhood objections on December 8, 2009 at 8:00 a.m. in Room 301B of the third floor of City Hall. At said date, time and place the licensee did appear and admitted receipt of the notice.

5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On November 30, 2009 at 12:30 a.m., officers of the Milwaukee Police Department were dispatched to a fight at 1023 North Old World Third Street (Bootleggers). The complainant stated that he was involved in a fight on the dance floor inside the bar. Security removed all parties involved in the fight, which continued in the alley on the north side of the building. The caller was the only involved party to remain on the scene. He did not require or request medical attention.
 - B. On March 5, 2009, an officer of the Milwaukee Police Department visited taverns on Old World Third Street in order to explain complaints the department had received regarding overservice of alcohol to intoxicated patrons. On March 7, 2009, the same officer observed several patrons leave Bootleggers (1023 North Old World Third Street). These patrons were intoxicated to the point they had trouble walking and vomited shortly after leaving the bar.
 - C. On March 14, 2009 at 1:10 a.m., officers of the Milwaukee Police Department responded to an open line 911 call at 1023 North Old World Third Street (Bootleggers). The investigation revealed someone had used one of the phones at the bar to dial 911 but no caller could be located.
 - D. On June 12, 2009 at 11:25 a.m., a Milwaukee Police Department officer observed a subject being escorted from 1025 North Old World Third Street (Bootleggers) by security. This subject crossed the street and then returned and attempted to reenter the bar. When the officer and bar security prevented the subject from going back into the bar, he became angry, attempting to strike one of the staff from the bar and resisting attempts by the officer to place him under arrest. A police report was filed.
 - E. The owner of an adjacent business who also has an apartment above his business and a roof top Jacuzzi

objected to patrons of "Bootleggers" coming on to his roof and engaging in disorderly behavior and vandalism, to include soaking in the nude in his Jacuzzi without his permission.

- F. Another neighbor who lives in an apartment building across a narrow alley from "Bootleggers" objected to patrons on the roof looking into his second story windows. In an email, this neighbor asked for a roof top screen, but did not include a request for blinds on the bar's second story windows.
- G. One neighbor who has a second story patio in the building across the alley has had beer bottles thrown on the patio from patrons in 2008 and "Bootleggers" then went to plastic cups. However, in the summer of 2009, the patrons of "Bootleggers" started throwing chairs onto her patio.
- H. In addition, the appearing neighbors objected to noise from the patrons of "Bootleggers" as well as vomiting and urinating by the patrons onto the adjacent properties and public ways.
- I. There were several neighbors who testified to noise, vandalism and general disruptive behavior which disrupted the peace of the neighborhood.
- J. The agent of "Bootleggers" made the point that the entire street is noisy not only from patrons of various taverns but also traffic, and that he has tried to work with the neighbors to include a promise to expand the security screen on the roof top bar. He also noted that there have been only two incidents regarding the patrons on the roof top bar.

CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
2. Based upon the above facts found, the Committee concludes that the licensee, Brian C. Randall, Agent for Bootleggers of Milwaukee, LLC, who holds Class "B" Tavern and Tavern Dance licenses for the premises located at 1023-27 North Old World Third Street in the City and County of Milwaukee, Wisconsin ("Bootleggers of Milwaukee ") has not met the criteria of Chapter

90 of the Milwaukee Code of Ordinances or Chapter 125 of the Wisconsin Statutes to allow renewal of his Class "B" Tavern and Tavern Dance licenses without undergoing a thirty (30) day suspension of said licenses, based upon the police report and neighborhood objections. In addition, the Committee recommends that the full Common Council amend the floor plan of this premises to delete from the premises the roof top bar. The Committee finds the police report and neighborhood objections as stated above to be true.

3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "B" Tavern and Tavern Dance licenses of Brian C. Randall, Agent for Bootleggers of Milwaukee, Inc., for the premises located at 1023-27 North Old World Third Street in the City and County of Milwaukee, Wisconsin ("Bootleggers of Milwaukee ") with a thirty (30) day suspension and to amend the floor plan of "Bootleggers" to delete from the licensed premises the roof top bar.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes and two (2) noes, recommends that the Class "B" Tavern and Tavern Dance licenses held by Brian C. Randall be renewed with a thirty (30) day suspension based on the police report and neighborhood objections and that the roof top license be removed.

Said suspension is to be in effect between 12:01 a.m. January 15, 2010 through midnight, February 13, 2010.

1. Jorge Avila (hereinafter the "Licensee") is the holder of a Class "D" Bartender license in the City and County of Milwaukee, Wisconsin. Said license expires at midnight, December 31, 2009.

3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On October 13, 2009, the Milwaukee Police Department responded with a police report that could form a basis for non-renewal or suspension of said license.
4. CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
2. Based on the above facts found, the Committee concludes that the licensee, Jorge Avila, has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "D" Bartender license based upon nonappearance.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council should exercise its discretion to not renew the Class "D" Bartender license held by Jorge Avila based upon nonappearance.

RECOMMENDATION

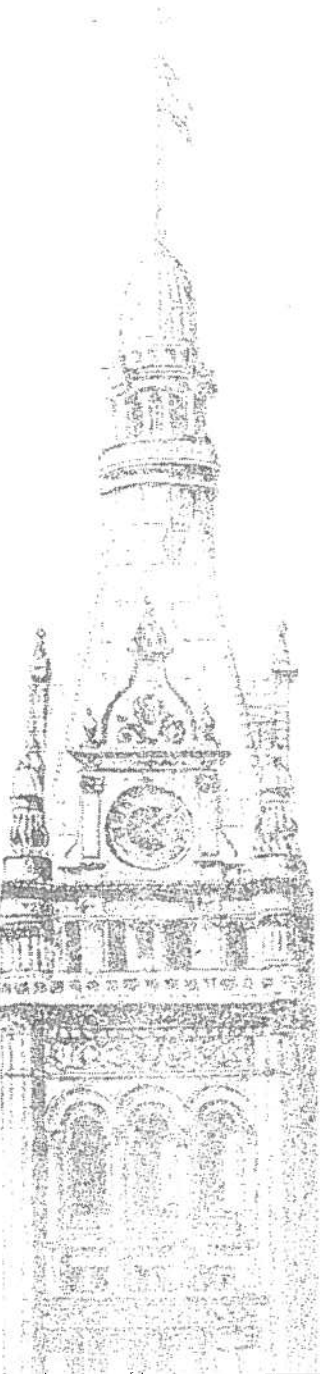



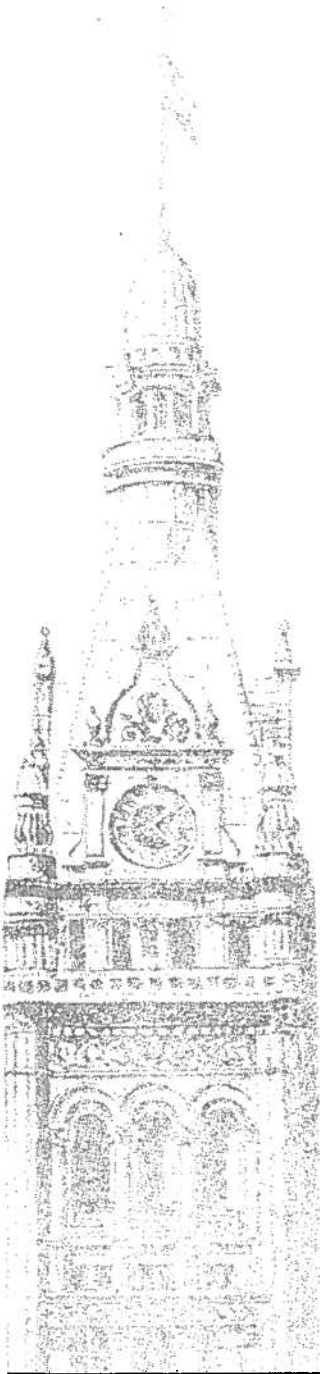

Based on the above facts found, the Committee concludes that the licensee, Heliodoro Madrid Soto, has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of his Home Improvement Contractor license based upon nonappearance.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council should exercise its discretion to not renew the Home Improvement Contractor license held by Heliodoro Madrid Soto based upon nonappearance.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4), zero (0) noes and one (1) excused, recommends that the Home Improvement Contractor license be denied based upon nonappearance.
