Narrative

This report is written by Police Officer Melissa Jo GRAMS, assigned to District 5, Early Power shift.

On Thursday May 15th, 2025 at approximately 11:05PM, squad 5222 (myself) and squad 5232 (PO Shelley WEISSENBORN and Jonathan ENDERLE) were dispatched to a Shits Fired complaint at 3867 N 25th Street located in the city and county of Milwaukee.

Upon arrival, we spoke with the victim identified as G [REDACTED] TORRIJOS (F/W [REDACTED]) who stated her neighbor Veronica NUNN (F/B 10/17/1980) shot a gun in the air.

I spoke with TORRIJOS who stated she's had ongoing problems with NUNN. TORRIJOS is currently getting her roof redone on her property. TORRIJOS stated on 5/15/2025 NUNN came outside with a black handgun tucked in her leggings. TORRIJOS stated NUNN was making threats to her about if any shingles fell onto her property from the roof while she had her hand on her firearm. TORRIJOS stated she feared for her safety and thinks NUNN would shoot her. TORRIJOS stated the same incident happened yesterday after she left the location to her workers, but they did not call police.

PO Monica ROEKER arrived on scene for as a Spanish Translator and spoke with the following victims:

The victims listed above stated on 5/15/2025 around 10:30AM NUNN walked outside the house complaining about the roof and shingles. The victims stated she was making threats to them with a firearm in her waistband while she had her hand on it. The victim's stated NUNN then went into the backyard, and they heard 3 shots. HERNANDEZ-VELAZQUEZ and LOPEZ-TORRES stated they saw NUNN fire the shots. The victim's all stated they feared for their safety and jumped off the roof until police arrived.

While interviewing these victims, D [REDACTED] HERNANDEZ-VELAZQUEZ stated NUNN made threats to them yesterday with the firearm in her waistband while she was holding the gun. D [REDACTED] HERNANDEZ-VELAZQUEZ stated this happened on 5/14/2025 at 3PM. D [REDACTED] HERNANDEZ-VELAZQUEZ stated NUNN was in the backyard and he heard 3 shots come from her backyard. The victims from above stated they were all there for the incident, and it made them fear for their safety.

We attempted to knock on NUNNS door but was unable to make any contact with her.

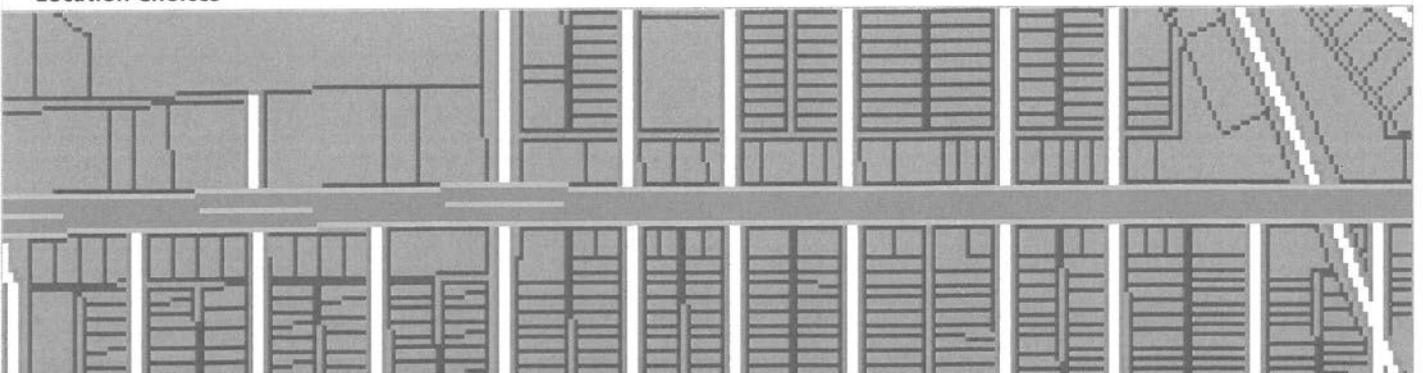

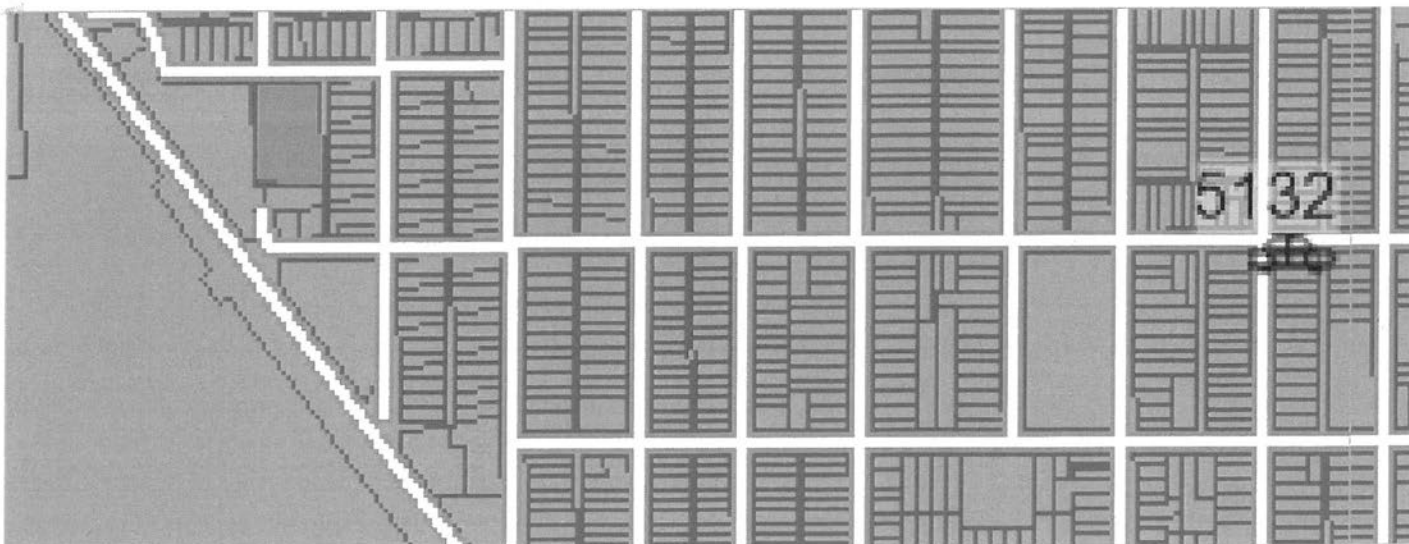

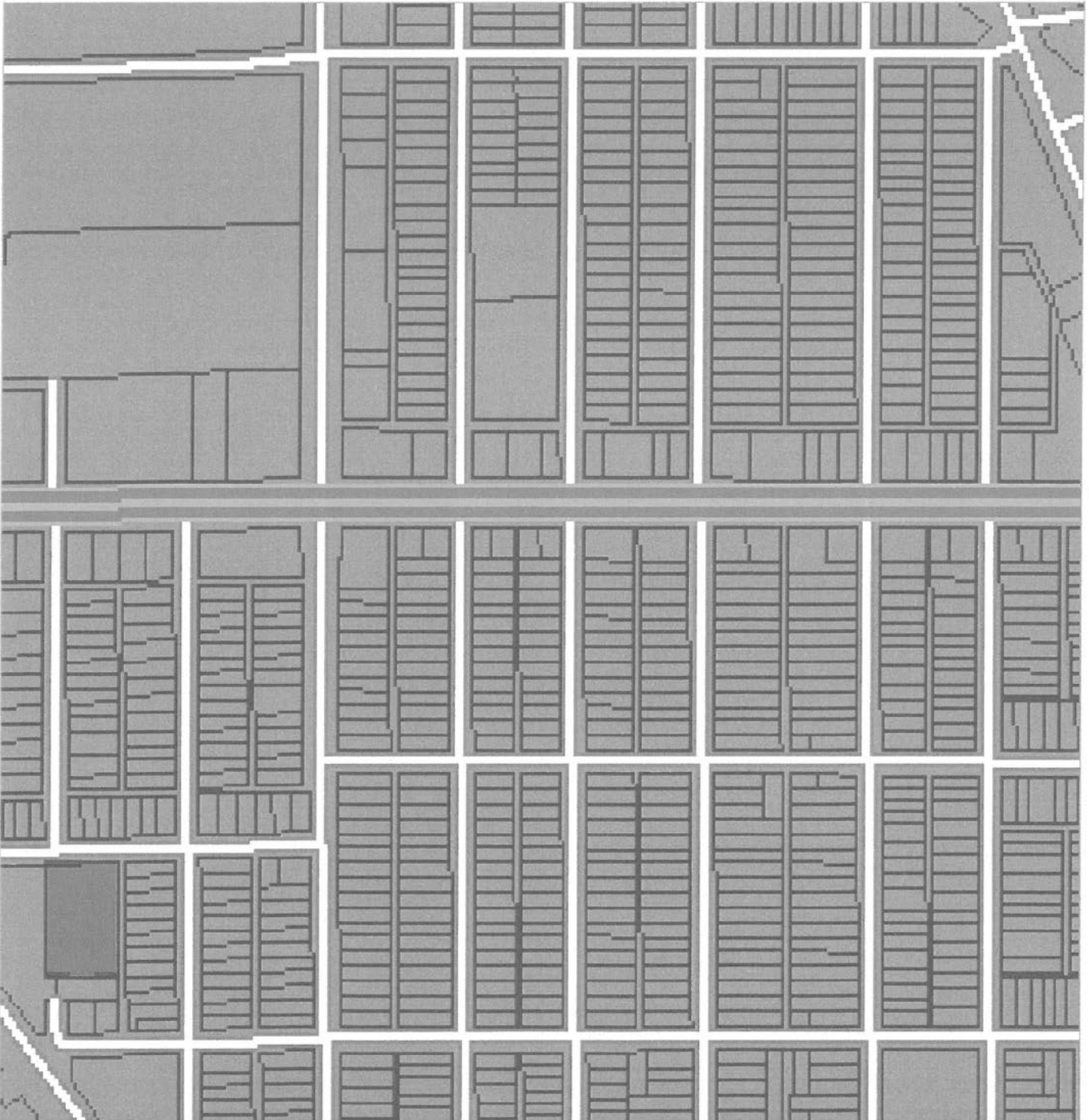
