The victims listed above stated on 5/15/2025 around 10:30AM NUNN walked outside the house complaining about the roof and shingles. The victims stated she was making threats to them with a firearm in her waistband while she had her hand on it. The victim's stated NUNN then went into the backyard, and they heard 3 shots. HERNANDEZ-VELAZQUEZ and LOPEZ-TORRES stated they saw NUNN fire the shots. The victim's all stated they feared for their safety and jumped off the roof until police arrived.
While interviewing these victims, DEED_HERNANDEZ-VELAZQUEZ stated NUNN made threats to them yesterday with the firearm in her waistband while she was holding the gun. DEED_HERNANDEZ-VELAZQUEZ stated this happened on 5/14/2025 at 3PM. DEED_HERNANDEZ-VELAZQUEZ stated NUNN was in the backyard and he heard 3 shots come from her backyard. The victims from above stated they were all there for the incident, and it made them fear for their safety.
We attempted to knock on NUNNS door but was unable to make any contact with her.




