My name is Tizca S. Medina, I am writing this letter in response to the denial letter I received on my claim. My case file number is 03-5-1138. I wish to appeal your decision for denial and request a hearing.

The accident occurred on September 17, 2003, but is noted that the area in question was not repaired until November 14, 2003. I understand there have been two other complaints on 4-15-03/6-20-03 pertaining to the same area.

Prior to the accident, I had two surgeries on the right arm, Carpal tunnel, cubital tunnel was done on 12/4/2002. Rotator cuff syndrome was done on 6-20-03. The accident has caused severe damage to the right arm and split wrist.

I currently have on the both knee, the right arm, split wrist, muscle pain, and entrapment with the cold weather conditions.

I've had to attend various therapy sessions due to the severity of the accident. Documented and official letters have been obtained for my records.

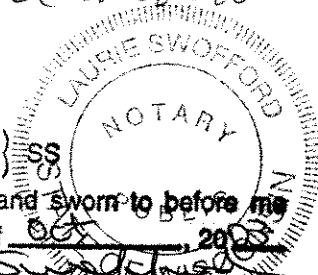

My purse flew in the air.

The bus driver from the bus came running to help me. He helped me to get up. I was disoriented, bleeding, and limping. As soon as I got home, I had someone drive me to St. Francis Emergency Dept. They took x-rays at the hospital of my right wrist and ankle. They washed up my knees cause they were bleeding. The x-rays showed that I had a sprained right ankle and wrist.
