Thiel regularly, collaborating on initiatives and efforts to ensure that our central business district is economically viable, sustainable, and healthy. A downtown and a city that is free of crime and helps to develop positive relationships with our Milwaukee Police Department is critical to Milwaukee's long-term success.

In 2013, Milwaukee Downtown created the Community Intervention Team (CIT) comprised of representatives from the Milwaukee Police Department, the City Attorney's office, the Milwaukee County Housing Division, Visit Milwaukee, and the District Attorney's office. Lt. Thiel has been working with this group in various ways to ensure our unsheltered citizens have access to the resources they need to lead a healthy and safe life.

Personal safety is critical to an area representing less than 3% of the city's landmass but more than 20% of our city's tax base.

Lt. Thiel leads his team with courage, decisiveness, passion, support, humility, empathy, and honesty.

Lt. Thiel's work with our organization and others demonstrates a solid problem-solving interest. I have often observed how Lt. Thiel interacts with our community and his staff, and I have personally witnessed how he strives to ensure everyone is treated fairly and honestly.

Given Lt Thiel's commitment and credibility, I feel confident he will bring strong leadership skills to his role as Captain, and our community will benefit greatly.
