On Monday May 23, 2022 Squad 7322 (P.O. Stupar and I) responded to an armed robbery at CITGO Gas Station 4137 W Fond DU Lac Av which is in the City and County of Milwaukee, WI.

Upon arrival we spoke to the caller/ worker Curtis NALLS b/m 01/02/1980 who stated he was out cleaning the parking lot when he looked in and found 2 b/m wearing all black robbing the gas station attendant. NALLS stated he then ran away from the CITGO and went across the street. NALLS stated he then saw the 2 males go down the alley Eastbound.

P.O. Stupar spoke to the Gas station attendant SAI A. RAJU 07/19/2000 stated the following two actors; #1 B/M 20-30 DRK Complex 600 THIN BLK shirt BLK Pants BLK COVID masks armed with a silver semi auto handgun #2 was a B/M 20-30 600 SLIM DRK clothing unarmed. Suspect 1 and 2 walked through the store and Suspect 1 then pulled the gun and told RAJU to give him all the money in the register. Taken was \$2000.00 in cash. Suspects then fled East bound in the alley on W Fond Du Lac AV.

Both suspects were wearing gloves.

There are cameras in the store that work, however the ones in alley did not work. Video was available to responding detectives for review and recovery.

On Monday, June 13, 2022 at approximately 2:24 AM, we were dispatched to the address of 4137 W Fond Du Lac Av, regarding a ShotSpotter Complaint. It should be noted that a worker of the business contacted police stating people were shooting outside the location.

Upon arrival, I spoke with an employee, who was later identified as Gurinder SINGH (W/M, 01-22-88), who stated he was an employee of the business, which was located at 4137 W Fond Du Lac Av (CITGO ON FONDY), who informed us of the incident that occurred prior to our arrival. JOHNSON, the other employee, stated a customer exchanged words with 2 other males outside of the business and he observed a gun so he retreated into the business. JOHNSON heard shots fired but was unaware who did it.

On Friday, July 22nd 2022, Squad 7469 (P.O. David Michaels and I) at approximately 10:11 PM responded to 4137 W Fond Du Lac Ave., Petrol Brothers Inc. Service Station, which is located in the City and County of Milwaukee, WI for a "Battery" complaint.

Upon our arrival we made contact with an employee, identified as Simrengidt SINGH (w/m, 02/27/1992), who stated stated a former employee and his girlfriend were inside and were destroying property, neither of which were on scene.

One of the managers/owners of the gas station, identified as Manjit K SANDHAR (w/f, 09/04/1967), arrived on scene a short time later. SANDHAR stated earlier in the day, her husband informed the former employee, she identified as Harmanpreet SINGH (w/m, 09/04/1999), that he had two weeks to find another job. SANDHAR stated SINGH made a statement to the effect of him quitting instead and then walked out of the service station without incident.

At approximately 10:00 PM, SINGH and his unknown girlfriend entered into the service station. The unknown girlfriend started destroying property throughout the inside of the store as well as behind the counter.

SANDHAR estimated the damage to be approximately \$2,000.00

The incident was caught on surveillance cameras throughout the store. SANDHAR provided me the password to the surveillance system so I could download a copy onto a USB drive.

All employees of the service station were extremely cooperative and helpful while we were conducting

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your nPMe, and address. (If your first and/or last nPMes are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
