Menomonee Valley Land Use Plan Objectives:

- A. Retain and strengthen viable and existing industries
- B. Attract desirable and new industrial and business development
- C. Promote compatible new mixed-use development in selected locations
- D. Maintain and protect adjacent neighborhoods and business areas

The Land Use Plan recommends that the Menomonee Valley be upgraded and revitalized as an urban industrial and mixed-use district, providing sites for a wide range of land uses. Industrial uses will be emphasized in the central portion of the Valley. New industrial/business park development will be promoted on vacant land in the western portion. New commercial, residential, public and open space uses will be encouraged east of 6th Street.

IL (Light Industrial) Zoning General Description:

This district is intended to provide sites primarily for light industrial uses that utilize medium-sized buildings and do not have extensive outdoor storage areas or operations. This district includes both older industrial corridors (IL2) and modern industrial parks (IL1). While most buildings contain clean, light industrial uses, some commercial and office uses may also be included. This district contains heavier uses than the IO district and requires more extensive buffering from adjoining residential areas.
