Your basis for denying this claim is without merit, and if the City persists in their denial we will simply proceed to litigation.

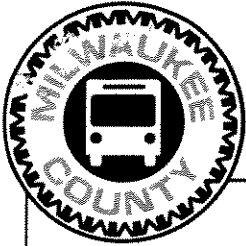

Pursuant to Wisconsin Statutes Section 893.80, you are hereby notified that on June 1, 2006, at about 7 & North, our bus #4910, owned by Milwaukee County, sustained property damages as a 2002 Chevy Blazer struck the side of our stopped bus. The license plate number of the "City" vehicle was #117-FNV; the driver of the "City" vehicle was Timothy Graham, and the vehicle is reportedly used by the City of Milwaukee Police Department. The property damages, which total \$6131.65 were caused by the negligent act of the operator of said "City" vehicle in failing to maintain control of the vehicle. Our itemized repair bill is attached and intended to be part of this notice of claim.

Satisfaction of said damages is claimed from the City of Milwaukee in the amount of Six Thousand One Hundred Thirty One & 65/100 Dollars.
