Hi Nik,

My husband and I recently moved from the Walker's Point neighborhood to the East Side to purchase a condo in the Western Leather Lofts on Pearson St.

Since moving in about a month ago, there have been shootings in the Brady St. West area nearly every night. Sometimes we see these stories in the news the following morning (like today re: last night's shooting outside Casablanca) and several other nights I personally have been awoken by gun shots and drag-racing late at night.

Obviously, we love the area which is why we decided to invest and become homeowners here, but are concerned about the recent violent crime. Is there anything we can do to advocate for enhanced police presence to deter crime and either speed bumps or a "pedestrian-only" area on Brady to discourage the drag-racing?

Lastly, is there anything you'd recommend the neighborhood residents ourselves do? We're happy to advocate for efforts within our building.

Their shadiness and blatant disregard for the area has been an open secret for a long time. Please do something about them. I don't need my block taped off by the police again.

5. On 03/30/2017 a 19 year old Milwaukee police aide, working in conjunction with Milwaukee

5. On 03/30/2017 a 19 year old Milwaukee police aide, working in conjunction with Milwaukee police, attempted to gain entry to Casablanca (728 East Brady Street). There was no security at the entrance of the business and the police aide was denied service by a bartender.

6. On 11/29/2018 officers conducted underage tavern enforcement in District 1. The tavern at 728 E. Brady St, Casablanca passed the check.

- 7. On 02/13/21 at 1:38am, Milwaukee Police, along with the Wisconsin Department of Health Services, conducted a license premise check at 728 E. Brady Street. The applicant stated that his establishment was up to code and no violations occurred.
- 8. On 04/08/21 at 11:16pm, Milwaukee Police received a call at the First District Police Station complaining about the loud music emanating from 728 E. Brady Street. The call said that she is a neighbor and the loud music coming from the establishment can be heard from inside her residence. She also told the officer that patrons from the tavern, after closing time, play loud music and hang out in the neighborhood yelling. The officer tried to call the applicant but received no answer and left a message.
- 9. On 05/20/21 at 4:18pm, Milwaukee Police had a meeting with the applicant at 728 E. Brady Street. Topics of the discussion were, a "shots fired" complaint where one of his employees (a suspected drug dealer) was the target, complaints of patrons playing loud music in vehicles, patrons drinking in vehicles, and public urination. The applicant showed officers surveillance cameras that were installed on E. Brady Street and that he would consider the employee, who was the target of violence, employment status. The applicant said that he has contacted a security company to provide security for his establishment.
- 10. On 06/08/21 at 11:27pm, Milwaukee Police were dispatched to 728 E. Brady Street for a shooting complaint. Investigation revealed that a fight between groups of subjects happened as they were leaving the establishment and security separated the group and told the subjects to leave. The subjects began to fight again at the corner of Cass and Brady. Security responded trying to stop the fight. As the group was leaving a subject approached security, lifted up his shirt to display a handgun and said this was family matter and to let them fight.

Security backed off and observed two other males with firearms in their waist bands. The male and female began to fight again. Security heard 8-10 gunshots. A witness stated a female in the group fired several shots striking one of the subjects to the hip.

On Thursday, April 8, 2021 while assigned to the Desk Officer position, I handled a Noise Nuisance complaint over the phone for Casablanca (728 E Brady St) that was pending. I spoke with the caller who identified herself as Melissa MCNULTY (414)731-7320 who stated she lives near Casablanca and there was loud music which started at approximately 10:15 PM this evening and was loud enough that she could hear it clearly in her residence. Melissa stated the music keeps her up at night, and disturbs her almost every night. Melissa stated this is an ongoing problem with Casablanca. Melissa also stated that after the business closes, the patrons who leave the business are loud and hang out in the neighborhood playing loud music and yelling. I informed Melissa of City of Milwaukee Ordinance 108-23-2 which states that outside music must be turned off by 10:00 PM Sunday - Thursday, and by midnight on Friday and Saturday. Melissa stated she could not tell if the music was coming from an outside speaker or if it was just the base from the music inside. I informed Melissa I would be filing this report and would attempt to contact the Agent of the business and have him turn the music down.

At approximately 11:51 PM on 4/8/21 I called phone number 414-350-3785 which is the listed Agent's (MUSA, Alaa I W/M 1/13/1984) phone number on the Class B License. MUSA did not answer the phone, but I left a message stating that there was a noise complaint called in by a neighbor and that I would be filing this report. I provided my contact information for MUSA in the message.

This report is being submitted by Officer Carlos Felix assigned to squad 1264 at District One, Early Shift.

On Tuesday May 20, 2021 at 4:18PM Squad 1215 Sgt. Kevin Sadowski and I conducted follow up at 728 E. Brady Street, Casablanca.

We met with owner/ agent Alaa Musa in his office at the business. Musa advised me and Sgt. Sadowski of cameras that the Brady Street Business BID purchased and he had deployed in the area. Musa pointed to a monitor in his office and showed us live feed from the cameras that have been installed and working on East Brady Street.

After viewing the cameras and advising on the placement, Sgt. Sadowski proceeded to advised Musa of follow up regarding a shots fired call that occurred a few blocks away and involved one of his employees (CAD#211370134). Sgt. Sadowski advised Musa during the investigation officers were told by a few other employees of his, that the indented target/employee is known as "Yago" and he is a low level drug dealer. Sgt. Sadowski expressed his safety concerns with "Yago" and his connection to the business as a known drug dealer whom has recently been targeted with violence. Musa agreed that "Yago" could be a safety risk for all at the business and stated that he would be considering "Yago's" employment status.

Musa was also advised of complaints our office has received from neighbors in the area. He was advised of patrons playing loud music in cars, drinking in their cars, and public urination. Musa was concerned with the complaints and stated that unruly behavior from patrons would not tolerated. He explained that he contracts with a third party company to provide uniformed security at the exterior of the door and monitor actives in front of the business.

On Tuesday, June 8, 2021 at 11:38 PM PO Lorenzo HERNANDEZ and I (Squad 1240, in full duty uniform and equipped with activated Axon body worn cameras) were dispatched to assist with a Shooting which occurred at 728 E Brady St, which is in the City and County of Milwaukee.

728 E Brady St is the Casablanca restaurant. The shooting occurred directly in front of Casablanca and the involved parties were patrons of the restaurant.

Witness interview of Marty I YOUNG (B/M, 06-20-98) by Det. PATTERSON:

Det. Janay PATTERSON interviewed a witness who had been dinning inside of Casablanca and was a witness to the events leading up to the shooting.

YOUNG stated that he went to Casablanca with his sister (Anastasia YOUNG F/B, 01/29/00) and his two cousins "Keya" and "Arianna". YOUNG explained Casablanca is a place where he often goes when he's in town just to hang out with his family. Once there, YOUNG said they went upstairs to the waitress area and requested to be seated in the rooftop area. YOUNG said as they were waiting to be seated, he noticed that it was somewhat crowded inside. YOUNG stated that the waitress returned and informed them that there was seating available on the rooftop, so she escorted them to their area. Next, YOUNG said as he followed the waitress, he was looking down at his phone texting, when he heard what he described as an "obnoxious laugh" as if someone was attempting to gain his attention inside Casablanca. YOUNG said he looked up and heard Anastasia, Keya, and Adrianna say "That's Brittany". Brittany would be identified later as Brittany HARRISON (B/F, 11/10/88).

YOUNG said he was confused as to why Brittany would be loud in his face when he was unaware that she was at Casablanca. YOUNG said he observed Brittany walk to the opposite side of the patio where it is enclosed with plastic windows. As Brittany is walked away, YOUNG said she turned towards them, swung her hair, and laughed obnoxiously again. YOUNG explained that he felt uncomfortable knowing that Brittany was there, so he decided to call his mother Alexandria for advice due to past encounters. According to YOUNG, his mother said "if Brittany is in a separate area, just ignore her and if anything happens I'll come down there."

After YOUNG spoke with his mother over the phone, he stated he continued to enjoy the night with his sister and cousins at Casablanca. Next, YOUNG said he called his uncle Robert CHAMBERS (M/B, 02/15/77) and invited him to join them for drinks at Casablanca. When Robert arrived, YOUNG said he and Anastasia walked from the rooftop, down to the entrance of Casablanca to get Robert. When they got to the door, YOUNG said Robert was talking to Casablanca security personnel and after waiting a while YOUNG informed Robert that he was going back upstairs. YOUNG said as he is walking up the stairs towards the patio, Brittany walked through the door with her friend towards him. YOUNG said he stopped walking and waited for her to walk by. YOUNG said instead of Brittany walking past, she simultaneously shoulder bumped him, looked at him up and down, and smacked her lips. YOUNG said as she did that, she stated to him "Yea little nigga, you ain't tough."

YOUNG said he told Brittany "you can have this". YOUNG explained that he called Keya afterward and informed her that Brittany just bumped him, and tried to provoke him to fight. YOUNG said he instructed

Keya to pay the tab and later he would reimburse her; YOUNG just wanted to leave as soon as possible. YOUNG said as he was leaving Casablanca and walking outside towards the entrance, Brittany followed behind him and stated "Y'all wanna fight?" YOUNG replied to Brittany "Fight you for what? I came here not thinking about you." YOUNG said the girls that were with Brittany were getting riled up and there was a lot of commotion directly in front of Casablanca. YOUNG said at that point verbal altercations ensued between Brittany, her friends, and YOUNG and his family. YOUNG stated that Robert tried to interject and break up the dispute but that's when all hell broke loose.

YOUNG said suddenly after the verbal argument, they all started fighting. YOUNG said as he was fighting Brittany, she grabbed his hair, and Brittany's friend who YOUNG knows as "Tasha Malone" uppercuts him in his right eye which resulted in bruising. YOUNG stated after security came outside and broke the fight up, they told Brittany to leave. Instead of leaving, YOUNG said Brittany walked back towards him, and they started fighting again. YOUNG said during the 2nd fight they were on the side of Casablanca near the corner of E Brady St and N Cass St. YOUNG said when security personnel broke up the fight again, his Uncle Robert grabbed him and Anastasia and told them to leave.

YOUNG explained as Robert was pushing him, he was also pushing Anastasia, Keya, and Arianna out from the crowd. Next, as YOUNG looked back he observed Brittany getting up from the ground, and as she was standing up YOUNG heard Brittany say "Y'all got me fucked up." Following that statement, YOUNG said Brittany fired two rounds in the air with her right hand. YOUNG recalled the third time Robert pushed him, he took off running towards the swing park because Brittany aimed the gun in his direction and fired additional rounds; YOUNG stated he believe that's when Robert got shot in his hip.

YOUNG said he heard about 15 gunshots. Once the shooting subsided, YOUNG said he ran back to the front of Casablanca to check on Robert. YOUNG said a citizen who was also at Casablanca assisted him with providing aid to Robert until medical personnel arrived.

Witness Interview of Michael D. PORTER (B/M, 04-23-85) (Employee of Casablanca) by Det. Justin SOKOLOWSKI:

On scene Det. SOKOLOWSKI interviewed PORTER, who was working at the front entrance as security during the incident.

PORTER stated that a group of females and one male exited Casablanca slightly before midnight and were standing near the front entrance. PORTER stated that a second group consisting of 4-5 females exited the location and the male began arguing with one female out of the first group of females.

PORTER stated that the male and female were mutually fighting each other but the male was winning by holding the females braids and ripping them out. PORTER stated that he broke up the fight and told both parties that they had to leave the location. PORTER stated that both groups moved a little towards Cass St and they were talking when the male charged the female and began attacking her again. PORTER stated that he got involved again and threw the male off the female. PORTER stated that he told everyone that they had to leave and they began to disperse to a minious that was in the road near to

PORTER stated that the victim who was shot lights up his right side of his shirt and displays a black semiautomatic handgun in his right pocket and stated that "that's my nephew, this is a family business, let them fight." PORTER stated that he began to back off and he observed two other males with guns in their waist bands but he was unsure if they were just walking down the street or if they were in the group. PORTER stated that the male and female were fighting again and he went back to the entrance of Casablanca since he was unarmed and did not want to get shot. PORTER stated that once he was inside he heard 8-10 gunshots outside of the door.

The shooting investigation is still ongoing.
