After the purchases were made, one customer went into a cooler and opened a drink and began to consume it. The agent advised the customer to pay for it and leave the store as they cannot consume beverages inside the store. An argument ensued between the customers and the agent, which eventually led to a physical altercation in which the agent armed himself with a wooden stick and began striking the customers. The agent was cooperative and allowed officers to view video surveillance of the incident.
- 5. On 03/25/23, the applicant was charged with Prohibited Alcohol Content in Germantown Village Municipal Court. On 04/25/23, he was convicted and his license was suspended for 6 months.

#### LICENSE PREMISE REPORT

This report is submitted by Officer Kevin Becker assigned to District Four, Early Shift.

On Thursday, December 22nd, 2022, I, Officer Kevin Becker was assigned to Squad 4241 in full duty uniform, a marked Milwaukee Police Squad and affixed with AXON worn body camera. At approximately 9:00 PM I was dispatched to a "Subject with Gun" call for police at the address of 6201 N. Teutonia Av. which is located in the City and County of Milwaukee. This particular location is one of many businesses which are located in a strip mall near the intersection of W. Florist Av. and N. Teutonia Av. The 6201 N. Teutonia Av. address is a "Diamond Beer and Liqueur" store where alcohol is sold. This store is affixed with both interior and exterior surveillance cameras that captured this incident. The following is the statements given by the victims as well as a description of the surveillance footage viewed.

Upon arrival, I would be introduced one of the victims identified by Wisconsin Driver's License as Sujit SINGH (M/A 03/29/1972, #414-306-4879, 11523 N. Concord Creek Dr, Mequon WI). SINGH was out of breath, appeared to have minor injuries on his face, and appeared to be upset. It should be noted that there was a minor language barrier with SINGH. SINGH provided the following statement.

#### Interview of SINGH

SINGH was asked if he needed any medical as he did have visible injuries to his face (which appeared minor). SINGH refused any medical services and did not request an ambulance. SINGH stated that a total of four customers came into the store. SINGH was behind the register (only register open). SINGH is the owner of this store and knew two of the four subjects were frequent customers but did not know names or any details about them. SINGH stated that two of the subjects inquired about alcohol behind the counter which they eventually paid for. The four continued browsing after purchasing the alcohol. Eventually, one of the customers went to the cooler where they took an alcoholic beverage, opened it, and started to consume said beverage. SINGH stated he told them that they cannot drink in the store. SINGH stated the subject drinking told SINGH to "stop yelling". SINGH stated he was not yelling and only request they pay for the drink. Eventually, the customer (that was drinking the beverage) did pay for the drink. While paying for the drink, SINGH stated the customer was still irate and pulled the receipt printer which was attached to the register. SINGH requested the subjects leave the store. While the subjects were walking towards the exit of the store, one subject pointed her finger at SINGH's 16year-old son. Again, an argument ensued and this time it turned physical. SINGH, his son, and all four customers ensued in a physical altercation. SINGH's son who was on scene was not injured during this incident however did have his shirt ripped during the altercation. SINGH's son is identified verbally as Sukhmanpreet GHOTRA (M/A 12/13/2006, #414-712-6301, 11523 N. Concord Creek Dr. Mequon, WI).

Eventually, SINGH armed himself with a solid wooden stick which was taken from behind the counter. This is when SINGH would strike all four customers with the stick which all appeared to generally be around the chest and waist area. SINGH struck the customers multiple times as the customers fled the store. As the customers fled, one customer produced a firearm and pointed it at both SINGH and GHOTRA. SINGH stated all four fled and left in an unknown vehicle in an unknown direction.

SINGH would provide officers access to his surveillance.

#### Interview of GHOTRA

GHOTRA had a similar story to SINGH's. GHOTRA stated he observed the customers drinking an unpaid beverage and observed them rip the receipt printer from the register. GHOTRA stated as the subjects left the store, one of the customers had pointer her finger at him and an unknown verbal dispute ensued which resulted in a physical altercation. GHOTRA stated he was struck 2-3 times on each side of his face but was not injured. GHOTRA did show me his ripped shirt.

#### Video Surveillance

SINGH provided us with footage which was accurate with his interview; I observed the following actors on the footage as in regard to the four suspect customers.

- 1. Black Male, Winter White Hat, Red Hoodie, Black and White Checkered Winter Jacket, Blue Jeans, Black Shoes. Armed with a black handgun
- 2. Black Male, Black Jacket, Gray Pants, White Shoes. (This is the customer who was drinking the unpaid beverage)
- Black Female, Green Coat. (This customer was throwing items at the owner and his song)
- 4. Black Male, Black Jacket, Black Pants, Black Shoes

Due to the store closing, I was unable to collect footage at that time and SINGH stated he will have a copy of the footage for me the following day.

Please see Officer Majeed's supplemental report regarding KIMBLE's involvement in this incident.

A Milwaukee Police Community Contact Card was issued to SINGH regarding this incident.

I was unable to locate any other customers involved nor I was I able to locate a vehicle on the surveillance cameras.

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
