Re: Certificate of Appropriateness for the installation of solar panels on the roof located at 929 N. 33rd Street. in the Concordia Historic District.


Dear Property Owner:

We are writing to you because the city's Historic Preservation ordinance now requires that all property owners within 200 feet of any project affecting an historic structure or within 200 feet of any project within an historic district requiring full Historic Preservation Commission (HPC) review must be sent an informational letter at least 20 days prior to the HPC meeting to allow time for public comment.

You have no obligation to reply and this letter is provided for your information. If you have comments on the project, you may send them in writing within twenty days of the date this letter to: Milwaukee City Hall, Office of the City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Your comments will then be forwarded to the Historic Preservation Commission.

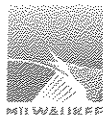
