This claim I am filing is for my damaged vehicle due to a collision that occurred between another party and I because of the malfunction traffic lights that are by Silverspring & Lovers Lane Rd. by I-45. The collision occurred on the date of March 31, 2007 which was a Saturday around 4:30pm. Supposedly both our lights were green since the other party had told me she had the green left turn arrow light. The other party stated she had the green left arrow and was coming from the East and was trying to make a left turn to get onto I-45 heading southbound. I was coming from the West (Menomonee Falls) heading East and I had the green solid light to keep going straight. We both kept going and that is when the collision occurred.

There have been many accidents in the past due to the malfunctioning of the lights. I don't think that both lights should be green at the same time. A police officer Watts from district #4 had mentioned that she has sat at one end and viewed that cars from both ends would keep going without stopping and that there have been many collisions at these lights.

Under the circumstances of the collision my car has some damage to it and my claim is to get my car fixed. I went to two different places for estimates; AUTOCRAFT, INC. gave me an estimate of \$2,199.69 and CARSTAR gave me an estimate of \$3,228.92 just for the damage on the outside of my vehicle.
