1. Description of Grant Project/Program (Include Target Locations and Populations):

Adapting lessons from the COVID-19 pandemic, the Centers for Disease Control & Prevention (CDC) created a “pre-award” for Public Health Crisis Response designed to deal with future emergencies. This award provides a vehicle to quickly deliver funding to state and local public health departments to deal with future public health crises.

As warranted, CDC can issue Notices of Award to pre-approved recipients outlining the funding, eligible expenses, and terms of Federal support in the event of a public health emergency. Total national funding is \$500M, the City will be awarded funding based on the CDC’s authorized and determined distribution of funds for the issue at hand.

2. Relationship to City-Wide Strategic Goals and Departmental Objectives:

This grant promotes the health, safety, and well-being of residents by assuring funding capacity for prompt response in the event of an emergency.

3. Need for Grant Funds and Impact on Other Departmental Operations (Applies only to Programs):

Grant funding will be determined by CDC as emergencies or public health crises occur. Given the City’s status as the regional population center and the Health Department’s relative capacity and expertise, the City of Milwaukee will take the lead role in organizing and carrying out any public health response for emergencies affecting the city and potentially the region. Authorization of this funding will preclude large upfront commitments of property tax dollars, and avoid delays in implementing a robust response to a future public health emergency.

4. Results Measurement/Progress Report (Applies only to Programs):

Results measurement will depend on the nature of the crisis at hand, and funding parameters from CDC if and when a Notice of Award is issued.

5. Grant Period, Timetable and Program Phase-Out Plan:

Authorization of this grant will provide immediately available funding for any future declared public health crisis, giving MHD the ability to scale up a crisis response within hours or days of a CDC declaration. Current funding creates the risk of insufficient funding for initial response, depending on the circumstances and the time of year the emergency occurs.

The CDC has a maximum of \$500,000,000 for this award to pre-qualified and awarded jurisdictions as needed between 2022 and January 31, 2027. Funding will be allocated to State and local jurisdictions based on the nature of the emergency and funding authorized by Congress, but CDC anticipates an average award of \$5,000,000.

Phase-out will be based on the emergency response and nature of the crisis, and longer-term funding allocated by Congress to local health departments and States.

6. Provide a list of Subgrantees:

No subgrantees have been identified. If needed, subgrantees will be specified in amended budgets and authorizations after the Notice of Award is received from CDC.
