Those wishing to provide oral testimony via phone or internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.

- 5. On 05/20/23 at 1:03am, Milwaukee Police were dispatched to 1319 W. North Ave, for a shot spotter assignment (business also called the police). Officers were alerted to guns shots in the vicinity of the business, and located spent casings on the parking lot. Officers were notified that the local hospital had a victim related to the shots fired who stated she was in the gas station parking lot when the incident occurred. The business was cooperative with the investigation and provided surveillance footage that showed the incident.
- 6. On 05/24/23 at 5:11am, Milwaukee Police were dispatched to 1319 W. North Ave, for a trouble with subject. Officers spoke with the employee who stated that a subject was on the property and damaged his vehicle. Officer attempted to view video but the employee did not have access to the surveillance system.
- 7. On 06/05/23 at 11:11am, Milwaukee Police were dispatched to 1319 W. North Ave, for a shooting complaint after being notified by hospital staff that two shooting victims arrived. Officers spoke with the employee who was cooperative with the investigation. The employee provided video of the incident, a receipt of purchase from the suspected shooter, and a witness statement. The employee stated that he observed the suspect park near the gas pumps. Then a red vehicle pulled in to the parking lot. The suspect got into an altercation with the driver of the red vehicle. The victim reentered the red vehicle and the suspect started shooting at the occupants of the red vehicle. The red vehicle fled the area and the suspect then eventually fled in the suspect vehicle.
- 8. On 07/03/23 at 11:54am, Milwaukee Police were dispatched to 1319 W. North Ave, for an overdose complaint. Officers arrived and on scene spoke with Milwaukee Fire, that were on scene for medical response. MFD personnel stated that they located a subject and administered Narcan, and that subject became responsive then left the area. MFD also treated two other subjects for possible drug overdose issues. Both subjects were transported to the hospital by ambulance, and admitted to officers of using drugs behind the location. Officers spoke with the employee and advised the business it has a loitering drug issue and must be aware when subjects are loitering. The employee stated that he does call for police services, regarding loitering complaints.

- 9. On 07/07/23 at 11:49pm, Milwaukee Police were dispatched to 1319 W. North Ave, for a welfare check of a female. Officers arrived and observed a group of subjects that appeared to be loitering. The female appeared to be on the ground but able to communicate. The subjects were smoking and had drinks in their hands playing loud music from vehicles. The subjects were told by officers that there is no loitering and had to leave. Some of the subjects left the location, but one subject stayed, he stated he worked for the location as security. Officers knew the subject to be an individual who has received drugs complaints. Officers spoke to the employee who was unaware of the loitering or the call of police service. The employee stated that the subject who claimed to be security does not work for the location. The employee was unable to provide video, regarding the incident because the employee stated that he did not have access to the video surveillance.
- 10. On 12/3023 at 12:49am, Milwaukee Police were dispatched to 1319 W. North Ave, for a damage to property complaint. Officer spoke with the employee who stated that a subject threw items on the floor, and damaged the card reader machine on the counter. The suspect became irate when he was asked to provided identification for proof age for a tobacco product, he attempted to purchase. The suspect then left the store and got on a MCTS bus leaving the area.

This supplemental report is written by PO Lauren MAROWSKY, Squad 3340, District 3, Late Shift. On Saturday, May 20th, 2023 at approximately 1:03 AM, PO Tyler HEANEY and I were dispatched to a ShotSpotter call for service at 1319 W. North Avenue, located in the City and County of Milwaukee. According to the ShotSpotter Application, 12 rounds (fully automatic) were fired on N. 13th Street, F81-934101. An additional ShotSpotter for five rounds was detected at the same location, F81-934103.

Caller: Initial call was a shotspotter activation, Aurora Sinai Security notified MPD of shooting victim upon the victim's arrival at hospital

#### Initial Response:

Upon arrival at the listed location at approximately 1:05 AM, PO HEANEY and I checked the area for anyone or anything that appeared to be struck by gunfire; however, nothing was located. During our search, I located 13 spent brass 9mm casings next to pump 8 inside the gas station parking lot, 1319 W. North Avenue.

At approximately 1:24 AM, PO HEANEY and I were notified a shooting victim had been located at Mt. Sinai Hospital. According to the victim, she was shot inside her vehicle, which was stopped on the east end of the gas station parking lot.

As we secured the scene, four spent brass .45 cal casings were located in the alley on the west side of the gas station. As I walked to the east side of the building, I located eight spent brass 9mm casings and eight spent aluminum .223 casings on N. Teutonia Avenue.

While on scene, PO HEANEY and I observed video surveillance, which showed a gray, newer model Volkswagen Atlas bearing WI Auto ACZ3826 stopped in the gas station parking lot. Video also showed the Volkswagen drive south through the alley, located just west of the gas station. In the video, I observed an occupant inside the Volkswagen discharge a firearm from the inside the vehicle.

## Additional Information:

Officers on scene spoke with the clerk, later identified as Sukhdev M. SINGH (w/m, 01/16/54), who was very cooperative with the investigation. An interview with SINGH could not be conducted because he does not speak English.

See supplemental reports for more information regarding the incident. CIB responded and took over the investigation.

On Wednesday, May 24, 2023, at 5:11am I responded to the address of 1319 W Vliet Av for a report of a trouble with subject. When I arrived, I spoke to the caller, Sukhdev SINGH. SINGH is a clerk at the gas station located at this address.

SINGH stated that while he was working inside at about 2:00am he observed a white male subject walk up to his vehicle, which was parked in front of the building. The subject broke off the mirror from the driver's side view mirror. SINGH stated that the subject offered to trade the mirror for a black and mild. When he refused the subject broke the other side view mirror off of the vehicle. The subject then pulled the rear license plate off of the vehicle and walked away with it.

I observed that there was a tan 2008 Chevy Impala bearing Wisconsin license plate ADY5252. I observed that both side view mirrors were broken and hanging off the vehicle.

I attempted to watch security video of the incident, but SINGH did not have the password to the system.

I collected the remaining plate and issued a PV-17 to SINGH.

On Monday, 06/05/23, at 11:11 am, we were dispatched dispatched to a shooting at the North Ave. Petro Mart gas station located at 1319 W. North Ave.

Detective Raena Vrtochnick, assigned to the Criminal Investigation Bureau, Violent Crimes Division, Day Shift arrived on scene and took over the investigation Detective Vrtochnick conducted an interview of the on-duty gas station attendant/cashier who was working at the time of this incident, Sukhvinder Singh Gill (W/M, 03/05/55), of 1704 W. Plainfield Ave., work phone 265-5445, cell phone 248-839-3236, who stated the following.

Gill stated that he was inside of the cashier booth when this incident occurred. Gill stated that a person that he does not know who had parked at pump #7 entered the gas station and pre-paid for \$5.00 in gas.

Gill stated that after this person returned to their vehicle, a red car pulled into the entrance of the gas station lot off of W. North Ave. Gill stated that he saw the person who was parked at pump #7 shooting at the person who was in the red car. Gill stated that he (Gill) did not know the person in the red car.

Gill was unable to provide a description of the person who was parked at pump #7 who he saw shooting at the person in the red car.

Gill provided Detective Vrtochnick with a receipt for the purchase made by the suspect in this offense, the person who was parked at pump #7, and Gill saw fire shots at the person in the red car. The receipt is dated and time stamped 06/05/23 at 10:45:33 AM.

Gill also provided us with access to the surveillance video. I viewed the video surveillance from the North Avenue Petro Mart Citgo gas station located at 1319 W. North Ave. from 06/05/23. It should be noted that both the date and the time indicated on the video surveillance were accurate.

At 10:46 am the shooting suspect's vehicle, a Nissan Sentra four door, black in color, with no rear license plate, enters the lot of the gas station off of N. Teutonia Ave. from the South, parking at pump #7, facing Northbound towards W. North Ave.

At 10:47 the suspect, who is the driver of the above vehicle, and is a black male, 25, 510, 170, with a

medium to muscular build, a medium complexion, and chin length black dread locks with bleached ends, wearing a white tank top, a pair of dark colored jogging pants with a red bandana and a black bandana in his right rear pocket, and black gym shoes, with a large black necklace with a orange medallion, enters the gas station and pre-pays for gas.

At 10:48 am a black female, 507, medium to heavy set, wearing a multi-colored dress with a backpack on her back, who was subsequently identified during this investigation as Diana E. Culp (B/F, 08/24/85), is observed walking Eastbound on W. North Ave. and entering the gas station lot.

A Jeep Liberty, red in color, that was Eastbound on W. North Ave. enters the gas station lot, stopping in the gas station lot just South of the entrance. The driver of the red Jeep Liberty, a tall black male with a slim build, who was subsequently identified during this investigation as the shooting victim, Thomas J. Harris (B/M, 08/14/74), exits the Jeep Liberty and approaches Culp. Harris appears agitated and animated. There appears to be a second person in the Jeep Liberty seated in the front passenger seat. This person was subsequently identified during this investigation as the second shooting victim, Daphine D. Johnson (B/F, 10/30/85). Johnson is not observed exiting the Jeep Liberty at any point at the gas station.

At 10:48 the suspect exits the gas station and returns to his vehicle which is parked at pump #7. It appears that Culp attempts to walk away from Harris who follows her. The suspect is observed looking in the direction of Culp and Harris.

The suspect retrieves a gas can from his vehicle and walks around the rear of his vehicle to the gas pump. The suspect stops and looks towards the West where Culp and Harris are located.

At 10:49 am Harris is observed grabbing Culp by her hair or head and throwing her to the ground. Harris violently attacks Culp as she is on the ground, beating her and striking her multiple times. This attack lasts approximately thirty seconds in duration. Culp is able to get up and walks towards the gas station as Harris returns to the Jeep Liberty.

The suspect produces a handgun from his right side and approaches the Jeep Liberty as Harris is entering the driver door. The suspect is pointing his gun at the Jeep Liberty and appears to fire shots from a distance of approximately 15 to 20 feet from Harris' vehicle.

Harris drives Southbound through the gas station lot and strikes a concrete barrier, reverses after striking the barrier, and drives Eastbound through the lot while the suspect points his gun in his (Harris') direction. Harris exits from the East side of the gas station onto N. Teutonia Ave. and flees Southbound on N. Teutonia Ave. The suspect does not fire any additional shots as Harris drives through and exits the gas station lot.

The suspect returns to his vehicle and pumps gas into his gas can. Culp exits the gas station at 10:51 am and walks Northbound on W. North Ave. out of camera view.

At 10:52 am the suspect puts on a baseball cap, enters his vehicle, and exits the gas station lot onto W. North Ave. The suspect drives Westbound on W. North Ave. and Southbound on N. 14th St. out of camera view.

On Monday, July 3, 2023, at approximately 11:54AM (while in full duty uniform with an Axon body worn camera activated and in a marked MPD squad car) P.O. Isaac KING and I responded to the Shell gas station located on 1319 W. North Ave, which is in the City and County of Milwaukee Wisconsin for an Overdose complaint.

Upon arrival, MFD personnel informed me that male subject who I verbally identified as Rodney O HARRIS (B/M 06/15/1983) was found unresponsive in the parking lot of the above listed address. MFD personnel also stated that HARRIS was administered 4MG of Narcan but refused to go to the hospital. HARRIS was in the passenger's seat of a vehicle at the gas station's parking lot when I spoke with him. HARRIS's speech was slurred, but he was coherent and alert. HARRIS and an unknown male who was driving the vehicle stated that they were taking HARRIS to the hospital so that HARRIS could receive medical attention. HARRIS refused to stay on scene to be transported by MFD personnel.

I then observed a Black sedan 4dr vehicle with MFD (engine 30, Green Shift, Captain ALWIN) staff around the vehicle providing medical assistance to male subject later identified as James A JONES (B/M 06/15/1985). JONES identity was confirmed through DOT database. MFD personal informed officers that they located JONES in the rear of the above listed residence conscious, but under the influence of an unknown substance. It should be noted that JONES was not operating the vehicle but sat inside of the vehicle while MFD gave first aid to him. MFD personnel also informed officers that Narcan was not administered.

JONES was transported to MT. Sinai hospital by MED 5 where he was evaluated in ER room # 9 and admitted at 12:44AM. JONES was treated by DR. RIPENHOFF.

I then spoke with Jeffrey W ELLIOTT (W/M 12/23/1976) who was verbally identified himself and stated he had been smoking crack cocaine with JONES in the rear of the above listed address but does not remember anything else about the incident. ELLIOTT was then transported to MT. Sinai hospital by ambulance Bell 414 to receive medical attention. Once at the hospital, ELLIOTT was evaluated in ER room # 16 where he was admitted at 12:32AM and treated by DR. SCHMIDT. ELLIOT informed officers he has been using crack cocaine for approximately two years and he did not take the drugs to harm himself.

ELLIOTT and JONES were in stable condition when officers exited the hospital.'

P.O KING spoke with Sanday SINGH (M/W 04/22/2002) who was the gas station attendant working during the time of the incident. P.O KING informed SINGH that there have been multiple overdose complaints in the rear of the business and that he should call the police when he sees the loitering at his business. SINGH was also made aware that patrol request will be made for the business as well. SINGH informed me that he called the police when her saw HARRIS unresponsive in the parking lot.

I observed a group of individuals huddled in a circle and standing around on the southwest side of the building and appeared to be smoking an unknown substance. The individuals observed my marked squad car as I approached closer to the female on the ground. Some of the individuals attempted to wake her up with no success and then walked away to the east side of the building of 1319 W. North ave.

As I exited my squad car, I observed vehicles parked and not getting gas at the pumps. I observed these same vehicles in the parking lot earlier as I was patrolling around. There was extremely loud music playing, subjects with drinks in their hands, smoking and dancing next to vehicles.

Not being able to properly hear the female I walked to the individuals that were clearly loitering and partying in the gas station that there was to be no loitering and they had to leave. Some of the individuals left but an individual who we have received complaints of drug dealing turned around and stated that he worked at the gas station. The male who identified himself as security was identified as Courtney T. FARR, FARR walked into the gas station and stated to the clerk that he was security. The employee identified as Sanjay SINGH shook his head no if FARR was working for him.

I spoke to licensed premise Sanjay SINGH (employee). SINGH was unaware of the female on the ground and people loitering.

On Saturday, December 30, 2023 at 12:49pm, Squad 3243 (P.O. Kayla DOMAGALSKI and I) was dispatched to 1319 W North Av, a Shell food mart & gas station, for a Theft call for service. We were in a marked MPD squad with emergency lights and audible siren. We were both in full duty uniform with badges affixed to our outermost garments and we were both equipped with Axon bodyworn cameras.

Upon arrival at 12:57pm, I interviewed Parveen M KUMAR (a/m 04-12-94) who stated that he is an employee at the gas station. KUMAR stated that at approximately 12:45pm, a subject came into the store requesting to purchase a Black & Mild cigar. KUMAR stated that he told the subject KUMAR would need to see identification to verify the subject's age. KUMAR stated the individual refused to provide identification, called KUMAR a "bitch ass", and started pulling on a credit/debit card reader near the register. KUMAR stated that the subject continued pulling on the card reader until the connecting cord snapped thus rendering the card reader inoperable and unable to be repaired. KUMAR stated the subject then proceeded to open and dump approximately 7 bags of chips on the ground and also squirt a bottle of soda underneath the plexiglass glass partition by the register at employees. KUMAR stated he attempted to contain the subject within the store with an automated gate by the front door but the subject was able to pry it open. KUMAR stated that the subject then left the store and left westbound in a MCTS bus. KUMAR estimated the card reader's value at \$750. KUMAR was unsure of the insurance company utilized by the store.

I reviewed the store's security camera footage which shows the suspect enter the store at 12:43pm. After a brief interaction with the cashier, the suspect can be seen damaging the card reader, dumping the chips on the floor, and squirting soda at employees. The suspect leaves through the front door at

12:51pm. At 12:56pm, the suspect can be seen boarding a westbound MCTS bus at the northeast corner of N Teutonia Av and W North Av.

P.O. DOMAGALSKI took digital photographs recovered the security camera footage. Both the photographs and video were uploaded to Evidence.com.

KUMAR was issued a PV-17 and Community Contact Card.

I contacted MCTS which was unable to recover any security camera footage from the bus.

While on scene, I observed the licenses posted and they were up to date. During my investigation for Property Damage I did not observe any violations in the licensed premise. All employees were cooperative throughout the investigation.
