

Re: Report of the Renewal Applications of Matthew I. Thomas, Agent for Alarm Business and Alarms Sales licenses for "Vision Security, LLC" doing business at 508 West 800 North, Orem, Utah ("Vision Security").

### FINDINGS OF FACT

1. Matthew I. Thomas (hereinafter "Licensee") is the holder of Alarm Business and Alarm Sales licenses for Vision Security. Said licenses expired at midnight, December 31, 2013.
2. An application to renew said licenses was untimely filed with the Office of the City Clerk on July 16, 2014.
3. Pursuant to Chapter 105-75 of the Milwaukee Code of Ordinances, the application was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department responded with a report that could form the basis of non-renewal or suspension of this license dated July 22, 2014.
4. On October 31, 2014 the City Clerk's Office provided notice to the Licensee pursuant to Chapter 105-75-6 of the Milwaukee Code of Ordinances of the police report that could form the basis for non-renewal or suspension and included a copy of the police report. The matter was scheduled for hearing on November 12, 2014 at 9:45 a.m. and the licensee did not appear.
6. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
  - A. On August 20, 2012 Milwaukee Police Alarm Operator Ann McCarthy received a complaint from a resident, Mrs. Willie Bowen, on behalf of her mother-in-law, Ms. Lucy Bowen. Mrs. Bowen states a sale representative from Vision Security took advantage of her mother-in-law, who is 96 years



old and has Alzheimer's disease, and that this sales representative forged Ms. Bowen's signature on the contract. The sales representative, Bradley Collins, was advised by a sales manager for Vision Security to cancel Ms. Bowen's contract and to reimburse her for any charges related to reinstallation of her previous alarm system.

- B. At the meeting of September 10, 2014, Attorney Sean Brown, representative for Mr. Thomas, stated that the business did operate in the City of Milwaukee in 2014, despite the licenses expiring on December 31, 2013.
- C. Notice was sent to Matthew I. Thomas, Vision Security, LLC at 508 W 800 N, Orem, UT 84057, along with a copy of the police report on October 31, 2014 in an envelope which was sent by U.S. first-class prepaid mail in an envelope bearing the return address of the License Division, 200 East Wells Street, Room 105, Milwaukee, WI 53202. The address of 508 W 800 N, Orem, UT 84057 was the address given by the applicant on his renewal application. The notice included a copy of the police report. The licensee failed to appear at the hearing and the envelope containing the notice and police report was not returned to the License Division by the U.S. Postal Service.

#### CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 105-75-7 and -9 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Matthew I. Thomas, as agent for Vision Security, LLC has not met the criteria of Chapter 105-75-9 of the Milwaukee Code of Ordinances to allow the renewal of the licenses based on nonappearance, the police report and prior testimony.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Public Works Committee that the full Common Council of the City of Milwaukee should exercise its discretion and judgment to not renew the Alarm Business and Alarm Sales licenses held by Vision Security, LLC, Thomas I. Matthew, Agent, based upon nonappearance, the police report and prior testimony.

## RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of five (5) ayes and zero (0) noes voted to not renew the Alarm Business and Alarm Sales licenses held by Matthew I. Thomas as agent for Vision Security, LLC based upon nonappearance, the police report and prior testimony.



Re: Report of the Renewal Application of Saqib Javed for a Public Passenger Vehicle Driver License.

**FINDINGS OF FACT**

1. Saqib Javed (hereinafter the "Licensee") is the holder of a Public Passenger Vehicle Driver license in the City and County of Milwaukee, Wisconsin. Said license expired at midnight, October 31, 2014.
2. An application to renew said license was filed with the Office of the City Clerk on October 8, 2014.
3. Pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department filed a police report that could form the basis of non-renewal or suspension of this license.
4. On October 31, 2014, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes of a police report that could form the basis for suspension or non-renewal of the license of the licensee and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police report on November 12, 2014 at 9:30 a.m. in Room 301B of City Hall. At said date, time and place, the licensee did not appear and was not represented by counsel.
5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
  - A. Notice was sent to Saqib Javed at 2326 West Parnell Avenue, Milwaukee, WI 53221, along with a copy of the police report on September 23, 2014



in an envelope which was sent by U.S. first-class prepaid mail in an envelope bearing the return address of the License Division, 200 East Wells Street, Room 105, Milwaukee, WI 53202. The address of 2326 West Parnell Avenue, Milwaukee, WI 53221 was the address given by the applicant on his renewal application. The notice included a copy of the police report. The licensee failed to appear at the hearing of November 12, 2014 and the envelope containing the notice and police report was not returned to the License Division by the U.S. Postal Service.

- B. The Wisconsin Department of Transportation suspended the applicant's driver's license for the following:

12/20/2013 19 days for failure to pay forfeiture

The record also reveals the following:

12/12/2012 guilty failure to fasten seat belt  
1/10/13 guilty failure to keep vehicle under control  
11/5/13 guilty of speeding excess

- C. A check of License Division records indicates that during the period of suspension the applicant failed to return his PPV license to the City Clerk as required by City Ordinance 100-59-1-b

#### CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24, Wisconsin Statutes.
2. Based upon the above facts found, the Committee concludes that the licensee, Saqib, has not met the criteria of Chapter 100 of the Milwaukee Code of Ordinances or § 349.24 of the Wisconsin Statutes to allow renewal of his Public Passenger Vehicle Driver license based upon nonappearance and the police report.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Public Works Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Public Passenger Vehicle Driver license held by Saqib Javed based upon nonappearance and the police report.

## RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee recommends that the Public Passenger Vehicle Driver license of Saqib Javed be denied based upon nonappearance and the police report.



**FINDINGS OF FACT**

1. Murad S. Alhakimi (hereinafter the "Licensee") is the holder of a Public Passenger Vehicle Driver license in the City and County of Milwaukee, Wisconsin. Said license expired at midnight, October 31, 2014.
2. An application to renew said license was filed with the Office of the City Clerk on October 30, 2014.
3. Pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department filed a police report dated October 31, 2014 which report could form the basis of non-renewal or suspension of this license.
4. On November 3, 2014, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes of a police report that could form the basis for suspension or non-renewal of the license of the licensee and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police report on November 12, 2014 at 9:30 a.m. in Room 301B of City Hall. At said date, time and place, the licensee did appear and was not represented by counsel.
5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:



- A. On February 25, 2014 the applicant was charged in Milwaukee county with possession with intent to deliver-THC (>2500-10,00g) felony. He was found guilty on May 14, 2014 and sentenced to 3 years prison with 2 years extended supervision(imposed and stayed), 8 months in the House of Correction, 3 years probation.

#### CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24, Wisconsin Statutes.
2. Based upon the above facts found, the Committee concludes that the licensee, Murad S. Alhakimi, has not met the criteria of Chapter 100 of the Milwaukee Code of Ordinances or § 349.24 of the Wisconsin Statutes to allow renewal of his Public Passenger Vehicle Driver without a suspension of 15 days.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Public Works Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Public Passenger Vehicle Driver license held by Murad S. Alhakimi with a suspension of 15 days.

#### RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee by a four (4) ayes and one (1) noe recommends that the Public Passenger Vehicle Driver license of Murad S. Alhakimi be renewed with a 15-day suspension based upon the police report.

Said suspension is to be in effect from the dated of the Common Council meeting on November 25, 2014 and for 15 days thereafter.



#### CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24, Wisconsin Statutes.
2. Based upon the above facts found, the Committee concludes that the licensee, Jean Mosima, has not met the criteria of Chapter 100 of the Milwaukee Code of Ordinances or § 349.24 of the Wisconsin Statutes to allow renewal of his Public Passenger Vehicle Driver license without undergoing a ten (10) day suspension based upon the driving record.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Public Works Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew with a ten (10) day suspension the Public Passenger Vehicle Driver license held by Jean Mosima based upon the driving record.

#### RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee recommends that the Public Passenger Vehicle Driver license of Jean Mosima be renewed with a ten (10) day suspension based upon the driving record.

Said suspension is to be in effect from the date of the Common Council hearing of November 25, 2014 and for ten (10) days thereafter.
