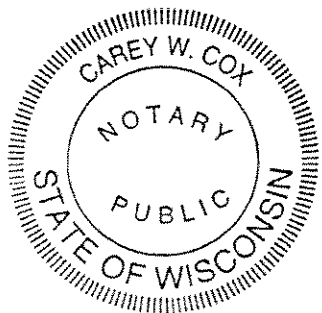

- 060220...**A substitute ordinance relating to policies and procedures for the selection and maintenance of sister city relationships.
- 060256...**Substitute ordinance relating to the change in zoning from Two-Family Residential to Local Business, on land located generally West of North 42nd Street and South of West North Avenue, in the 15th Aldermanic

District.

- 060416...**Substitute ordinance relating to the change in zoning from Two-Family Residential to a Detailed Planned Development known as Jackson Street Condominiums, on land located generally South of East Brady Street and East of North Jackson Street, in the 3rd Aldermanic District.
