There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. The licensee should be prepared to address these matters at the hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. This report is written by *PO Victor HERNANDEZ*, assigned to *DISTRICT TWO, Late Shift*.

On Tuesday 9/16/25 at approximately 3:07am, Squad 2350 (PO Spencer JACKSON and I) were dispatched to the address of 814 S 2nd Street which is located in the City and County of Milwaukee for a property damage complaint.

Upon *our arrival* we made contact with the caller/bouncer who identified himself as DE LA ROSA, Piero N (H/M 7/18/91) who proceeded to show us a video from the establishment's security camera system depicting a male who was also on scene and who identified himself as SYED, Abdul Razack (A/M 6/8/91) throwing rocks at the establishment's two front windows; eventually breaking the two windows. DE LA ROSA Stated that he chased after SYED after the two windows were broken and was able to stop SYED until we arrived. DE LA ROSA also attempted to contact the listed owner of the establishment MALDONADO, Julio to alert him of the incident but was not successful. While on scene I observed the two front Windows of the establishment to be broken and damage consistent with blunt force from a solid object, along with shattered glass on the ground. I spoke with MARTINEZ, Daniel (H/M 8/4/73) who is also a security guard at the establishment and asked if he could provide me an estimate of the damages and stated that the last time a window was replaced it cost the owner around \$1200-\$1500 for

a single window. Due to the damages exceeding \$2500 SYED was then arrested on scene and conveyed to District Two for booking and processing.

Observations: DE LA ROSA, and MARTINEZ were very cooperative and both stated that the incident occurred just after the business closed early for the night.

## **Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:**

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.  
**Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.**


