This issue is growing in our City and these resolutions and actions help address and activate solutions.

I'm writing as a resident and community member to ask you to please vote YES on Resolution #251662, Ordinance #251676, and Communication File #251661 when they come before the Public Health & Safety Committee on February 20th.

For the past seven months, communities like Metcalfe Park have been without a grocery store.
