- A petition signed by more that 50 percent of the owners in the area affected by this name change.

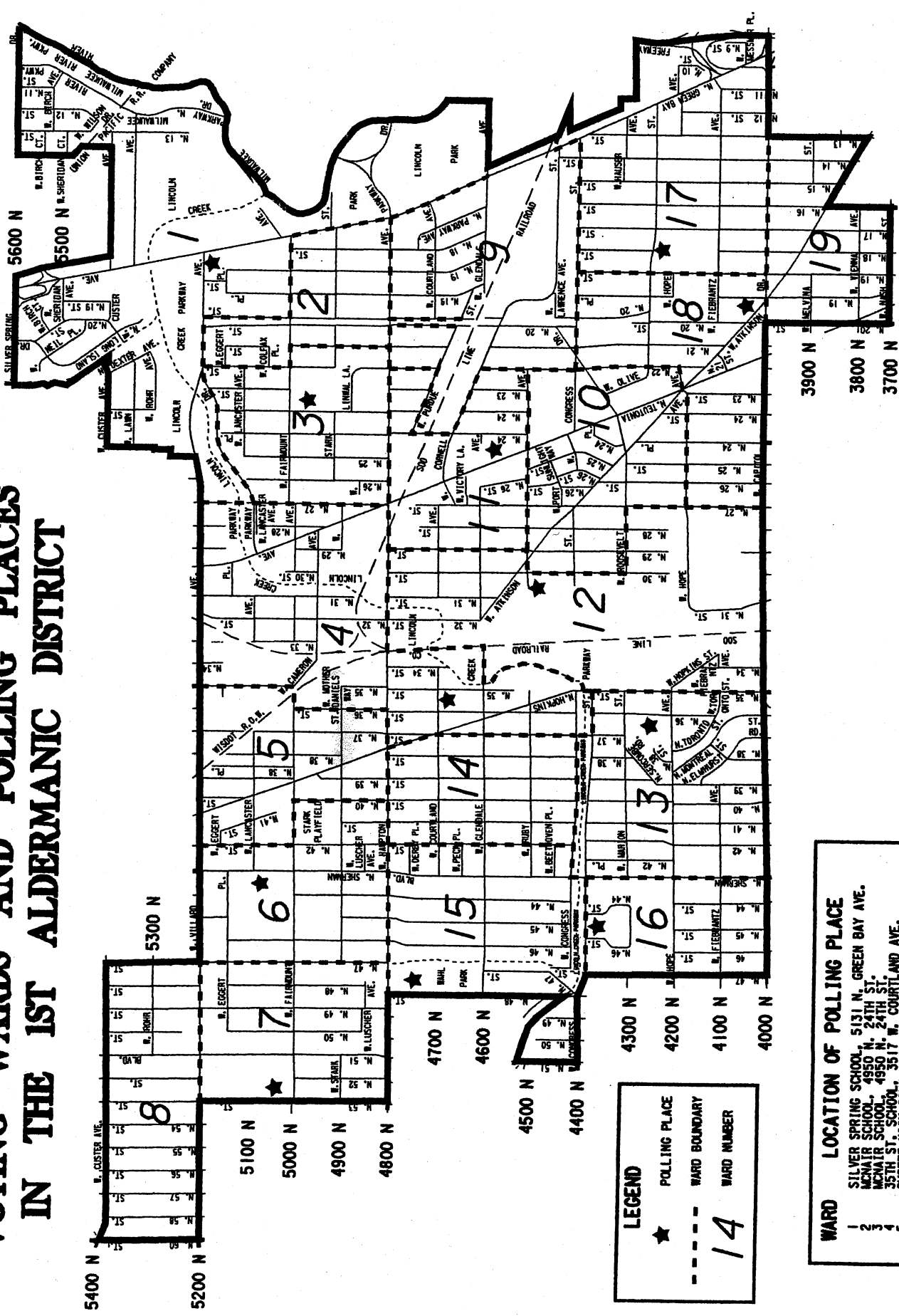







