
Dear Ms. Billings:


We have received your claim in the amount of \$1,214.22, relating to damage sustained to your vehicle on March 16, 1007 when you allege it was struck by a City vehicle at North Humboldt and East Brady.

Our investigation reveals that the Fleet Accident Report completed as a result of this accident notes that the driver of the City dump truck-trailer believed that the right turn signal was on. The driver began to make a right turn. You then attempted to make a right turn between the City vehicle and the curb. The City vehicle made contact with your vehicle. The Wisconsin Motor Vehicle Accident Report notes this. The liability for this accident is upon you. As such, the City cannot accept liability for your damages. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
