
This office is in receipt of your claim in the amount of \$2,000.00, relating to damage sustained to your Lawn Sprinkler System on August 12, 2004 at 8424 West Center Street that you allege was caused by the City of Milwaukee.

Our investigation reveals that the Infrastructure Services Division records indicate that the construction activity in this area relates to the State of Wisconsin Department of Transportation Contract Number 2066-04-70 for removing and constructing a seven inch concrete pavement in the vicinity of West Center Street between North 76<sup>th</sup> and 92<sup>nd</sup> Streets. The contractor is: La Londe Contractors, Inc., P.O. Box 070420, 2929 South Chase Avenue, Milwaukee, WI 53207. Since the City is not involved with the project, it cannot accept liability for your loss. Accordingly, we are denying your claim.
