If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. This report was written by Milwaukee Police Officer, Jesus RODRIGUEZ (PS#029217), assigned to District Two, Early Power Shift, Squad 2245, with Police Officer Delian MENDEZ-SANTIAGO (PS#028797).

On Sunday, January 12th, 2025, at approximately 6:07pm Police Officer MENDEZ-SANTIAGO and I responded to the address of 1201 W. National Ave. for a Battery call for service. The caller identified himself as Raj. Upon arrival I observed two male subjects inside the store, one who was highly intoxicated and only able to stand straight by holding himself up and another subject who was sleeping on the ground.

I spoke with the standing subject who identified himself with a Wisconsin identification card as Anthony D. NORD JR (B/M, 12/12/1993). NORD stated that he didn't know who the subject that was on the ground. NORD initially made a comment that he might have something to do with the fact the subject was on the ground, stating "I told him not to get in my face." implying that he battered the man.

The subject on the ground identified himself as Richard E. CLAY SR (B/M, 12-16-1955). CLAY who had a very strong odor of alcohol and urine emanating from his body appeared to have been battered, as he an abrasion on his head and hands. CLAY only stated that he had been drinking for two days straight and only wanted to be taken to the hospital by ambulance. CLAY would be transported to a local hospital by Bell Ambulance #411.

CLAY did not wish to be a victim of battery and stated that NORD did not assault him and did not know him.

While on scene Officer MENDEZ-SANTIAGO spoke with the store employee, Rajwinder SINGH (A/M, 05-02-1998) who stated that that he saw nothing or heard nothing. It must be noted that Video footage from within the store reveled that CLAY and NORD had a verbal argument that turned physical prior to police arriving and SINGH was observed arguing with the two men while he held a bat in his hands.

The hearing before the Licenses Committee will take place on 4/8/2026 at 9:40 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
