Hi Tim,

DocuSign is actually administered by ITMD at this point, and their license is set up to cover the entire city. The provisioning process is manual at this point—you have to send an email to Don Turner in ITMD—at which point you will have access to e-sign and set up templates for document types you use a lot. For example, we have a docusign template for secure structure applications, because it's frankly a lot easier to track them in electronic vs. paper form. Other departments use it for anything that needs a signature attached to it—purchasing uses it for contracts, DCD Real Estate uses it for its property transactions, DPW uses it for a lot of personnel-type stuff, etc. The purpose of the policy is to get departments thinking about the documents they send through DocuSign as potential records, and about where those records should be retained once the signing transaction is complete (to wit: not DocuSign's own servers).

I've been playing with the template builder enough that if you think there is a particular form that could benefit from having data collected via DocuSign, I can probably help you compile it—there's a lot of neat stuff it can do besides e-signatures. If you have certain types of form fields it can even do data analysis, though that's not a function that I've explored extensively. If you'd like to meet to discuss putting something together, please let me know.
