

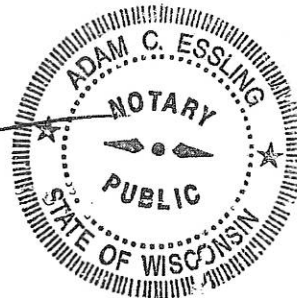

This report is submitted by Detective Gust Petropoulos assigned to the homicide Unit day shift.

On Sunday, April 17th, 2016 Detective Michael Sarenac and I went to the City Tow Lot to process the following vehicles for evidence. This was done with the assistance of Forensic Investigators Sylvia Ortiz and John Hinkle, who also took photographs.

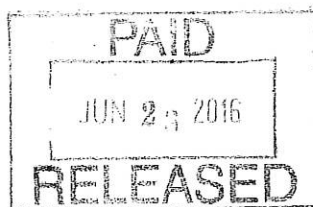
