There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

**Notice for applicants with warrants or unpaid fines:**

**Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.**

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 12/16/05 at 12:27am, a Milwaukee Police aide, who is under the age of 21, at the direction of a Milwaukee Police officer, approached the bartender and ordered two cans of beer. The bartender never asked for identification and sold the beer to the police aide. The bartender was identified as Terrence L. Stocks, b/m 01-09-66 and he was issued a citation for Sale To Underage Prohibited.

2. INCIDENT – On 5-31-07, at 9:40pm, officers were dispatched to back up other officers in connection with a "Trouble with a Subject" complaint at TJ's on 35<sup>th</sup>, at 237 N 35<sup>th</sup> Street. Arriving on the scene, the officers observed 20-30 people on the parking lot just south of the tavern, standing on the lot listening to music from several vehicles and drinking various types of alcoholic beverages from cans and bottles. When the subjects saw the officers, several walked toward a large dumpster, threw their open bottles and cans into the dumpster, and entered the tavern through an open rear door. Inside the tavern they observed a person identified as Kevin Jones, son of the licensee, who was one of the

persons seen outside on the lot drinking with others. The officers then spoke to the licensee on the premises. They told him about the persons drinking outside on the parking lot. He became very defensive, stating the parking lot did not belong to him, it belonged to the Credit Union. He continued arguing with the officers, saying it was not his responsibility what the patrons did after they left his bar. The officers asked the subject for his name, and the address of the bar. He said the address was on the front of the building, and "if you want it, go get it yourself." The officers asked to see the tavern license. It was posted on the wall at least 7 feet above the ground, and illegible at that height. When the officers asked licensee to bring the license off the wall, he said "You do it." Tommy subsequently retrieved the license from the wall, but continued to complain about how the officers were harassing him. When the officers left the premises, they went to the vehicle on the parking lot, next to the tavern, where they had earlier observed Kevin Jones, son of the licensee, standing. Inside the vehicle they observed an open 12 oz bottle of Miller genuine draft beer, approximately 1/4 full, still cold to the touch. They also observed a few other bottles and cans of alcoholic beverages, which appeared to be freshly opened containers, laying on the ground on the parking lot. The licensee was very argumentative with the officers on the scene, his defiant attitude toward the officers on the scene was not that of a responsible tavern operator. Report filed.

3. On 05/15/2010 at 12:46am Milwaukee police responded to a shooting in the parking lot at 237 North 35<sup>th</sup> Street (T.J.'s on 35<sup>th</sup>). Investigation revealed a patron left the bar around 12:30am. A subject who approached from the alley shot the patron. Milwaukee police incident report #101350009 filed.

4. On 06/19/22 at 1:19am, officers conducted a License Premise Check at 237 N. 35<sup>th</sup> St. The agent was on scene and cooperative. No violations were found.

5. On 10/18/22 at 10:47p.m., Milwaukee Police were dispatched to a Shooting at a local hospital. Investigation revealed a celebration of life was being held at 237 N. 35<sup>th</sup> St., and an argument broke out between patrons. One of the patrons was armed with a gun in their pants pocket, which the patron stated accidentally discharged during the incident. Officers did locate blood droplets inside the establishment as well as a bullet laying on a napkin in the bar. The officers contacted the agent who was no longer on scene. The agent stated they initially thought it was a firecracker, however, quickly realized it was a gunshot. The agent admitted to picking up the bullet and placing it on the napkin, but then locked up the bar and left never calling the police. The agent stated there was video surveillance, however, it has not been working recently.

### INITIAL INVESTIGATION

On 10/18/22, Squad 3440 PO. Michael MARX and I responded to a Shooting complaint located at 237 N 35th St. 237 N 35th St. is a tavern called TJ's on 35th Street.

The victim walking into St. Lukes Hospital and advised Squad 3451 PO. SWEENEY and PO. TOLENTINO arrived at the hospital and spoke with the victim. The victim stated the shooting happened outside the main entry door of 237 N 35th St.

Upon arrival we located blood droplets under the main entry door and on the sidewalk within feet of the main entry door. Fearing that others might be inside who have been shot, but being unable to physically force the doors on our own due to their being reinforced, we called MFD, Engine 9 arrived on scene and made a force entry into the rear door of the tavern.

We observed all the lights to be turned off and no one inside. We cleared the tavern and did not locate anyone inside.

We observed several small blood droplets on the inside floor directly inside of the front entry door. We also observed a bullet laying on top of a napkin on the bar top. We also observed a bullet hole in a rug that is within feet of the main entry door and a small dent in the floor under the rug. This appears to be caused by a bullet.

We did not observe any other bullet holes inside or outside of the tavern. We also did not locate any other casings or bullets inside or outside of the tavern.

We also observed a buffet of fresh food that was sitting on the pool table. It appears everyone left in a rush.

I collected the bullet and placed it on inventory #

Squad 1921 PO. ULATOWSKI took numerous photos of the scene, blood and bullet.

This report is written based off PO Eric SWEENEY initial report.

On Tuesday, October 18, 2022 at 10:47PM Squad 3451 (PO Richard TOLENTINO and PO Eric SWEENEY) was dispatched to a walk-in shooting at St. Luke's Medical Center (3174 South 31st Street).

Upon arrival PO. SWEENEY spoke with the victim Erika N. MARTIN (B/F 03-24-1987). MARTIN had what appeared to be an entrance wound on her upper right thigh as well as an apparent exit wound on her lower right thigh. It should be noted that there was a dark residue around the apparent entrance wound as well as a small amount of burnt tissue consistent with a firearm being discharged in close proximity to the wound.

The following is a synopsis of my interview with MARTIN. Squad 9240 (Detective Jonathan BOHN) conducted an in-depth interview. See supplemental report regarding.

MARTIN stated that she was at TJ's bar (237 North 35th Street) for a "celebration of life" of her

girlfriend's (Jessica R. WILLIAMS [B/F 04-20-1989]) sister's child's father, who recently passed. MARTIN stated that while at the bar, she, WILLIAMS, and WILLIAM's sisters became involved in a verbal dispute with a male subject whom she did not know, but described as a black male in his mid to late 30s standing approximately 5'08" with a heavy build and wearing a black du-rag. MARTIN maintained that she urged WILLIAMS and the rest of their party to leave the location, fearing that a physical altercation was imminent.

MARTIN states that as she was leaving the bar she heard a single gunshot and a short time later, realized that she had been shot in the leg.

MARTIN stated that WILLIAMS then drove her to St. Luke's to seek medical treatment in their rental vehicle, a gray Dodge Journey bearing Texas registration plate MWP2025.

MARTIN initially stated that she was not in possession of a firearm during the incident.

Later, when confronted with the numerous inconsistencies in her story and the type of wound she received MARTIN admitted that she did have a Taurus .38 special revolver in her right pocket which accidentally discharged during the incident. MARTIN maintained that she did not draw the firearm, or put her hand in her pocket throughout the incident, and did not know how the firearm discharged.

This report is written based of Police Officer Ethan SCHLAX, initial report.

On Tuesday, October 18, 2022, at approximately 10:46 PM, squad 3220 (PO Ryan MILLER and PO. Ethan SCHLAX) was dispatched to assist with locating a shooting scene at 237 N. 35th St, which is located in the City and County of Milwaukee, Wisconsin.

Upon arrival, Squad 3220 assisted with locating and securing the scene.

Squad 3220 were then tasked with attempting to locate the owner of the bar (the above address), Tommie L. JONES (b/m, 02-22-48). Squad 3220 went to 337 N. 29th St. to check for him. Upon knocking on the door, Squad 3220 spoke with a male, identified verbally as Christopher S. JONES (b/m, 02-18-86), who stated that he is Tommie's son. Christopher appeared to be unaware of the shooting incident at the bar. He advised Squad 3220 that Tommie was not home and if he wasn't at the bar, then he was likely with a friend of his, known only as "Anne". Christopher was able to get ahold of Tommie via phone (414-202-3725). Tommie stated that he was at 4689 N. 70th St. Tommie stated that he was having a family gathering at the bar to remember his nephew, who recently passed away in a car crash. Tommie stated that people began arguing about the food. Tommie stated that he then heard what he believed to be a fire cracker, but quickly learned that someone had fired a gun, but he did not see who. Tommie stated that everyone then left. He stated that he found the bullet on the floor and he picked it up and put it on a napkin on the bar. Tommie then locked up and left the bar as well, not calling police to report the incident.

Tommie stated that he did not want to return to the bar and requested that officers would board up the

door that had been forced to gain entry for a welfare check.

There were cameras all over the inside and outside of the bar and a screen on the inside that showed small boxes with the live stream view of what each camera showed. Tommie stated that he leases the camera system and that he normally has access to the video through an application on his phone but that it has not been working recently and he does not know how to access it. Tommie stated to officers that he has tried to call the company that he leases the cameras through but he has not been able to solve the issue. Tommie stated that there is a password on the system and that no one currently is able to access it, including him, until he gets in touch with the company from whom he leases the cameras.

Officers were not able to gain access to the surveillance system on scene.

Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

## **Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:**

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
