There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- The applicant's Wisconsin driver's license revealed the following convictions:

1. On 11/06/10 at 8:28 pm, Milwaukee police conducted an Underage Tavern Sting at 8340 W Lisbon Avenue. Officers had a police aide, who is under the age of 21, entered the bar with the aide purchasing a Mikes Hard Lemonade in which the bartender sold without asking for ID. Police identified the bartender as Joseph Fiumefreddo who admitted to police to selling the drink because he thought the aide was over 21. During the investigation, the licensee Jeffrey Kamermayer arrived on scene and inquired as to what happened. Officers advised Kamermayer of what happened whom then became angry and stated, "I just sent every employee a text." Kamermayer further stated that "almost everyone should be carded because they are coming for us". Fiumefreddo was cited for sale to underage.

2. On 01/29/11 at 8:52 pm, Milwaukee police were conducting Sales of Alcohol to Underage Persons and had a Milwaukee police aide, who is under the age of 21, enter 8430 W Lisbon Avenue in attempts to purchase alcohol. The police aide order two beers from the bartender, identified as Jenni Young, and was asked by Young for ID. The aide stated she didn't have any and when asked by Young for the aide's birthdate, the aide provided a false date. Young served the beer to the police aide. When questioned by police, Young stated that the girl looked older than 21. Young was cited for sale to underage.

3. On 09/15/2017 the applicant was cited for Operating While Intoxicated 2nd. He was convicted on 03/22/2018 and his license was revoked for 1 year plus 70 days House of Corrections.

4. On 10/12/2019 at 12:51am officers were dispatched to a Battery complaint at N. 84th St and W. Lisbon Av. The fight occurred in the median but started inside Kam's Corner Tap, 8340 W. Lisbon Av. The victim stated there was verbal altercation inside about someone bumping into another subject. This argument was broken up by bystanders. The victims were outside when they were assaulted by three subjects from inside the bar. The officers spoke with the bartender who stated he did not see either of the altercations. The tavern does have cameras but the ones outside are inoperable. The bartender stated the agent is the only one with access to the cameras. The tavern license presented by the bartender had an expiration date of 10/11/2019.

5. On 10/12/2019 at 11:09pm officers conducted a license premise check at Kam's Corner Tap, 8340 W. Lisbon Av. The officer spoke with the bartender, who provided a receipt stating the license fee was paid. The officer checked LIRA and found the license was valid-pending renewal.

6. On 09/06/2022 at 11:35pm officers investigated a homicide at 8430 W. Lisbon Av. The officers interviewed the bartender, who stated the victim and his girlfriend left the bar and she heard shot fired outside. She stated a subject ran inside stating someone was shooting at the victim. The applicant was on scene during the investigation and was cooperative. The bar did provide video to the officers.

7. On 04/06/23 at 4:31p.m., Milwaukee Police conducted a License Premise Check at 8430 W Lisbon Av. No violations were found and the employee was cooperative.
8. On 04/16/23 at 3:35p.m., Milwaukee Police were dispatched to a Trouble with Subject at 8430 W. Lisbon Av. Investigation revealed an intoxicated subject, who was previously told could not enter the premise, repeatedly entered and was causing problems both with patrons and staff. The subject was on probation/parole and absolute sobriety was one of their bail conditions. The subject was subsequently arrested on a probation violation.

This report is written by PO Chad STILES, assigned to District 7, Day Shift.

On Sunday, 04/16/2023, at 15:35 hrs, Squad 7141, PO Chad STILES and Aina GOODWILL, responded to Kam's Tap Bar, 8340 W Lisbon Ave, in the city and county of Milwaukee for a trouble with a known subject (MPD CAD#23-106-1094)

We responded in marked Milwaukee Police Department Squad car 582, in full Milwaukee Police Department uniform, both equipped with Axon camera systems.

On arrival, I spoke to the owners Carey A KAMERMAYER W/F, DOB 07/21/1972, and Jeffrey P KAMERMAYER, W/M, DOB 07/10/1967, of Kam's Tap Bar, who stated that a known subject, (previous patron) Peter W BERRES, W/M, DOB 10/24/1963, came into the bar with a beer on Friday, 04/14/2023, told to leave and again on Saturday 04/15/2023 around 1900 hrs, and was told by Kam's Tap bartender Valerie BAERTLEIN, that he would not be served, to leave and he was no longer allowed on their property. BERRES then started yelling and caused a disturbance in the bar, and eventually left, driving his 2009 white Chevrolet Silverado pickup truck, bearing WI plate JU9592, up the sidewalk on W Lisbon Ave for approximately a block, which BAERTLEIN did record on her cellphone and submitted to investigating officers on MPD Evidence.com link.

Carey and Jeff stated that BERRES returned to the tavern on Sunday, 04/16/2023 around 1520 hrs, trespassing and was passing notes to patrons and then confronted Jeffrey, calling him a "junkie" and made fun of his teeth, for which he had radiation treatment, and then "got in his face with his finger at his nose", yelling and causing a disturbance, causing them to fear for their safety.

BERRES is on bail with Milwaukee County Case 2020CM001970 and on probation/parole with Milwaukee

Those wishing to provide oral testimony via phone or internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
