2	(NOTE: All City Personnel Were Sworn Under
3	Oath Prior to These Proceedings.)
4	CHAIRMAN BOHL: Maria Albiter, Class "B"
5	tavern and tavern dance renewal application for Tex
6	Mex Place at 1900 West Lincoln Avenue, also in the 8th
7	Aldermanic District. Okay. Miss Albiter, you are
8	here. Are you represented by counsel?
9	MR. PADWAY: Yes.
10	CHAIRMAN BOHL: And, sir, your name is?
11	MR. PADWAY: Attorney William Padway,
12	P-a-d-w-a-y.
13	CHAIRMAN BOHL: Okay. Miss Albiter, could
14	you please raise your right hand?
15	(Whereupon the Applicant was Sworn Under
16	Oath.)
17	CHAIRMAN BOHL: And do you acknowledge
18	receiving notice of today's meeting with the
19	possibility that your license application may be
20	denied based on the items in the police report, as
21	well as neighborhood objection to loitering, littering
22	noisy patrons, traffic congestion, suspected drug
23	activity, and conduct which is detrimental to the
24	health, safety and welfare of the neighborhood?
25	MS. ALBITER: Yes, sir.

1	CHAIRMAN BOHL: Okay. With that, Health
2	Department?
3	MR. BOND: No objection.
4	CHAIRMAN BOHL: Neighborhood Services?
5	MS. BENDER: No objection.
6	CHAIRMAN BOHL: Sergeant Hogan?
7	SERGEANT HOGAN: There's one incident since
8	the license was last issued, and I'll be reading from
9	the report filed by one of the investigating
10	detectives.
11	"During the month of October 2002,
12	information was received at the Vice Control Division
13	from a confidential source that individuals associated
14	with the Tex Mex Tavern were involved with large scale
15	drug trafficking. One of these individuals was later
16	identified as Jose Jimeze. Mr. Jimeze subsequently
17	directly delivered and conspired to sell in excess of
18	500 grams of cocaine to an undercover officer during a
19	series of transactions. These transactions occurred
20	within the attached rear garage of the tavern over a
21	period of approximately two months.
22	During the course of this investigation,
23	the undercover officer was directed by Mr. Jimeze to
24	contact the tavern owner known as Jose for cocaine.
25	Jose was later identified as Jose Albiter. The

00004
1 undercover officer made subsequent contact with Jose
2 Albiter, and between December 4th of 2002 and January
3 3rd of 2003, at least four undercover cocaine
4 transactions occurred with Albiter, totaling in excess
5 of 225 grams. These transactions and meetings
6 occurred within the tavern and the garage attached to
7 the tavern.

8 On January 7th, 2003, a search warrant was 9 executed at the tavern and at the Albiter residence. 10 Recovered inside the tavern was approximately \$12,000 11 in U.S. currency, documents, and one firearm. Inside 12 the garage attached to the tavern was recovered 13 another firearm. A \$50 bill was recovered from the 14 safe in the office area of the tavern and was 15 discovered to match part of the buy money that was 16 used in an undercover transaction with Albiter.

17 When conducting an interview with Maria 18 Albiter, the wife of Jose Albiter, she stated that she 19 handled all the financial dealings and bills generated 20 from the tavern operations. Maria Albiter indicated 21 that the business generated from the tavern operations 22 was not very significant. She denied having any 23 knowledge of drug trafficking by her husband or any 24 other individuals. She stated that the money used to 25 purchase the tavern came from an injury settlement

00005 1 that her husband received from a prior work-related 2 accident. 3 Jose Albiter and Mr. Jimeze were charged in 4 a criminal complaint with the delivery of controlled 5 substance, cocaine. Mr. Jimeze was also wanted by 6 U.S. Marshals for escape from a federal prison in 7 Duluth, Minnesota. 8 Mr. Albiter admitted to his involvement in 9 conspiring with Mr. Jimeze to distribute cocaine. The 10 street value of the cocaine sold to the undercover 11 officer is estimated to be in excess of \$50,000. 12 Presently actions are being taken to federally seize 13 the tavern property and other assets involved with 14 this incident." That's all. 15 CHAIRMAN BOHL: Thank you, Sergeant Hogan. Miss Albiter, or counsel, you have the ability to 16 17 raise any questions or respond to the police report at 18 this time. Is there anything --19 MR. PADWAY: Yes, I would like to respond. 20 Mr. Albiter is currently pending criminal charges in 21 Milwaukee County Circuit Court for the transactions 22 that were reported. What I would note is that -- or 23 what you should know is that Mrs. -- the name of --24 The ownership and the license is in his wife's name, 25 that she cooperated with law enforcement by giving the

1	statement, and it was a very truthful statement. I do
2	have with me proof of the large personal injury
3	settlement that was obtained.
4	Mr. Albiter used to work in Illinois,
5	Waukegan, Illinois, and suffered a severe injury where
6	he lost use of his right arm and had to have his knee
7	reconstructed and had back injuries which left him
8	disabled. I can present this personal injury
9	settlement documentation which shows that they
10	received \$142,000, and he no longer works at that
11	company because of his disability, and that settlement
12	occurred on December 1st of 2000. They did then
13	purchase, with those proceeds, the Tex Mex Place.
14	Mrs. Albiter's actively very actively
15	involved in the operation of it. She cannot What
16	happens in that criminal case will involve her
17	husband, not her. There's no allegation of any
18	problems that she has been involved with. It is a
19	business that she is using, obviously, to support her,
20	her son, and her husband if he's acquitted. If he is
21	convicted of this offense, I suspect he will end up in
22	prison.
23	I should also note that this is a small
24	establishment, 51 people. I read the file or the
25	cards and the notice which says there's neighborhood

1	objections. From reading the cards that were actually
2	filed, that to my knowledge is incorrect. I say that
3	because there were eight individuals that responded on
4	the cards; two individuals of the eight objected, but
5	they did not object for reasons of loitering,
6	littering, noisy patrons or traffic congestion. They
7	objected on the sole basis that there was already a
8	lot of businesses in the area, and they just did not
9	want another licensed tavern. From reading the cards,
10	it would be my interpretation that they thought that
11	this was a new establishment coming into the area.
12	Clearly this is a situation where there is
13	an objection as a result of the spouse of the owner.
14	It is my suggestion that if that is the concern, that
15	that can be easily remedied by an agreement that that
16	spouse not be allowed near the tavern during the
17	pendency of his criminal proceedings, and that can be
18	arranged, and my client has no problem with it. But
19	as far as neighborhood objections, I don't believe
20	there really are any neighborhood objections.
21	There are some patrons here in support of
22	this license being given that would say that it's an
23	extremely clean, low-key tavern that is used by the
24	neighborhood for just a very pleasant social
25	experience.

00008 1 2	CHAIRMAN BOHL: Okay. Thank you, Counsel. Are there any questions of committee members relating
3	to the police report at this point? Okay. This item
4	is noticed for neighborhood objections. Are there
5	residents of the neighborhood who are here, just a
6	show of hands, who are here to testify in this matter?
7	Okay. I see one hand up. Ma'am, are you here for or
8	against?
9	MS. ZINKE: Against.
10	CHAIRMAN BOHL: Against. Okay. Thank you.
11	We'll take you in one moment here. Alderman Donovan,
12	is there something that would you like to make an
13	opening statement here?
14	ALDERMAN DONOVAN: Yes. Thank you,
15	Mr. Chairman. In the words of the attorney, the
16	patrons of this establishment came to enjoy
17	themselves, and they certainly did, with a great deal
18	of drug trafficking in my estimation going on at this
19	establishment.
20	I believe with the evidence that has come
21	forward, it's critical that we, as elected officials,
22	send a loud and clear message to licensed
23	establishments in this community that this type of
24	behavior cannot be tolerated. This makes a mockery of
25	the term "war on drugs" if this license is granted. In

00009 1 the words of the attorney here, the applicant was very 2 actively involved in the operation of this tavern, and 3 yet claims to be completely unaware of the goings on 4 or the activities of her husband, which I am convinced 5 operated the establishment just as much as she did. 6 Now, a point was made that there were no 7 significant neighborhood objections, and I'm not going 8 to argue that point. I think we're all aware that a 9 large number of complaints that come forward about 10 taverns are generated because of loud music or because 11 of patrons shooting up -- shooting guns off or 12 urinating in public, and so on and so forth, all the 13 types of testimony this committee has heard on 14 numerous occasions. I'm not saying that took place at 15 this establishment. 16 They had no need -- you know, there was 17 no -- People evidently just came in and bought their 18 drugs and were quiet about it, and I think that is 19 something that can't be tolerated. 20 I should also like to point out that this 21 area along Lincoln Avenue has been and continues to be 22 a problem with prostitution, and I think by allowing 23 for this establishment to remain open, that's just 24 fueling that type of activity. Drug activity in that

neighborhood is very high already. This area sits in

1	the middle of a Targeted Investment Neighborhood. We
2	are trying very hard to turn this particular
3	neighborhood around, so I would I feel I would be
4	negligent as an alderman and a representative of my
5	district if I did not plead with this committee to
6	deny this license to this applicant. And I would
7	treat any establishment with this kind of record the
8	same way. Thank you.
9	MR. SCHRIMPF: Mr. Chairman.
10	CHAIRMAN BOHL: Thank you, Alderman Donovan.
11	Mr. Schrimpf?
12	MR. SCHRIMPF: Yeah. I was out of the room,
13	and I apologize for that. I got buttonholed while I
14	was out of here. Are we on Tex Mex?
15	CHAIRMAN BOHL: That is correct.
16	MR. SCHRIMPF: Okay. I just want to caution
17	the committee, what is before you and what is included
18	in the notice is the police report, nothing else.
19	CHAIRMAN BOHL: This is also cited for
20	neighborhood objections. We do have one resident
21	who's here.
22	MR. SCHRIMPF: I don't see that on my
23	notice. It says attached police report.
24	CHAIRMAN BOHL: Right underneath it,
25	neighborhood objections to littering, loitering, noisy

00011 1 patrons, traffic congestion, suspected drug activity, 2 etcetera, etcetera. 3 MR. SCHRIMPF: That's not on my notice. 4 SERGEANT HOGAN: That's Schultz. 5 MR. SCHRIMPF: Oh, wrong. I'm sorry. Okay. 6 I take it all back. 7 CHAIRMAN BOHL: All right. Thank you, Alderman Donovan. Ma'am, if you would come forward 8 9 here now. 10 (Whereupon Linda Zinke was Sworn Under 11 Oath.) 12 CHAIRMAN BOHL: For the record we will need 13 your name, your address, and then any testimony that 14 you have directly witnessed, seen or heard. 15 MS. ZINKE: My name is Linda Zinke. 16 CHAIRMAN BOHL: And, ma'am, if you could 17 move forward to the microphone so we can hear you 18 clearly. Thank you. 19 MS. ZINKE: My name is Linda Zinke. I live 20 at 2213 South 18th Street. I am speaking for the drug 21 trafficking and the prostitution. We do not need 22 another liquor license in the neighborhood. 23 We have an elementary school directly across 24 from 19th and 18th and Lincoln. If there's drug 25 activity, it's also fueling the prostitution problems

1	that we're having. It's also fueling a number of
2	violent activities, and I just don't feel that we need
3	another liquor license, especially as far as this bar
4	has been under investigation and has had obviously
5	drug problems.
6	CHAIRMAN BOHL: Miss Zinke, you indicate you
7	live how far from this establishment?
8	MS. ZINKE: I live on 18th, but
9	CHAIRMAN BOHL: How far is that from this
10	location approximately?
11	MS. ZINKE: Less than a block.
12	CHAIRMAN BOHL: Okay. So you're less than a
13	block away.
14	MS. ZINKE: Uh-hmm.
15	CHAIRMAN BOHL: What have you directly seen
16	or witnessed related to some of the items that you're
17	talking about?
18	MS. ZINKE: Well,
19	CHAIRMAN BOHL: And I mean in terms of
20	not only relaying that this is a problem in the
21	neighborhood, but directly established to this
22	particular establishment.
23	MS. ZINKE: Okay. It's not very clean
24	outside of the bar, all right. That's number one.
25	Number two, there's drug trafficking. That's already

00013 1 been established. There's an elementary school across the street from the bar. We do not need another 2 liquor license in the neighborhood. We have plenty 3 4 of bars that are proliferating the drugs, the 5 prostitution. We don't need this in our neighborhood. We're trying to revitalize the area. 6 7 CHAIRMAN BOHL: Okay. Miss Zinke, what -- I guess what I'm getting at is that when the committee 8 9 takes into consideration residential testimony, we 10 need to hear items that you directly have witnessed. 11 Now, I know that you are aware of items in 12 the police report. That, for the committee's sake, 13 is hearsay evidence. Unless you, yourself, have 14 witnessed drug activity going on or some of these 15 problems directly attributable, that is not testimony 16 that we can use in --17 MS. ZINKE: So what you're saying is that 18 the people who live in that area that are experiencing 19 these things on a daily basis don't have a voice 20 because we did not directly witness this? Is that 21 what you're telling me? So we don't have a voice in 22 this at all. 23 CHAIRMAN BOHL: What I'm telling you is by 24 state law we are required not to consider hearsay 25 evidence, but direct testimony of residents and

00014 1 testimony that's attributed in the police report. 2 MS. ZINKE: Uh-hmm. And I'm telling you 3 that many of the bars that are  $\ensuremath{\text{--}}$  and there are many 4 bars, every corner, every corner in a three-block 5 area, and that includes hers, there is a liquor 6 license. There's also an Open Pantry that has a 7 liquor license. We have prostitution going on. It's coming up -- It directly effects my home. 8 9 CHAIRMAN BOHL: Ma'am, trust me. I am 10 sympathetic to the concerns. 11 MS. ZINKE: We are --12 CHAIRMAN BOHL: Ma'am, ma'am. Please. We 13 are required by state law. I didn't establish the 14 state law, Alderman Johnson-Odom didn't establish the 15 state law. That is what state law dictates we are 16 allowed. I just want to clarify that for the record. 17 This is something that has to be known. We must 18 follow the rule of the law. If you are unhappy with 19 that, you should talk with your state legislature, but 20 we have to stay with the state law. Other questions 21 at this point for Miss Zinke? 22 ALDERMAN GORDON: Mr. Chairman. 23 CHAIRMAN BOHL: Alderman Gordon. 24 ALDERMAN GORDON: Thank you. Miss Zinke, 25 have you observed at any point in time any activities

1	such as littering, loitering, public display of
2	alcohol use, public urination, foul language being
3	used, loud language being used, or loud music being
4	played coming from this establishment?
5	MS. ZINKE: Not directly from the bar. From
6	the garage behind the bar that is attached to the bar,
7	yes, because that alley is my access to 19th Street
8	from my parking space behind my house.
9	ALDERMAN GORDON: So that garage that is
10	located behind the establishment, is that, to your
11	knowledge, a part of that establishment?
12	MS. ZINKE: As far as I know. It's attached
13	to the building.
14	ALDERMAN GORDON: It's attached to the bar?
15	MS. ZINKE: Yes.
16	MR. GORDON: And you've observed personally
17	the kinds of activities that I just stated coming from
18	that part of the property?
19	MS. ZINKE: The garage doors are open.
20	There's cars being worked on at times. There's a lot
21	of litter around the bar, yes.
22	ALDERMAN GORDON: Thank you.
23	CHAIRMAN BOHL: Okay. Any other questions?
24	ALDERWOMAN ODOM-JOHNSON: I just have one.
25	CHAIRMAN BOHL: Alderwoman Johnson-Odom.

00016 ALDERWOMAN JOHNSON-ODOM: All of these 1 2 allegations or charges or whatever are referred to 3 Jose Albiter. Is he in jail now? 4 MR. PADWAY: No, is he not. 5 ALDERWOMAN JOHNSON-ODOM: Is he a part of this establishment? 6 7 MR. PADWAY: He is my client's husband, he 8 has worked in the tavern, but it is her tavern and her 9 license. 10 ALDERWOMAN JOHNSON-ODOM: Has there been 11 anything since the last time he was arrested? Was 12 that in January? 13 MR. PADWAY: I'm not representing him, but 14 I do not believe -- That action against him, to my 15 knowledge, is what has brought this objection to this 16 renewal, and only that particular action. 17 ALDERWOMAN JOHNSON-ODOM: And he has a 18 hearing tomorrow? I mean on Thursday? 19 MR. PADWAY: I believe he's got a court 20 hearing coming up. 21 ALDERWOMAN JOHNSON-ODOM: A jury trial in 22 April? 23 MR. PADWAY: Could be. 24 ALDERWOMAN JOHNSON-ODOM: But does he hang 25 around this bar.

1	MR. PADWAY: He used to. I mean if it is
2	He can be completely disassociated from this tavern
3	during the pendency of that proceedings without any
4	problem.
5	CHAIRMAN BOHL: Mr. Padway, that is
6	something that this committee cannot you know, you
7	can attest to that, but that's nothing that we can
8	hold you or the applicant to, just for clarification.
9	Alderman Johnson-Odom, are you finished at this point?
10	ALDERWOMAN JOHNSON-ODOM: Uh-hmm.
11	CHAIRMAN BOHL: Miss Zinke, thank you for
12	your time and your concerns here. We're going to go
13	to Alderman Donovan, if you have any closing remarks,
14	and then we'll go to you, sir, afterwards. And then
15	we'll take this in committee.
16	MR. PADWAY: Well, don't you want to hear
17	from the witnesses that came in support?
18	CHAIRMAN BOHL: Okay. That's fine.
19	Are there other I did ask for all neighborhood
20	residents who were here to testify. Are there
21	individuals here to testify in support of this
22	application.
23	MR. PADWAY: Yes.
24	CHAIRMAN BOHL: Okay. If you could come up
25	briefly, provide Well, why don't we swear you in.
20	Siteri, provide werr, why don't we swear you in.

00018 1 First off, why don't you all raise your right hands, 2 and we'll swear you in en masse. 3 (Whereupon the Witnesses were Sworn Under 4 Oath.) 5 CHAIRMAN BOHL: And what we'll ask you to do 6 is to come up to this microphone, clearly provide your 7 name and your address, and your reason for supporting 8 the license application. Sir, why don't you go ahead. 9 Let me just -- Let me first off, before we 10 get into this gentleman's testimony, we are still on 11 our 9:30 agenda. The first item of the day took 12 substantially longer time than we anticipated. On the 13 11:00 agenda are a number of bartenders' licenses. If 14 you are here for a new bartender's license -- and I 15 don't know how long it will be. We have a number of 16 items to get through before we get to bartenders' 17 licenses. 18 If you are here for a new bartender's 19 license, and you will not be able to wait around until 20 we get to to those matters, you will be able to go out 21 to the hallway, and there should be a person at the 22 back desk. You can provide your name and your -- to 23 that person, and what we will do is we will call you 24 up during our next license hearing in three weeks if 25 you are unable to wait. So if you need to do that,

1	you have that opportunity. As I said, we don't know
2	what time it will be. It may be an hour. If you're
3	able to wait, that's fine.
4	If you're here for renewal, you must stick
5	around. But if you're here on a new license, a new
6	bartender's license, and if you cannot stick around,
7	this is your opportunity to provide that information
8	here, so
9	AUDIENCE MEMBER: What about a new location?
10	CHAIRMAN BOHL: Likewise.
11	AUDIENCE MEMBER: Likewise what?
12	CHAIRMAN BOHL: Likewise, if you We can
13	hold you on the agenda if you're unable to stick
14	around. Correct. So if you want to just exit out and
15	give your information at the back desk. I'm sorry,
16	sir, go ahead.
17	MR. CASPER: Well, I'm not here for a
18	bartender's license.
19	CHAIRMAN BOHL: We're back on this item
20	here at the Tex Mex.
21	MR. CASPER: Right. I live above the
22	CHAIRMAN BOHL: Sir, we're going to need
23	your name and your address.
24	MR. CASPER: James Frank Casper, the
25	friendliest ghost, C-a-s-p-e-r, 1900 West Lincoln

00020 1 Avenue, upper front, Apartment 1, Milwaukee, 2 Wisconsin, 53215. 3 CHAIRMAN BOHL: Okay. Mr. Casper, why is it 4 that you support the license? 5 MR. CASPER: I don't support -- I'm one of 6 her tenants. I live above it. I don't tend bar. 7 CHAIRMAN BOHL: Okay. 8 MR. CASPER: Just when the officers came, I 9 wasn't home that day, but I'm there two and a half 10 years. 11 CHAIRMAN BOHL: Counsel, we'll give you an 12 opportunity to question the witness here. Sir, are 13 you here to support this license or to not support 14 this license? 15 MR. CASPER: Well, as a witness, that there 16 ain't no problem, you know, with us, I mean either 17 upstairs or downstairs. It's very clean and neat. 18 ALDERMAN GORDON: I'll take that as support. 19 CHAIRMAN BOHL: Okay, that you support the 20 license. Are there questions from committee? 21 ALDERMAN GORDON: Mr. Chairman. 22 CHAIRMAN BOHL: Yes. 23 ALDERMAN GORDON: I'm sorry, I missed this, 24 Mr. Casper. Did you say that you live upstairs above 25 the establishment?

00021 MR. CASPER: Yes, I do. 1 2 ALDERMAN GORDON: But you don't work there. 3 MR. CASPER: No, I'm retired. 4 ALDERMAN GORDON: Okay. How long have you 5 lived upstairs above the establishment? 6 MR. CASPER: Two and a half years, I said. 7 My roommate lived there. That's before Luis and Maria 8 took over. George and Pat Slominski had it for 11 9 years. Then it was Jean's Bar before I moved in. 10 ALDERMAN GORDON: Thank you. 11 CHAIRMAN BOHL: Okay. Mr. Padway, you 12 wanted to ask questions. 13 MR. PADWAY: Mr. Casper, you've been in the 14 Tex Mex Tavern? 15 MR. CASPER: Yes. 16 MR. PADWAY: And how often do you go in 17 there? 18 MR. CASPER: I give Maria's husband, Luis, 19 the rent once a month, and then I have a couple of 20 beers maybe two or three times a day -- I mean a week. 21 Then I go right back up stairs. 22 CHAIRMAN BOHL: Mr. Padway, if you could 23 direct your questions to the committee using the 24 microphone, he can answer them, but that way -- We 25 want to get you clearly on the record here. Thank

00022 1 you. 2 MR. PADWAY: In your observations is it a 3 clean tavern? 4 MR. CASPER: Yes, it is. It's very clean. 5 You can eat off the floor, or the bathrooms. 6 MR. PADWAY: And when you're upstairs, do 7 you notice any problems from the tavern? 8 MR. CASPER: No. 9 MR. PADWAY: And you would like to see the 10 tavern keep its license? 11 MR. CASPER: Yes, I would like to appreciate 12 that. 13 MR. PADWAY: And how many other people --14 There are two apartments up? 15 MR. CASPER: Yes, there is. MR. PADWAY: And to your knowledge, you 16 17 haven't heard any complaints from the other tenant 18 upstairs? 19 MR. CASPER: No, I haven't. 20 MR. PADWAY: I have nothing else. 21 CHAIRMAN BOHL: Alderman Donovan, anything? 22 ALDERMAN DONOVAN: No, I have no questions 23 of this gentleman. 24 CHAIRMAN BOHL: Okay. Thank you, 25 Mr. Casper. The next -- Mr. Casper, we're finished

00023 1 with you. 2 MR. CASPER: Thank you very much. 3 CHAIRMAN BOHL: Okay. If those who are 4 still here to testify, if you want to start lining up, 5 that would be appreciated here. That way we'll 6 expedite this a little, okay? 7 Ma'am, again, up to the microphone here. 8 And maybe the other two witnesses could take the two 9 seats behind you. Ma'am, if you could state your name 10 and your address, please, for the record? 11 MS. SALINAS: Lisa Salinas, 2812 South 45th 12 Street. 13 CHAIRMAN BOHL: And the spelling of your 14 last name, please. 15 MS. SALINAS: S-a-l-i-n-a-s. 16 CHAIRMAN BOHL: Okay. And our address, 17 ma'am? 18 MS. SALINAS: 2812 South 45th Street. 19 CHAIRMAN BOHL: And your testimony? 20 MS. SALINAS: Well, I'm a bartender there at 21 Tex Mex, and I haven't -- since I've been working there going on two years, I've never had to call the 22 23 police, never had no complaints, never had a fight, 24 never had gunshots. And as far as drug activity, 25 first of all, they haven't been charged with anything

00024 1 yet. There was no evidence found in the tavern, at 2 his residence, or on him when he was arrested. 3 And on my behalf, I've never seen any 4 illegal things because, I mean, I wouldn't allow it 5 myself. Especially if I'm working, I would, you know, 6 ask that person to leave. 7 CHAIRMAN BOHL: Okay. Counsel, is there 8 anything that --9 MR. PADWAY: You've worked there how long? 10 MS. SALINAS: Going on two years. 11 MR. PADWAY: And is the tavern kept clean? 12 MS. SALINAS: Oh, always. 13 CHAIRMAN BOHL: Counsel, we going to --14 In the issue of time, we're going to go on the 15 record here and say that Tex Mex is the cleanest 16 establishment in the City of Milwaukee, and -- I mean 17 I want to -- I don't want it to get to the point where 18 we're -- just as we stated earlier, -- where we're 19 getting redundant testimony. 20 MR. PADWAY: Okay. 21 CHAIRMAN BOHL: We're looking for new and 22 substantial -- She substantially agrees with the 23 previous gentleman who provided testimony. She can 24 agree to that extent. But if you have additional 25 questions, we'll take that now at this point.

1	MR. PADWAY: No.
2	CHAIRMAN BOHL: Okay. Committee members?
3	Okay. Alderman Donovan?
4	ALDERMAN DONOVAN: No questions.
5	CHAIRMAN BOHL: Thank you, ma'am.
6	MS. SALINAS: Thank you.
7	CHAIRMAN BOHL: Sir, if you want to step
8	forward. Again, clearly your name, spelling it if
9	it's difficult, and your address.
10	MR. LARA: Okay. My name is Pete Lara, Jr.
11	I live at 1725 South Pearl Street, which is about a
12	mile or something from the place. I do go in there
13	two, three times a week, and it's always been nice and
14	comfortable, clean and everything, so
15	CHAIRMAN BOHL: Okay. Thank you. Questions
16	by committee members? Alderman Donovan?
17	ALDERMAN DONOVAN: No questions.
18	CHAIRMAN BOHL: Sir?
19	MR. SALINAS: My name is Jose Salinas,
20	S-a-l-i-n-a-s. I live at 1613 South Muskego Avenue,
21	and I go there on a regular basis like four times a
22	week, usually. I'm there for an amount of periods of
23	times. Ever since I've been there, I've never seen a
24	problem or a fight. No police have ever had to show
25	up or anything like that, and it's pretty much one of

1	my usual hangouts.
2	CHAIRMAN BOHL: Okay. Questions by
3	committee? Mr. Padway, anything?
4	MR. PADWAY: No.
5	CHAIRMAN BOHL: Alderman Donovan?
6	ALDERMAN DONOVAN: I didn't get the address.
7	MR. SALINAS: 1613 South Muskego Avenue.
8	It's about less than a mile from there.
9	ALDERMAN DONOVAN: Thank you.
10	MR. SCHRIMPF: How far away do you live?
11	ALDERMAN BOHL: Mr. Schrimpf.
12	MR. SALINAS: South Muskego Avenue?
13	MR. SCHRIMPF: Yeah.
14	MR. SALINAS: That's about a less than a
15	mile.
16	MR. SCHRIMPF: A mile away.
17	CHAIRMAN BOHL: Okay. Mr. Padway, if you
18	have anything else that you want to present forward
19	here, we're going to then hear from Alderman Donovan,
20	and then we'll take this into committee.
21	MR. PADWAY: Okay. The only issue that I'd
22	bring up is there was reference from the other witness
23	about problems with the garage. I would like to note
24	that the garage area and the two apartments are rented
25	out. So whatever complaints there may have been about

00027 1 the garage, maybe somebody working on their car, would 2 have been by somebody who actually leases -- rents out 3 the garage and leases the space. 4 CHAIRMAN BOHL: Okay. Alderman Donovan, 5 anything else in terms of a closing statement here? 6 ALDERMAN DONOVAN: Yeah. Thank you, 7 Mr. Chairman. Very briefly, you know, with all due respect, and I have no doubt that the testimony from 8 9 the folks in support is very sincere; I have no doubt 10 that the inside of the tavern is kept clean, but I 11 should also like to point out that the testimony is 12 either from renters or employees or people who live 13 quite a significant distance away from the 14 establishment and are patrons there. Well, certainly 15 patrons are not necessarily going to object because 16 it's where they go and enjoy themselves. 17 The point is, the argument here that I am 18 certainly trying to make is that I feel we -- it's 19 critical that a message be sent that drug dealing 20 taking place in taverns cannot be tolerated. And I 21 should also like to point out that according to the 22 record, drug dealing did take place in the attached 23 garage, or at least some of it, in the attached 24 garage. The garage is a attached to the building, and 25 so anyway, those are my only comments. Thank you.

00028 CHAIRMAN BOHL: Okay. Mr. Padway, this is 1 2 your last opportunity. 3 MR. PADWAY: Thank you. You know, it's 4 clear that this is here because of an allegation 5 against my client's spouse that there was a drug 6 transaction that took place in the garage, not in the 7 tavern, and he has not been convicted as of yet. 8 This is -- I don't believe that you punish a 9 spouse for an alleged conduct of the spouse when he's 10 not yet even been proven. That would be tantamount to 11 anybody here being held accountable for what their 12 spouse's actions have done in a different location. 13 Mrs. Albiter has operated this tavern two 14 years. It has been operated well. There is no 15 citizen complaint of any foundation that was brought 16 forth complaining. The upstairs tenant who clearly 17 lives right above came forward, other people came 18 forward on her behalf. 19 To not renew her license, in my opinion, 20 would be extremely harsh for the action of another 21 individual, and another individual that we acknowledge 22 is facing criminal charges. And there is a system to 23 punish that individual if in fact they are convicted, 24 and that is the appropriate focus, not taking away a 25 small establishment's license that has, at most, a

00029 1 capacity of 50 people and that has not caused problems 2 in the neighborhood. 3 CHAIRMAN BOHL: Okay. Before we go to 4 Alderman Dudzik, who has a question, my question is 5 for Mr. Schrimpf, and that is relating to -- Relating 6 to the charges now here against Mrs. Albiter's 7 husband, there has not been an adjudication on these 8 matters. How much leeway does the committee have to 9 utilize these in its decision? 10 MR. SCHRIMPF: In this particular case, 11 Mr. Chairman, the Wisconsin Fair Employment Law 12 actually comes in and governs part of it because --13 And I understand that the husband is charged, and the 14 husband is not the licensed applicant. 15 But under the Wisconsin Fair Employment Act, 16 where there is a pending charge, the circumstances of 17 which substantially relate to the circumstances of the 18 licensed activity, then the committee can use the 19 existence of the pending charge as the basis for a 20 licensing decision. 21 Now, let me get to the next issue which is 22 the fact that it is the husband who's not the licensed 23 applicant. As I review the police report, -- and I'm 24 given to understand that this information has come 25

into the committee, -- some of the transactions took

1	place within the tavern, and some of the transactions
2	took place within the garage that was attached to the
3	tavern, and some of the buy money was recovered in the
4	safe of the office area of the tavern. Therefore, you
5	have at least arguably, it's up to the committee as
6	to how they view that, but certainly you have a link
7	to the licensed premises, and you have a link to the
8	activities of the licensed premises.
9	I would point out that the under the
10	ordinances, the husband can function as a Class D
11	bartender within the place. That's one point. And I
12	would commend to the committee their review of like
13	cases where bartenders have been involved in drug
14	transactions within taverns, and what the committee
15	has done in those particular cases with licenses. So
16	those are my comments in answer to your question.
17	CHAIRMAN BOHL: All right. Alderman Dudzik?
18	ALDERMAN DUDZIK: Mr. Schrimpf answered the
19	questions in his description. Thank you.
20	CHAIRMAN BOHL: Okay. We are now in
21	committee. Is there a motion?
22	ALDERMAN GORDON: Yes, Mr. Chairman.
23	CHAIRMAN BOHL: Alderman Gordon.
24	ALDERMAN GORDON: Thank you. At this time
25	I'm going to move for renewal of the license with a

1 10-day suspension based on police objections or the
2 police report. I think that the report clearly shows
3 that illegal activity has been taking place in this
4 establishment, and whether it's adjudicated or not,
5 I think that there is sufficient evidence for this
6 committee to impose the minimum penalty.
7 I think that will give Miss Albiter the

I think that will give Miss Albiter the 8 opportunity to talk with Alderman Donovan relative to 9 what is going to be happening at this establishment, 10 henceforth, after the Common Council weighs in on it 11 on March the 25th. But clearly the illegal activity 12 that has been alleged is serious, and it's caused, 13 obviously, some consternation amongst residents in the 14 immediate community surrounding the establishment. 15 Thus, I think that the minimum suspension period is 16 appropriate, and that's my motion.

17 CHAIRMAN BOHL: The motion before us is for renewal of the Class "B" tavern and tavern dance 18 19 license with a 10-day suspension. On the motion? 20 ALDERMAN GORDON: Just as a further caveat 21 to the motion, Mr. Chairman. 22 CHAIRMAN BOHL: Alderman Gordon. 23 ALDERMAN GORDON: The husband, Jose L. 24 Albiter, -- I don't know if we can impose this, but

25 based on Mr. Schrimpf's comments, is there a way to

00032 1 prevent him from being involved in the daily routine of the establishment? Or can we impose his not being 2 3 allowed on the premises? 4 MR. SCHRIMPF: Not without a change in the 5 current ordinance. 6 ALDERMAN GORDON: Okay. Thank you. So 7 that's my motion. 8 CHAIRMAN BOHL: Again, we have the motion 9 before us. Is there any comments on the motion? I'm 10 going to again pass the gavel and ask for recognition. 11 Madam Chair? 12 ALDERWOMAN JOHNSON-ODOM: Alderman Bohl. 13 ALDERMAN BOHL: I can appreciate the 14 concerns brought by the one resident. Again, in this 15 instance I have too many concerns with the police 16 report and the level of drug activity. I do not 17 believe that 10 days is sufficient, so I will oppose 18 the motion in hopes that it does not move forward, and 19 maybe we'll see where it goes. 20 But the motion before us is renewal of the 21 Class "B" tavern and tavern dance license with a 10-22 day suspension. Are there any other objections other 23 than my own? 24 ALDERMAN DUDZIK: I'll object, please. 25 CHAIRMAN BOHL: Okay. We have two

1	objections. That's a two-two vote. Is there another
2	motion on the floor?
3	ALDERMAN DUDZIK: I would move
4	CHAIRMAN BOHL: All Dudzik.
5	ALDERMAN DUDZIK: Thank you. I would move

7	CHAIRMAN BOHL: Okay. The motion before us
8	is for nonrenewal of the Class "B" tavern and tavern
9	dance application. On the motion? Anyone else?
10	ALDERWOMAN JOHNSON-ODOM: I would think
11	CHAIRMAN BOHL: Alderwoman Johnson-Odom.
12	ALDERWOMAN JOHNSON-ODOM: I think that
13	that's too severe. I would go for a for a longer
14	suspension and see what happens on April 28th. Was
15	the stipulation that the husband not be involved with
16	the bar? Was that
17	CHAIRMAN BOHL: Alderwoman Johnson-Odom,
18	that is something that the committee does not have the
19	purview to hold him to.
20	MR. PADWAY: May I
21	CHAIRMAN BOHL: We are in committee,
22	Counsel.
23	MR. PADWAY: I apologize. I can address
24	that issue.
25	CHAIRMAN BOHL: Okay. Alderman Dudzik, I

1	don't know where this is going to go, but we'll give
2	it a shot. The motion before us is for nonrenewal of
3	the tavern, tavern dance. The rationale was the items
4	in the police report?
5	ALDERMAN DUDZIK: Yes.
6	CHAIRMAN BOHL: Based on items in the police
7	report. Are there any objections to this motion? And
8	I will object.
9	ALDERMAN GORDON: I object.
10	ALDERWOMAN JOHNSON-ODOM: I object.
11	CHAIRMAN BOHL: Okay. There's a
12	one-to-three. I'm going to pass the gavel here.
13	ALDERWOMAN JOHNSON-ODOM: Alderman Bohl.

And it will based on items in the police report. 6 7 Are there any comments on the motion we have 8 before us? Okay. The motion is again for renewal of 9 the tavern and tavern dance license with a 40-day 10 suspension. Are there any objections to that motion? 11 Hearing none, so ordered. Mr. Schrimpf? 12 MR.
